The plan emphasizes the replacement and rehabilitation of existing facilities and the selective addition and expansion of facilities.

The FY2026-2030 CIP book contains vertical construction projects supported by the General Services Department for its clients (Fire, Health, Library, Parks, Police and Solid Waste), projects supported by Houston Public Works (Street & Traffic, Storm Drainage, Water and Wastewater) and the Houston Airport System. In addition, Information Technology, Fleet, and Component Units citywide capital programs are included.

Background:

While the physical site is in the planning phase, ALMAAHH is already serving as a convener and platform for American Latino artists, cultural practitioners, and partner organizations, with an active presence in Houston's public cultural life. The mutual interest of the Parties is in advancing cultural access, civic engagement, and educational opportunity across the City of Houston.

ALMAAHH shall use the City's contribution solely for the payment of the costs generally identified in this Agreement and for no other purpose. The scope of ALMAAHH's work consists of the following:

1. **Site Research and Planning** – Conducting studies and analyses necessary to determine the suitability and potential of a location for the future arts and culture complex. Through targeted studies and planning efforts, ALMAAHH will assess the site's suitability and inform the overall master plan—including infrastructure needs, cultural relevance, and community access.

2. **Program Development and Public Engagement** – Designing and implementing arts and cultural programs in partnership with existing local organizations, with the goal of serving diverse communities throughout Houston. As part of this collaboration, ALMAAHH will co-develop arts and culture programs and events across different parts of the city anchored at Houston Public Library ("HPL") locations, designed to support and expand the reach of HPL's seven areas.

3. **Data Collection and Strategic Insight** – Gathering and analyzing qualitative and quantitative data related to artists, cultural partners, and audiences, in order to inform future planning and contribute to broader public understanding of community cultural needs. In addition to programming, the collaboration will include the collection and analysis of data related to

participation in the events and programs—gathering insights from artists, cultural organizations, and diverse audiences.

Budget: The approximate budget for ALMAAHH's activities is:

Museum complex planning - \$100,000 Public engagement - \$20,000 Research and data collection - \$10,000 **Total-** \$130,000

The City shall reimburse ALMAAHH for a portion of its operations budget in an amount not to exceed \$130,000.00 based on invoices submitted by ALMAAHH and approved by the Director or designee of the Houston Public Library ("Director"), showing the work performed and corresponding itemized actual costs or expenses of that work. The City shall submit reimbursement to the ALMAAHH at its address for notices within 30 days of receipt of an approved invoice.

## **Background:**

The Chief of Police for the Houston Police Department (HPD) is seeking approval from City Council for an ordinance that would authorize the acceptance of grant funds from the Office of the Governor's Public Safety Office, Criminal Justice Division (CJD) for the FY26 Criminal Justice Grant Program, specifically for the HPD Family Violence Initiative. The grant period is set from October 1, 2025, to September 30, 2026. If awarded, the Office of the Governor will provide \$150,000.00 in funding. No city matching funds or in-kind contributions are required. This would be the city's first award under this program.

The purpose of the grant is to support the HPD's Family Violence Division investigators in conducting follow-up investigations related to domestic violence cases. Investigators will prioritize and manage timely caseloads, while also gathering monthly data on the number of cases assigned, cleared cases, arrests, charges filed, and weapons recovered. This data will be used to track family violence-related homicides, comparing current figures with previous years. During the grant period, officers will have the flexibility to work extended hours on high-priority cases, particularly those with a higher likelihood of escalating to homicide. Ultimately, the goal is to reduce domestic violence-related homicides, enhance public safety, decrease crime, and support improvements in the criminal justice system. If awarded, the grant funds will be used to cover overtime pay for officers, sergeants, and lieutenants involved in investigative duties.

The Houston Police Department also requests City Council to authorize the Chief of Police or his designee, to act as the City's representative in the grant application process with the authority to apply for, accept, and expend the grant funds as awarded and apply for, accept and expend all subsequent awards, if any, to extend the budget period, and to authorize the Mayor to execute all

related agreements, with the approval of the City Attorney in connection with the grant, not to exceed five years.

#### Background:

The Chief of Police for the Houston Police Department (HPD) is seeking approval from City Council for an ordinance that would authorize the acceptance of grant funds from the Office of the Governor's Public Safety Office, Criminal Justice Division (CJD) for the FY26 Criminal Justice Grant Program, specifically for the HPD Family Violence Initiative. The grant period is set from October 1, 2025, to September 30, 2026. If awarded, the Office of the Governor will provide \$150,000.00 in funding. No city matching funds or in-kind contributions are required. This would be the city's first award under this program.

The purpose of the grant is to support the HPD's Family Violence Division investigators in conducting follow-up investigations related to domestic violence cases. Investigators will prioritize and manage timely caseloads, while also gathering monthly data on the number of cases assigned, cleared cases, arrests, charges filed, and weapons recovered. This data will be used to track family violence-related homicides, comparing current figures with previous years. During the grant period, officers will have the flexibility to work extended hours on high-priority cases, particularly those with a higher likelihood of escalating to homicide. Ultimately, the goal is to reduce domestic violence-related homicides, enhance public safety, decrease crime, and support improvements in the criminal justice system. If awarded, the grant funds will be used to cover overtime pay for officers, sergeants, and lieutenants involved in investigative duties.

The Houston Police Department also requests City Council to authorize the Chief of Police or his designee, to act as the City's representative in the grant application process with the authority to apply for, accept, and expend the grant funds as awarded and apply for, accept and expend all subsequent awards, if any, to extend the budget period, and to authorize the Mayor to execute all related agreements, with the approval of the City Attorney in connection with the grant, not to exceed five years.
