

City of Houston, Texas Ordinance No. 2020-628

AN ORDINANCE AMENDING ORDINANCE NO. 2020-0288 (PASSED ON APRIL 1, 2020) TO CHANGE THE TESTING LABORATORY CONTRACTOR FROM COASTAL TESTING LABORATORIES TO ASSOCIATED TESTING LABORATORIES, INC. FOR THE CONTRACT AWARDED TO GRAVA, LLC (APPROVED BY ORDINANCE NO. 2020-0288); AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HOUSTON, TEXAS:

Section 1. Section 1 of Ordinance No. 2020-0288 is deleted in its entirety and replaced with the following Section 1: "The City Council appropriates the sum or sums of money set out in the title of this Ordinance, out of the respective fund or funds set out in such title as follows: The sum of \$1,200,00.00 is appropriated for construction of the project described in the title, the sum of \$120,000.00 is appropriated for CIP Cost Recovery relating to the construction of facilities by the funds described in such title, the sum of \$60,000.00 is appropriated for contingency, the sum of \$95,000.00 is appropriated for testing services under **Outline Agreement No. 46000142888**. In the event there are unspent funds remaining in the Construction Appropriation after construction and closeout of the project, such unspent funds are appropriated for CIP Cost Recovery relating to construction of facilities financed by the fund described in the title."

Section 2. There exists a public emergency requiring that this Ordinance be passed finally on the date of its introduction as requested in writing by the Mayor; therefore, this Ordinance shall be passed finally on such date and shall take effect immediately upon its passage and approval by the Mayor; however, in the event that the Mayor fails to sign this Ordinance within five days after its passage and adoption, it shall take effect in accordance with Article VI, Section 6, Houston City Charter.
