AN ORDINANCE APPROPRIATING THE SUM OF \$245,518.79 OUT OF THE METRO **PROJECTS** CONSTRUCTION **DDSRF** TO THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF HOUSTON AND HARRIS COUNTY FLOOD CONTROL DISTRICT FOR THE BRAYS BAYOU FLOOD DAMAGE REDUCTION PLAN FOR THE HILLCROFT BRIDGE (APPROVED ORDINANCE NO. 2003-1282); PROVIDING FUNDING FOR CIP COST RECOVERY AND CONTINGENCIES RELATING TO CONSTRUCTION OF FACILITIES FINANCED BY THE METRO PROJECTS CONSTRUCTION DDSRF; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HOUSTON, TEXAS:

Section 1. The City Council hereby appropriates the sum or sums of money set out in the title of this Ordinance, out of the respective fund or funds set out in such title as follows: the sum of \$188,860.61 is appropriated for contract services related to the project described in the title, the sum of \$37,772.12 is appropriated for contingency, and the sum of \$18,886.06 is appropriated for CIP Cost Recovery relating to construction of facilities financed by the fund described in such title.

Section 2. There exists a public emergency requiring that this Ordinance be passed finally on the date of its introduction as requested in writing by the Mayor; therefore, this Ordinance shall be passed finally on such date and shall take effect immediately upon its passage and approval by the Mayor; however, in the event that the Mayor fails to sign this Ordinance within five days after its passage and adoption, it shall take effect in accordance with Article VI, Section 6, Houston City Charter.
