AN ORDINANCE APPROPRIATING \$13,700.00 OUT OF THE MISCELLANEOUS CAPITAL PROJECTS/ACQUISITIONS CP SERIES E FUND FOR HURRICANE HARVEY DAMAGE REPAIRS FOR LOOSCAN NEIGHBORHOOD LIBRARY FOR THE HOUSTON PUBLIC LIBRARY; DECLARING THE CITY'S INTENT TO SEEK REIMBURSEMENT FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY AND OTHER ELIGIBLE SOURCES FOR SUCH

EXPENDITURE; CONTAINING PROVISIONS RELATING TO THE SUBJECT; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HOUSTON, TEXAS:

Section 1. The City Council hereby appropriates the sum of money set out in the title of this Ordinance, out of the fund set out in such title.

Section 2. The City Council declares its intent to seek reimbursement for some, or all, of the expenditures of such fund from the Federal Emergency Management Agency and other eligible sources to the extent allowed by law and hereby authorizes the Mayor to take all actions necessary to secure such reimbursement.

Section 3. There exists a public emergency requiring that this Ordinance be passed finally on the date of its introduction as requested in writing by the Mayor; therefore, this Ordinance shall be passed finally on such date and shall take effect immediately upon its passage and approval by the Mayor; however, in the event that the Mayor fails to sign this Ordinance within five days after its passage and adoption, it shall take effect in accordance with Article VI, Section 6, Houston City Charter.
