#### **Summary:**

RECOMMENDATION from Director Administration & Regulatory Affairs Department for the designation of a Residential Parking Permit Area in the 1300 block of Moy St. Park, 5100-5200 blocks of Allen, 100 block of Avondale (south side), 2200 block of Whitney, 5300 block of Rose, 3100-3200 blocks of Reba and in the 2000 block of Converse - **DISTRICTS C - KAMIN** and **DISTRICT G - HUFFMAN** 

#### **Background:**

The Administration and Regulatory Affairs Department recommends that the following proposed areas be designated as a Residential Permit Parking (RPP) area and that a valid permit be required for on-street parking at the times of day and days of the week specified below.

- 1300 block of Moy St. Park and 5100 5200 blocks of Allen
- Days/Times: Wednesday Sunday, 10 PM 5 AM, tow-away zone

### RPP# 102121-24-360

- 100 block of Avondale, south side
- Days/Times: Monday Sunday, 5 PM 11 PM, tow-away zone

#### RPP# 113021-24-358

- 2200 block of Whitney
- Days/Times: Wednesday Sunday, 11 PM 5 AM, tow-away zone

#### RPP# 011322-22-359

- 5300 block of Rose
- Days/Times: Wednesday Sunday, 10 PM 5 AM, tow-away zone

#### RPP# 022822-23-361

- 3100 3200 blocks of Reba
- Days/Times: Monday Friday, 7 AM 9 AM, tow-away zone

#### RPP# 022822-24-362

- 2000 block of Converse
- Days/Times: Wednesday Sunday, 11 PM 5 AM, tow-away zone

Chapter 26, Section 26-311 of the City of Houston's Code of Ordinances provides for the creation of Residential Permit Parking areas in neighborhoods where excessive commuter parking is deemed a problem for residents. To date, 196 permit parking areas have been designated.

The Administration and Regulatory Affairs and Houston Public Works reviewed the applications and held a virtual public hearing on May 3, 2022, to discuss and ensure any outstanding issues with the proposed area were satisfactorily resolved within the community. The required public hearing notice was sent to all addresses within a 200 ft. boundary of the requested zone as well and the Super Neighborhood Council.

#### Fiscal Note

There is no impact to the fiscal budget and no additional spending authority. Therefore, no Fiscal Note is required as stated in the Financial Policies.
