AN ORDINANCE APPROPRIATING THE SUM OF \$7,426,583.00 OUT OF TAX INCREMENT FUNDS FOR REINVESTMENT ZONE NUMBER TWO, CITY OF HOUSTON, TEXAS (MIDTOWN ZONE), REINVESTMENT ZONE NUMBER THREE, CITY OF HOUSTON, TEXAS (MAIN STREET/MARKET SQUARE ZONE), REINVESTMENT ZONE NUMBER EIGHT, CITY OF HOUSTON, TEXAS (GULFGATE ZONE), REINVESTMENT ZONE NUMBER NINE, CITY OF HOUSTON, TEXAS (SOUTH POST OAK ZONE), REINVESTMENT ZONE NUMBER ELEVEN, CITY OF HOUSTON, TEXAS (GREATER GREENSPPOINT ZONE), AND REINVESTMENT ZONE NUMBER FIFTEEN, CITY OF HOUSTON, TEXAS (EAST DOWNTOWN ZONE) FOR

ADMINISTRATIVE EXPENSES, PAYMENT OF PROJECT COSTS, AND PAYMENTS TO CERTAIN REDEVELOPMENT AUTHORITIES AS PROVIDED HEREIN; CONTAINING PROVISIONS RELATING TO THE SUBJECT; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HOUSTON:

Section 1. That the City Council hereby appropriates from Fund 7550 the following sums of money:

- a. \$203,674.60 for transfer to City Fund 1000 for imputed administrative expenses; and
- b. \$3,869,817.40 for payment to Midtown Redevelopment Authority pursuant to Ordinance No. 2000-494.

Section 2. That the City Council hereby appropriates from Fund 7551 the following sums of money:

- a. \$29,599.40 for transfer to City Fund 1000 for imputed administrative expenses; and
- b. \$562,388.60 for payment to Main Street/Market Square Redevelopment Authority d/b/a Downtown Redevelopment Authority pursuant to Ordinance No. 2000-240.

Section 3. That the City Council hereby appropriates from Fund 7556 the following sums of money:

- a. \$13,811.00 for transfer to City Fund 1000 for imputed administrative expenses; and
- b. \$262,409.00 for payment to Gulfgate Redevelopment Authority pursuant to Ordinance No. 97-1571, as amended by Ordinance No. 2001-411.

Section 4. That the City Council hereby appropriates from Fund 7557 the following sum of money:

- a. \$207,051.00 for payment to South Post Oak Redevelopment Authority pursuant to Ordinance No. 1999-923.

Section 5. That the City Council hereby appropriates from Fund 7559 the following sums of money:

- a. \$25,000.00 for transfer to City Fund 1000 for imputed administrative expenses;
- b. \$612,667.00 for payment to Greater Greenspoint Redevelopment Authority pursuant to Ordinance No. 1999-1381; and

- c. \$1,104,187.00 for payment to Greater Greenspoint Redevelopment Authority pursuant to Ordinance No. 2000-924.

Section 6. That the City Council hereby appropriates from Fund 7563 the following sums of money:

- a. \$455,581.30 for payment to East Downtown Redevelopment Authority pursuant to Ordinance No. 2000-663; and
- b. \$80,396.70 for payment to Harris County pursuant to Ordinance No. 2011-74, as amended by Ordinance No. 2011-296.


Section 7. There exists a public emergency requiring that this Ordinance be passed finally on the date of its introduction as requested in writing by the Mayor; therefore, this Ordinance shall be passed finally on such date and shall take effect immediately upon its passage and approval by the Mayor, however, in the event that the Mayor fails to sign this Ordinance within five days after its passage and adoption, it shall take effect in accordance with Article VI, Section 6, Houston City Charter.
