

**PREVIOUS HISTORY AND PROJECT SCOPE:** On May 30, 2012, Ordinance No. 2012-515, City Council awarded a three-year contract with two one-year options to Times Construction, Inc., in an amount not to exceed \$5,300,345.00 for concrete repair services for various departments. The contract is funded through various appropriations/allocations for repair services. To date, \$3,088,765.00 has been expended on the contract.

**M/WBE INFORMATION:** The contract was awarded with a 14% MBE goal and 8% SBE goal. Currently, Times Construction, Inc. has achieved 12.49% MBE participation and 17.08% SBE participation.
