Summary:

AN ORDINANCE AMENDING EXHIBIT "A" OF THE CITY OF HOUSTON ORDINANCE NO. 2022-221 TO CHANGE CURRENT JOB CLASSIFICATION OF COMMANDER TO CAPTAIN AND CHANGE BASE PAY RATE OF POLICE OFFICER, PROBATIONARY; SUBSTITUTING THE AMENDED EXHIBIT AS PART OF THE CURRENT POLICE DEPARTMENT CLASSIFIED PERSONNEL ORDINANCE; PROVIDING A REPEALER; PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY.

Background:

The Police Chief for the Houston Police Department requests to amend the Police Department Classified Personnel Ordinance, Exhibit A - Fiscal Year 2025, by changing the job classification of Commander to Captain and changing the base pay rate of Police Officer, Probationary.
