#### **Background:**

<u>SUBJECT:</u> Contract Award for Ground Water Facility/Re-Pump Station/HVAC & Ventilation System Improvements at Various Locations - Package 2.

**RECOMMENDATION:** Award a Construction Contract to Servox, LLC for Ground Water Facility/Re-Pump Station/HVAC & Ventilation System Improvements at Various Locations - Package 2 and appropriate funds.

**PROJECT NOTICE/JUSTIFICATION:** This project is part of the City's Groundwater Facility/Re-pump Station Rehabilitation and Replacement Program and is required to meet the area's water demand and ensure compliance with the Texas Commission on Environmental Quality regulations program.

<u>DESCRIPTION/SCOPE:</u> This project consists of improvements to various groundwater facilities/re-pump stations. Improvements include renovations, pump installation/rehabilitation, and replacement of electrical switchgear, generators, valves, meters, motors, and HVAC & ventilation. The contract duration for this project is 1170 calendar days. This project was designed by Freese and Nichols, Inc.

**BIDS:** This project was advertised for bidding on December 17, 2024. Bids were received on January 30, 2025. The one (1) bid is as follows:

**AWARD:** It is recommended that this construction contract be awarded to Servox, LLC with a bid of \$21,659,640.47 and that Addenda Numbers 1 and 2 be made a part of this Contract.

**PROJECT COST:** The total cost of this project is \$24,025,604.51 to be appropriated as follows:

Bid Amount \$21,659,640.47
 Contingencies \$1,082,982.02
 Testing Services \$200,000.00
 CIP Cost Recovery \$1,082,982.02

Testing Services will be provided by Terracon Consultants, Inc. under a previously approved contract.

HIRE HOUSTON FIRST: The proposed contract requires compliance with the City's 'Hire Houston First' (HHF) ordinance that promotes economic opportunity for Houston businesses and supports job creation. In this case, Servox, LLC is a designated HHF company, but they were the successful awardee without application of the HHF preference.

<u>PAY OR PLAY PROGRAM:</u> The proposed contract requires compliance with the City's 'Pay or Play' ordinance regarding health benefits for employees of City contractors. In this case, the Contractor provides health benefits to eligible employees in compliance with City policy.

M/WSBE PARTICIPATION: The contractor has submitted the following proposed program to satisfy the 13.00% MBE goal and 7.00% WBE goal for this project.
