HCD25-96 Houston SRO - Subrecipient Agreement

Background:

The Housing and Community Development Department (HCD) recommends Council approval of an Ordinance authorizing a Subrecipient Agreement (Agreement) between the City of Houston (City) and Houston SRO Housing Corporation (Houston SRO), providing up to \$307,977.00 in Housing Opportunities for Persons with AIDS (HOPWA) funds for the continued operation of a permanent housing community residence with supportive services to a minimum of 33 very-low income single-person households living with HIV/AIDS.

Supportive services include comprehensive case management, housing counseling, referrals for general health services, job training, mental health, and substance abuse counseling, and other supportive services that reinforce opportunities towards independent living. Operating costs include, but are not limited to, property management, utilities, maintenance and repairs, and property insurance.

HCD conducted a Notice of Funding Availability (NOFA) for HOPWA services in March 2025 with a one-year renewal option at the City's discretion. Houston SRO was one of the selected agencies. This Agreement will begin on the date of countersignature of the City Controller and provide funding through September 30, 2026.

Houston SRO has received funding from the City since 1999 and had no findings on their last compliance monitoring review.
