








Notes:






NOTE—Johnny Goyen Park, part of PARD parks, will be maintained by HPB as part of BG2020. HPB will contract with BBP to maintain it and HPB and BBP will enjoy UHD's maintenance of the area to whatever extent UHD provides and HPB and/or BBP will make up the difference to bring it to standards or take over if UHD decides to no longer provide any services.



NOTE—This area was built by PARD with BBP providing a portion of the funding. It will be maintained by BBP under the COH/BBP Agreement.

NOTE—This area is a PARD park that was released to BBP to re-build the ICB. PARD expects that project to restore area used upon completion. BBP is to take over long term maintenance under the City/BBP agreement once the laydown area is no longer needed.
