**PROJECT DESCRIPTION:** The scope of work consists of removing one 25,000 gallon gasoline underground storage tank (UST), two 25,000 gallon diesel USTs, with associated appurtenances. The work also includes the installation of four 25,000 gallon USTs and disposal of aqueous liquid, saw-cutting, demolition and removal of concrete paving over the USTs, backfilling and compaction, waste classification, loading, hauling and proper disposal.
