


<b>SPECIFIC EXPLANATION:</b> <u>Texas Department of Transportation (TXDOT) FY17 Statewide Transportation Enhancement Program (STEP) Impaired Driving Mobilization Grant</u> <p>The Houston Police Department (HPD) is applying to the Texas Department of Transportation (TXDOT) for the FY17 Statewide Transportation Enhancement Program (STEP) Impaired Driving Mobilization grant in the amount of \$104,861. The program also requires an in-kind contribution of \$50,396.11 in fringe benefits and \$36,624.81 in travel costs. This grant does not require the City to make a cash match contribution.</p> <p>This grant will allow HPD Traffic Division to increase drinking while intoxicated (DWI) enforcement to reduce fatal and serious injury crashes. The STEP grant also funds a public information campaign by HPD on the dangers of DWI.</p>
