

2014 MAJOR THOROUGHFARE AND FREEWAY PLAN (Amendments to the 2013 MTFP)

On September 4, 2014, the Planning Commission recommended that City Council adopt changes to the 2013 Major Thoroughfare and Freeway Plan (MTFP). These recommendations were made as part of the annual MTFP Amendment cycle. The sixty recommended amendments are listed below.
