City of Houston, Texas Ordinance No. 2014-1031

AN ORDINANCE APPROPRIATING \$1,099,250.00 OUT OF THE EQUIPMENT ACQUISITION CONSOLIDATED FUND FOR THE PURCHASE OF COMPUTERS, PERIPHERALS, AND RELATED PROFESSIONAL SERVICES FOR VARIOUS DEPARTMENTS FOR THE HOUSTON INFORMATION TECHNOLOGY SERVICES DEPARTMENT; CONTAINING PROVISIONS RELATING TO THE SUBJECT; AND DECLARING AN EMERGENCY.

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HOUSTON, TEXAS:**

Section 1. The City Council hereby appropriates the sum of money set out in the title of this Ordinance out of the funds set out in such title for the purpose set out thereunder.

Section 2. The Mayor is hereby authorized to take all actions necessary to effectuate the City's intent and objectives in approving such undertaking described in the title of this ordinance, in the event of changed circumstances.

Section 3. The City Attorney is hereby authorized to take all action necessary to enforce all legal obligations under said undertaking without further authorization from Council.

Section 4. There exists a public emergency requiring that this Ordinance be passed finally on the date of its introduction as requested in writing by the Mayor; therefore, this Ordinance shall be passed finally on such date and shall take effect immediately upon its passage and approval by the Mayor; however, in the event that the Mayor fails to sign this Ordinance within five days after its passage and adoption, it shall take effect in accordance with Article VI, Section 6, Houston City Charter.
