ORDINANCE No. 2014 - 1056

AN ORDINANCE APPROVING AND AUTHORIZING A SECOND AMENDMENT TO ANCILLARY LAND EXCHANGE AGREEMENT BETWEEN THE CITY OF HOUSTON AND HOUSTON INDEPENDENT SCHOOL DISTRICT ("HISD") TO PROVIDE AN ADDITIONAL CREDIT OF \$1,500.00 TO HISD FOR EACH PROPERTY TO BE ACQUIRED BY THE LAND ASSEMBLAGE REDEVELOPMENT AUTHORITY ("LARA") PURSUANT TO THE RESTATED URBAN REDEVELOPMENT INTERLOCAL AGREEMENT; CONTAINING FINDINGS AND OTHER PROVISIONS RELATING TO THE FOREGOING SUBJECT; AND DECLARING AN EMERGENCY.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HOUSTON, TEXAS:

Section 1. That the City Council hereby approves and authorizes the contract, agreement, or other undertaking described in the title of this Ordinance, in substantially the form as shown in the document which is attached hereto and incorporated herein by this reference. The Mayor is hereby authorized to execute such document and all related documents on behalf of the City of Houston. The City Secretary is hereby authorized to attest to all such signatures and to affix the seal of the City to all such documents.

Section 2. That the City Attorney is hereby authorized to take all action necessary to enforce all legal obligations under such contracts, agreements, or other undertakings without further authorization from Council.

Section 3. That there exists a public emergency requiring that this Ordinance be passed finally on the date of its introduction as requested in writing by the Mayor; therefore, this Ordinance shall be passed finally on such date and shall take effect immediately upon its passage and approval by the Mayor; however, in the event that the Mayor fails to sign this Ordinance within five days after its passage and adoption, it shall take effect in accordance with Article VI, Section 6, Houston City Charter.

**SECOND AMENDMENT
TO
ANCILLARY LAND EXCHANGE AGREEMENT**

This Second Amendment to Ancillary Land Exchange Agreement ("Amendment") is made by and between the City of Houston (hereinafter the "City") and the Houston Independent School District ("HISD").

WHEREAS, the City and HISD are parties to that certain Ancillary Land Exchange Agreement ("Original Ancillary Agreement") dated on or about July 22, 2005, approved by City Ordinance No. 2005-702, dated June 8, 2005, which provides, among others, a credit of \$500.00 from the City to HISD ("HISD Credit") for each Houston Hope I property that is struck off to the City to be conveyed to Land Assemblage Redevelopment Authority ("LARA");

WHEREAS, the City and HISD are parties to that certain First Amendment to Ancillary Land Exchange Agreement ("First Amendment") dated on or about July 9, 2009, as approved by City Ordinance No. 2009-225 dated March 25, 2009, pursuant to which the HISD Credit was increased from \$500.00 to \$1,000.00 (the Original Ancillary Agreement as amended by the First Amendment being hereinafter referred to as the "Ancillary Agreement");

WHEREAS, the City has requested that HISD consent to the Restated Urban Redevelopment Interlocal Agreement by and among the City, Land Assemblage Redevelopment Authority, HISD, and other taxing units for a term beginning on the countersignature date of the City Controller and ending on March 12, 2017 ("Restated Agreement");

WHEREAS, HISD is willing to give its consent to the Restated Agreement and is requesting the City to provide an additional credit in the amount of \$1,500.00 for each property described on Exhibit "A" attached hereto ("Property"); and

WHEREAS, the City is willing to provide HISD an additional credit of \$1,500.00 with respect to the Property.

NOW, THEREFORE, the City and HISD agree as follows:

1. Article 2 of the Ancillary Agreement is hereby amended by deleting the same in its entirety and substituting in lieu and in place thereof the following:

"With respect to each of the properties described on Exhibit "A" attached hereto, the City will grant an additional credit to HISD in the amount of One Thousand Five Hundred and No/100 Dollars (\$1,500.00), to be deposited in the Credit Account within thirty (30) days after the Effective Date. For purposes hereof, the term "Effective Date" shall mean and refer to the date of full execution by all parties thereto of the Restated Agreement."

2. Except as expressly modified hereby, the Ancillary Agreement remains in full force and effect according to all the terms and provisions thereof.

IN WITNESS WHEREOF, the parties hereto have caused this instrument to be duly executed to be effective as of the Countersignature Date of the City Controller.
