Summary:

AN ORDINANCE APPROPRIATING THE SUM OF \$48,682.00 OUT OF THE PARKS AND RECREATION DEDICATION FUND AS AN ADDITIONAL APPROPRIATION TO AN INTERLOCAL AGREEMENT BETWEEN THE CITY AND HOUSTON PARKS BOARD LGC, INC. FOR THE CONSTRUCTION OF IMPROVEMENTS TO VARIOUS PARKS; APPROVING AND AUTHORIZING AN AMENDED AND RESTATED INTERLOCAL AGREEMENT BETWEEN THE CITY AND HOUSTON PARKS BOARD LGC, INC. FOR THE CONSTRUCTION OF IMPROVEMENTS TO VARIOUS PARKS; AND DECLARING AN EMERGENCY.

Background:

The Houston Parks and Recreation Department recommends City Council appropriate additional funds and approve an amended and restated Interlocal Agreement with the Houston Parks Board LGC to provide additional funding for one of the park projects that were the subject of the original agreement.

The additional appropriation is needed due to higher than estimated lowest construction bid for the Lee LeClear Tennis Center Court Lighting project (Park Sector 8). The revised project costs are shown below:
