E26676 - Storm Regenerative Air Sweepers - MOTION

Background:

S05-E26676 - Approve the purchase of two (2) storm regenerative air sweepers through the Houston-Galveston Area Council (H-GAC) in the total amount of \$313,810.00 for the Fleet Management Department on behalf of Solid Waste Management Department.

Specific Explanation:

The Director of the Fleet Management Department and the Chief Procurement Officer recommend that City Council approve the purchase of two (2) Schwarze A4 storm regenerative air sweepers through the Interlocal Agreement for Cooperative Purchasing with the Houston-Galveston Area Council (H-GAC) in the total amount of \$313,810.00 for the Solid Waste Management Department (SWMD) and that authorization be given to issue a purchase order to the H-GAC contractor **Texan Waste Equipment, Inc. DBA Heil of Texas**. The sweepers will be used by the department to collect and remove contaminants that are getting into storm water drains at the SWMD parking lots. **The funding for these items is included in the adopted FY19 Equipment Acquisition Plan.**

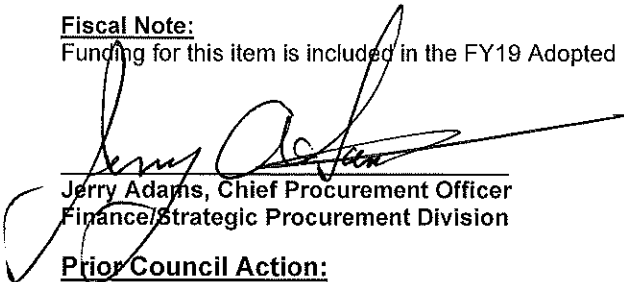
