Summary:

SET A PUBLIC HEARING DATE regarding the removal of a tract of land totaling approximately 6 acres from the existing Alief Park for the construction of the new Alief Neighborhood Center Building

Background:

The Houston Parks and Recreation Department (HPARD) requests City Council set a date for a public hearing regarding removing a tract of land totaling approximately 6 acres from the existing Alief Park for the construction of the new Alief Neighborhood Center building.

The existing Alief Park is comprised of approximately 37 acres of land located in Harris County at the corner of Bellaire Boulevard and Kirkwood Road.

Section 26.001 of the Texas Parks & Wildlife Code provides that a city may not approve any program or project for the use of land designated as park land unless, after a public hearing, its governing body determines that: (1) there is no feasible and prudent alternative to the use or taking of the park land, and (2) the program or project includes all reasonable planning to minimize harm to the park land.

The proposed date of the public hearing is **Wednesday, August 14, 2019** at 9:00 a.m. in City Council Chambers, 901 Bagby Street, 2nd Floor, Houston, Texas.
