HAS - Accept Work for Reconstruction of Taxiway NB at IAH

Summary:

RECOMMENDATION from Director Houston Airport System for approval of final contract amount of \$43,626,136.48 and acceptance of work on contract with **SPAWGLASS CIVIL CONSTRUCTION, INC** for Reconstruction of Taxiway NB at George Bush Intercontinental Airport/Houston - 2.50% over the original contract amount and under the 7% contingency amount -<u>DISTRICT B - DAVIS</u>

Background:

Pass a motion to approve the final contract amount of \$43,626,136.48, or 2.50% over the original construction contract amount of \$42,559,404.92 and under the 7% contingency amount, accept work, and authorize final payment.

SPECIFIC EXPLANATION:

The contractor, SpawGlass Civil Construction Inc., has completed all the work required under the contract in the amount of \$43,626,136.48 for the reconstruction of Taxiway NB at George Bush Intercontinental Airport/Houston (IAH).

The final contract amount includes Change Orders Nos. 1-26 with a net total of \$1,066,731.56. The changes were primarily due to circumstances that were unforeseen at the time of design.

The project consisted of seven (7) phases in order to accommodate the on-going operational use of the taxiways. During construction, United Airlines requested that Phase 5 be modified to incorporate a "split" closure of the taxiway adjacent to their maintenance yard. The split closure would leave half of the access way open and avoid longer plane route detours. To accomplish this split phasing, an additional 60 days was added to the contract.

Additionally, during the construction of Phase 5, pavement issues were discovered with work that was completed during Phases 1, 2, and 3. The subsequent evaluation, analysis, and negotiated remedial actions for the affected areas were finalized in July 2016. The negotiated repairs and panel replacements were done as warranty issues and not subject to liquidated damages. The contract was not closed until all quality issues were addressed and accepted.

During construction, the project was managed and inspected by Houston Airport System

personnel and NICET, a certified concrete quality specialist firm.

It is now requested that City Council pass a motion to approve the final contract amount of \$43,626,136.48, or 2.50% above the original construction contract amount of \$42,559,404.92 and under the 7% contingency amount, accept work, and authorize final payment.

The total project cost of \$43,626,136.48 is fully recoverable through federal funds, airline rates and charges, and other airport revenue.

MWBE PARTICIPATION:

SpawGlass Civil Construction Inc. achieved a 28.88% participation rating toward a 25% goal, earning an "Outstanding" rating by the Office of Business Opportunity.

Pass a motion to approve the final contract amount of \$43,626,136.48, or 2.50% over the original construction contract amount of \$42,559,404.92 and under the 7% contingency amount, accept work, and authorize final payment.

SPECIFIC EXPLANATION:

The contractor, SpawGlass Civil Construction Inc., has completed all the work required under the contract in the amount of \$43,626,136.48 for the reconstruction of Taxiway NB at George Bush Intercontinental Airport/Houston (IAH).

The final contract amount includes Change Orders Nos. 1-26 with a net total of \$1,066,731.56. The changes were primarily due to circumstances that were unforeseen at the time of design.

The project consisted of seven (7) phases in order to accommodate the on-going operational use of the taxiways. During construction, United Airlines requested that Phase 5 be modified to incorporate a "split" closure of the taxiway adjacent to their maintenance yard. The split closure would leave half of the access way open and avoid longer plane route detours. To accomplish this split phasing, an additional 60 days was added to the contract.

Additionally, during the construction of Phase 5, pavement issues were discovered with work that was completed during Phases 1, 2, and 3. The subsequent evaluation, analysis, and negotiated remedial actions for the affected areas were finalized in July 2016. The negotiated repairs and panel replacements were done as warranty issues and not subject to liquidated damages. The contract was not closed until all quality issues were addressed and accepted.

During construction, the project was managed and inspected by Houston Airport System personnel and NICET, a certified concrete quality specialist firm.

It is now requested that City Council pass a motion to approve the final contract amount of \$43,626,136.48, or 2.50% above the original construction contract amount of \$42,559,404.92 and under the 7% contingency amount, accept work, and authorize final payment.

The total project cost of \$43,626,136.48 is fully recoverable through federal funds, airline rates and charges, and other airport revenue.







AMEND MOTION #2007-259, 3/7/2007, TO INCREASE the spending authority from \$38,588,900.00 to \$54,024,460.00 for Chemical, Inorganic Metal Salt Coagulants for the Department of Public Works & Engineering, awarded to BRENNTAG SOUTHWEST, INC (Formerly ALTIVIA CORPORATION) - \$15,435,560.00 - Enterprise Fund

Background:

S12-S22149-A4- Amend Council Motion 2007-0259, passed March 7, 2007, to increase the spending authority from \$38,588,900.00 to \$54,024,460.00 for inorganic metal salt coagulant chemicals for the Department of the Public Works & Engineering.

Specific Explanation:

The Director of the Department Public Works & Engineering and the Chief Procurement Officer recommend that City Council amend Council Motion 2007-0259, passed March 7, 2007, to increase the spending authority for inorganic metal salt coagulant chemicals (aluminum sulfates and aluminum chlorohydrate) awarded to **Brenntag Southwest, Inc**. (formerly ALTIVIA Corporation) from **\$38,588,900.00** to **\$54,024,460.00.00**. Inorganic metal salt coagulant chemicals are imperative to the potable drinking water purification process as promulgated by state and Federal mandates.

This award was approved by Council on March 7, 2007 by Motion No.: 2007-0259 for a 36-month period with two option years to extend for a total 60-month term, in an amount not to exceed \$27,563,500.00 and was subsequently amended by CM#2012-0183 passed March 21, 2012 to extend the awarded term to April 17, 2015. On October 31, 2012 was amended by CM#2012-0771 to increase the spending authority to \$38,588,900.00 and subsequently amended by CM#2014-0738 passed July 30, 2014 to extend the awarded term to April 16, 2018. Expenditures as of April 13, 2017 totaled \$38,348,525.88.

In fiscal year 2013, the NEWPP was forced to increase its usage of inorganic metal salts to keep up with its rigorous water treatment plan and ensure compliance with the Environmental Protection Agency, the Texas Commission on Environmental Quality (TCEQ) and the Safe Drinking Water Act mandates. TCEQ approved the City of Houston's proposal to convert the North East Water Purification Plant (NEWPP) from its primary acidified aluminum sulfate coagulant to aluminum chlorohydrate (ACH), due to the continued degradation of raw water supply from Lake Houston. This degradation resulted in raw water influent with low alkalinity, high turbidity and very high levels of organic carbon, which diminished the effectiveness of acidified aluminum sulfate. The ACH coagulant has proven to be a more sustainable coagulant as it works effectively on a larger range of Lake Houston's raw water quality scenarios. While the primary benefit of ACH is improved turbidity

removal, the secondary benefits include reduced sludge generation and less reliance on costly secondary treatment chemicals such as caustic soda and polymer that are used to adjust finished water pH and alkalinity. In addition, the ACH coagulant is compatible with the NEWPP's existing storage and piping facilities.

Though the addition of ACH has proven highly effective and reduced overall raw water treatment costs, an

estimated \$2,000,000.00 annually, the remaining spending authority is insufficient for the remaining term. An increase in an amount not to exceed **\$15,435,560.00** will ensure there is an uninterrupted supply of this imperative chemical product until a new contract can be presented for award, which is expected within the next 120 days. All other terms and conditions shall remain as originally approved by City Council.

This recommendation is made pursuant to Chapter 252, Section 252.022 (a) (2) "a procurement necessary to preserve or protect the public health and safety of the municipality's residents" of the Texas Government Code for exempted procurements.

MWBE Subcontracting:

This contract was awarded with a 3% M/WBE participation goal and the contractor is currently achieving 2.4%. The Department's Small Business Development Section and the Office of Business Opportunity and SPD have assisted the contractor in the selection of another certified M/WBE subcontractor, EH Transport, and will continue to monitor and work with the contractor to ensure maximum M/WBE participation.

Background:

S12-S22149-A4- Amend Council Motion 2007-0259, passed March 7, 2007, to increase the spending authority from \$38,588,900.00 to \$54,024,460.00 for inorganic metal salt coagulant chemicals for the Department of the Public Works & Engineering.

Specific Explanation:

The Director of the Department Public Works & Engineering and the Chief Procurement Officer recommend that City Council amend Council Motion 2007-0259, passed March 7, 2007, to increase the spending authority for inorganic metal salt coagulant chemicals (aluminum sulfates and aluminum chlorohydrate) awarded to **Brenntag Southwest, Inc.** (formerly ALTIVIA Corporation) from **\$38,588,900.00** to **\$54,024,460.00.00**. Inorganic metal salt coagulant chemicals are imperative to the potable drinking water purification process as promulgated by state and Federal mandates.

This award was approved by Council on March 7, 2007 by Motion No.: 2007-0259 for a 36-month period with two option years to extend for a total 60-month term, in an amount not to exceed \$27,563,500.00 and was subsequently amended by CM#2012-0183 passed March 21, 2012 to extend the awarded term to April 17, 2015. On October 31, 2012 was amended by CM#2012-0771 to increase the spending authority to \$38,588,900.00 and subsequently amended by CM#2014-0738 passed July 30, 2014 to extend the awarded term to April 13, 2017 totaled \$38,348,525.88.

In fiscal year 2013, the NEWPP was forced to increase its usage of inorganic metal salts to keep up with its rigorous water treatment plan and ensure compliance with the Environmental Protection Agency, the Texas Commission on Environmental Quality (TCEQ) and the Safe Drinking Water Act mandates. TCEQ approved the City of Houston's proposal to convert the North East Water Purification Plant (NEWPP) from its primary acidified aluminum sulfate coagulant to aluminum chlorohydrate (ACH), due to the continued degradation of raw water supply from Lake Houston. This degradation resulted in raw water influent with low alkalinity, high turbidity and very high levels of organic carbon, which diminished the effectiveness of acidified aluminum sulfate. The ACH coagulant has proven to be a more sustainable coagulant as it works effectively on a larger range of Lake Houston's raw water quality scenarios. While the primary benefit of ACH is improved turbidity removal, the secondary benefits include reduced sludge generation and less reliance on costly secondary treatment chemicals such as caustic soda and polymer that are used to adjust finished water pH and alkalinity. In addition, the ACH coagulant is compatible with the NEWPP's existing storage and piping facilities.

Though the addition of ACH has proven highly effective and reduced overall raw water treatment costs, an estimated \$2,000,000.00 annually, the remaining spending authority is insufficient for the remaining term. An increase in an amount not to exceed **\$15,435,560.00** will ensure there is an uninterrupted supply of this imperative chemical product until a new contract can be presented for award, which is expected within the next 120 days. All other terms and conditions shall remain as originally approved by City Council.

This recommendation is made pursuant to Chapter 252, Section 252.022 (a) (2) "a procurement necessary to preserve or protect the public health and safety of the municipality's residents" of the Texas Government Code for exempted procurements.

MWBE Subcontracting:

This contract was awarded with a 3% M/WBE participation goal and the contractor is currently achieving 2.4%. The Department's Small Business Development Section and the Office of Business Opportunity and SPD have assisted the contractor in the selection of another certified M/WBE subcontractor, EH Transport, and will continue to monitor and work with the contractor to ensure maximum M/WBE participation.

Background:

SUBJECT: Approve an Ordinance authorizing the issuance of one or more series of City of Houston, Texas Tax and Revenue Anticipation Notes, Series 2017 (the "Series 2017 Notes"), approving and authorizing the distribution of a Preliminary Official Statement ("POS") and Official Notice of Sale ("NOS") to be used in connection with the sale of the Series 2017 Notes.

RECOMMENDATION: Approve an Ordinance authorizing the issuance of one or more series of City of Houston, Texas Tax and Revenue Anticipation Notes, Series 2017 (the "Series 2017 Notes"), approving and authorizing the distribution of a Preliminary Official Statement ("POS") and Official Notice of Sale ("NOS") to be used in connection with the sale of the Series 2017 Notes.

SPECIFIC EXPLANATION:

The City's General Fund revenue collections are not evenly distributed throughout the fiscal year. The major revenue source is ad valorem taxes, the largest part of which is collected shortly before the tax delinquency date of February 1st of each year. In order to finance its general operation expenditures each fiscal year, the City borrows against anticipated collection of taxes and revenues to cover temporary cash flow shortages. This request is for City Council's approval to issue Tax and Revenue Anticipation Notes for Fiscal Year 2018 in an aggregate amount not to exceed \$400 million.

The Tax and Revenue Anticipation Notes are structured in two parts, primarily to allow the City

to comply with federal tax laws and arbitrage regulations. The first ordinance will approve the initial borrowing. This initial issuance is sized to comply with the federal tax law exemptions and avoid arbitrage penalties. We currently project that the initial issuance will between \$150 and \$300 million and this amount, based on preliminary cash flows for FY2018, will continue to be conservatively refined until the pricing in June. The ordinance also authorizes the preparation of the POS and NOS in respect to the competitive sale of the initial Series 2017 Notes. Prior to distribution, the finance working group will approve and deem final the POS and NOS in conformity with the City's disclosure policies. The closing for the Notes is anticipated to occur in early July.

The second ordinance will authorize the Mayor and City Controller to authorize the terms of a second offering for a supplemental borrowing if there are additional cash needs later in the fiscal year. If the supplemental borrowing occurs (not to exceed \$400 million between both the initial and supplemental borrowing), the finance working group is authorized to determine certain matters relating to the supplemental borrowing consistent with the terms of this ordinance. The supplemental notes, if issued, would be repaid prior to fiscal year end. The supplemental borrowing option has only been utilized once in at least the past 12 years, in FY 2009, in an amount of \$40 million for Hurricane Ike related expenditures.

For the first borrowing, electronic bids for the Notes will be received on or about June 21, 2017 with the winning bid or bids approved via motion at the City Council meeting. If any bid becomes a leading bid within two minutes prior to the scheduled end of the bidding, the time period for submission of bids will automatically be extended by two minutes from the time that such bid was received. At the close of the bidding period, the Office of the City Controller, Finance Department and the City's Financial Advisors will verify interest rate calculations of bids received and join the City Council session to announce the results.

Since this is a competitive auction, there will not be a necessity for an underwriting team. The Law Offices of Francisco G. Medina are recommended as bond counsel. Bracewell LLP is recommended as disclosure counsel and special tax counsel.

Background:

SUBJECT: Approve an Ordinance approving a supplemental borrowing evidenced by City of Houston, Texas Tax and Revenue Anticipation Notes, Series 2017A (the "Series 2017A Notes"), which includes authorizing the execution of a note purchase agreement; approving bond counsel and special tax and special disclosure counsel making other findings and provisions related to such notes and matters incident thereto.

RECOMMENDATION: Approve an Ordinance approving a supplemental borrowing evidenced by City of Houston, Texas Tax and Revenue Anticipation Notes, Series 2017A (the "Series 2017A Notes"), which includes authorizing the execution of a note purchase agreement; approving bond counsel and special tax and special disclosure counsel making other findings and provisions related to such notes and matters incident thereto.

SPECIFIC EXPLANATION:

The City's General Fund revenue collections are not evenly distributed throughout the fiscal year. The major revenue source is ad valorem taxes, the largest part of which is collected shortly before the tax delinquency date of February 1st of each year. In order to finance its general operation expenditures each fiscal year, the City borrows against anticipated collection of taxes and revenues to cover temporary cash flow shortages. This request is for City Council's approval to issue Tax and Revenue Anticipation Notes for Fiscal Year 2018 in an aggregate amount not to exceed \$400 million.

The Tax and Revenue Anticipation Notes are structured in two parts, primarily to allow the City to comply with federal tax laws and arbitrage regulations. The first ordinance will approve the

initial borrowing. This initial issuance is sized to comply with the federal tax law exemptions and avoid arbitrage penalties. We currently project that the initial issuance will between \$150 and \$300 million and this amount, based on preliminary cash flows for FY2018, will continue to be conservatively refined until the pricing in June. The ordinance also authorizes the preparation of the Preliminary Official Statement ("POS") and Official Notice of Sale ("NOS") in respect to the competitive sale of the initial Series 2017 Notes. Prior to distribution, the finance working group will approve and deem final the POS and NOS in conformity with the City's disclosure policies. The closing for the Notes is anticipated to occur in early July.

This ordinance will authorize the Mayor and City Controller to authorize the terms of a second offering for a supplemental borrowing if there are additional cash needs later in the fiscal year. If the supplemental borrowing occurs (not to exceed \$400 million between both the initial and supplemental borrowing), the finance working group is authorized to determine certain matters relating to the supplemental borrowing consistent with the terms of this ordinance. The supplemental notes, if issued, would be repaid prior to fiscal year end. The supplemental borrowing option has only been utilized once in at least the past 12 years, in FY 2009, in an amount of \$40 million for Hurricane Ike related expenditures.

The City's usual practice for Tax and Revenue Anticipation Note borrowings is to invite electronic bids for the Notes. Depending on the size of any supplemental borrowing, this might be the method of sale used, or the size might better be handled through a negotiated sale or private placement.

At this time, there is no anticipation that an underwriting team would be necessary (particularly if bidding is used as the method of sale). The Law Offices of Francisco G. Medina are recommended as bond counsel. Bracewell LLP is recommended as disclosure counsel and special tax counsel.

The estimated project period is from July 1, 2015 through June 30, 2022.

Background:

The Houston Health Department (HHD) requests City Council's approval of an ordinance approving and authorizing an agreement between the City and Communities In Schools of Houston, Inc. (CIS) in connection with My Brother's Keeper (MBK) Houston Local Action Plan. The effective date of the contract is the date of countersignature by the City Controller and will continue for one year, with four (4) consecutive one-year renewal terms, on the same terms and conditions as the original agreement. The maximum contract amount of the agreement is \$346,800.00.

In February 2014, President Obama issued a challenge to local officials to encourage their cities to develop coherent "cradle-to-college" career strategies to help improve outcomes and reduce opportunity gaps for boys and young men of color. The City of Houston accepted the President's MBK Community Challenge in September 2014 and the HHD Director was appointed to lead Houston's response. HHD worked with a variety of individuals and organizations to develop the MBK Houston Local Action Plan. One of the cross-cutting strategies from the Local Action Plan was the implementation of an early warning system (EWS) and a system of care (SOC) response system. The EWS and SOC response system components include a systematic review of academic, behavior, attendance and other high risk social factors, an interagency intervention team on HISD campuses, a social services worker, a service provider network and care coordination to tailor services to the needs of individual students and families. These services are designed to address the social, emotional, physical and behavioral health issues that are the root causes for poor academic performance, poor attendance and unacceptable student behavior.

The mission of CIS is to surround students with a community of support, empowering them to stay in school and achieve in life. CIS partners with educators, students, and parents to identify needs of students who are at-risk of dropping out of school. Once the needs are identified, CIS customizes supports for students and families and provides individual case management services, engaging the community as part of this process. CIS monitors student level data and tracks education outcomes for those students served. Administered by the Texas Education Agency, CIS provides access to a wraparound continuum of care to over 100 schools in the Houston area and is explicitly authorized by the state to provide such services in Texas schools.

CIS will ensure individual needs are met through on-campus support and linkage to community support. The continuum of care will involve the referrals of students with moderate and intensive wraparound service needs. This contract will expand that program to directly assist 40 students which will indirectly impact approximately 300, the entire student body at HISD Scarborough High School.

Under this agreement CIS responsibilities include but are not limited to:

- A. In collaboration with the MBK Houston initiative at HISD Scarborough High School, coordinate a collaborating working relationship to maximize resources and prevent duplication of service to improve the attendance, academics, behavior, and social service needs of young people.
- B. Provide and coordinate student assistance services at the school campus in order to meet the physical and emotional needs of at-risk students and to empower these students to remain in school.
- C. Identify a full time staff person (CIS project manager) to be housed at Scarborough High School
- D. Provide and coordinate student assistance services at the school campus in order to meet the physical and emotional needs of at-risk students and to empower these students to remain in school.
- E. Identify a full time staff person (CIS project manager) to be housed at Scarborough High School
- F. Adhere to and maintain the CIS policies and procedures, including hiring practices, background checks, training of staff in regards to student interaction, methods of effective and ethical case management, data collection, and outcomes.
- G. Document services that are coordinated through this initiative at Scarborough High School in accordance with CIS policies and procedures.
- H. Maintain the case management records of all case managed students.
- I. Complete an end of year report which includes but is not limited to outcome measures demonstrating attendance, academics, behavior, and social services impact for case managed students.

III. HHD responsibilities include:

- A. Work with CIS to assure that a referral response system is in place to facilitate handling of referrals for basic needs of students and families (e.g. utilities, housing, transportation, etc.);
- B. Provide an MBK Coordinator to manage access to a service provider network to address the social services needs of students participating in the MBK system of care initiative;
- C. Establish a core connecting services center that provides information and referral that:

- a. connects people to services;
- b. seeks resources to support schools and families; and
- c. provides access to health, mental health and social services
- D. Coordinate activities and facilitate meetings of the MBK Houston EWS and SOC planning and coordination team.

Background:

Enact an ordinance to approve a construction Contract with James Construction Group, LLC to reconstruct Taxiway NA at George Bush Intercontinental Airport/Houston (IAH) and appropriate the necessary funds to cover the cost of these services.

SPECIFIC EXPLANATION:

The North Airfield Complex at Intercontinental Airport was constructed in the mid 1960's as part of the original facility and has been in continuous service since that time. Taxiway NA serves as one of the main routes for access to the terminal complex from the north and west runways.

Taxiway NA has reached the end of its service life and requires reconstruction. In addition, the reconstruction will support forecasted growth and the expansion of terminals and concourses, along with the need to accommodate larger aircraft.





Specific Explanation:

The Director of the Administration and Regulatory Affairs Department and the Acting Chief Procurement Officer recommend that City Council approve an ordinance awarding a **five-year contract**, with two one-year options to PM AM Corporation, in the estimated revenue amount of **\$10,500,000.00** for burglar alarm administration services for the Administration and Regulatory Affairs Department.

The City receives thousands of alarm calls every year. While some calls are true emergencies, many others are false alarms. In 2015, approximately 96%, nearly 76,960 of 80,390 burglar and panic alarm calls were false due to error, alarm system malfunction or improper installation, weather conditions and other causes. The purpose of this revenue sharing contract is to reduce the total number of unnecessary police responses to false alarms and ensure that the City's public safety resources serve the community as a whole as quickly and efficiently as possible

Most significantly, PMAM Corporation will reduce the number of false alarm case received by:

1. Identifying and notifying permit holders with repetitive false alarm incidents to take corrective actions.

2. Educating permit holders by providing software and customer support assistance with detecting and resolving the conditions

creating the repetitive false alarms.

3. Employing proactive false alarm prevention efforts to permit holders and non-permit holders with false alarm incidents.

4. Notifying and educating alarm system users through multiple platforms of potential false

alarm fees and penalties that could

be assessed if not properly permitted.

5. Providing software to interface with the City's GIS mapping module to offer Houston Police Officers with location alarm data

Summary:

Background:

Request for Proposal for S19-T25559 - Approve an ordinance awarding a contract to PM AM Corporation, in the estimated revenue amount of \$10,500,000.00 for burglar alarm administration services for the Administration and Regulatory Affairs Department.

Specific Explanation:

The Director of the Administration and Regulatory Affairs Department and the Acting Chief Procurement Officer recommend that City Council approve an ordinance awarding a **five-year contract**, with two one-year options to PM AM Corporation, in the estimated revenue amount of **\$10,500,000.00** for burglar alarm administration services for the Administration and Regulatory Affairs Department.

The City receives thousands of alarm calls every year. While some calls are true emergencies, many others are false alarms. In 2015, approximately 96%, nearly 76,960 of 80,390 burglar and panic alarm calls were false due to error, alarm system malfunction or improper installation, weather conditions and other causes. The purpose of this revenue sharing contract is to reduce the total number of unnecessary police responses to false alarms and ensure that the City's public safety resources serve the community as a whole as quickly and efficiently as possible

Most significantly, PM AM Corporation will reduce the number of false alarm case received by:

- 1. Identifying and notifying permit holders with repetitive false alarm incidents to take corrective actions.
- 2. Educating permit holders by providing software and customer support assistance with detecting and resolving the conditions creating the repetitive false alarms.
- 3. Employing proactive false alarm prevention efforts to permit holders and non-permit holders with false alarm incidents.
- 4. Notifying and educating alarm system users through multiple platforms of potential false alarm fees and penalties that could be assessed if not properly permitted.
- Providing software to interface with the City's GIS mapping module to offer Houston Police Officers with location alarm data and false alarm reports. Once specific high-volume false alarm areas are identified, additional targeted actions can be taken to reduce repetitive incidences.

PM AM Corporation received the highest overall score.
