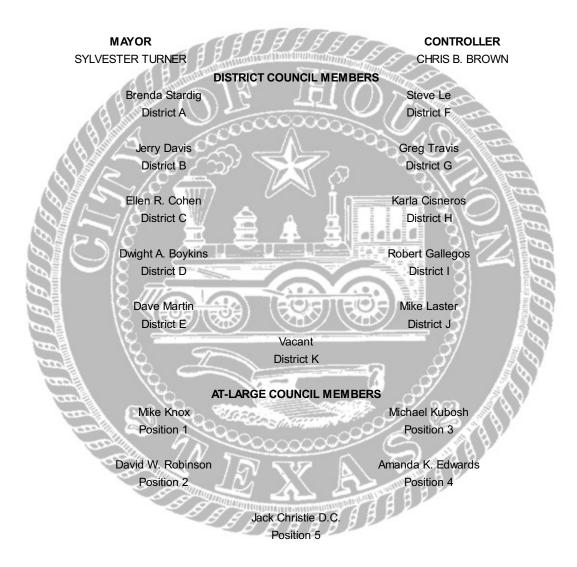

Background:

SUBJECT: Accept Work to Install Advanced Traffic Control Devices at Houston Arterial Traffic Signal System (HATSS) Intersections.

RECOMMENDATION: **(SUMMARY)** Pass a motion to approve the final Contract Amount of \$3,841,589.13 or 4.23% under the original Contract Amount, accept the Work and authorize final payment.

PROJECT NOTICE/JUSTIFICATION: This project was part of the Street and Traffic Capital Improvement Project (CIP) and was required to meet City of Houston standards and improve traffic. This project was approved by the Texas Transportation Commission in the 2013-2016 Transportation Improvement Program (TIP). Under this program, construction funding included both Federal and City participation. The State shall refund the City 80% of the construction cost up to \$2,032,120.00 which will be reimbursed through monthly billings as cost incurs for the project.

DESCRIPTION/SCOPE: This project consisted of rebuilding fourteen (14) traffic signals and traffic signal interconnect (fiber optic) installation along five (5) corridors. EPIC Transportation Group, LP. designed the project with 730 calendar days allowed for construction. The project was awarded to Traffic Systems Construction, Inc. with an original Contract Amount of \$4,011,142.00.

LOCATION: The project area is in fourteen (14) locations for traffic signal rebuild and five (5) corridors for traffic signal interconnect installation.

SWD - Amendment to Chapter 39

Summary:

ORDINANCE **AMENDING SECTION 39-62 OF THE CODE OF ORDINANCES, HOUSTON, TEXAS**, relating to responsibility for and establishing fees associated with replacement and retrieval of City solid waste containers

Background:

The Solid Waste Management Department (SWMD) spends a significant amount of money annually purchasing an average of 20,000 carts (garbage and recycling) to replace lost, stolen and/or damaged garbage and recycling carts. Those monies are currently not recovered from residents. The useful life of a typical City solid waste garbage or recycling container is about ten (10) years, which can increase depending on how the resident cares for his/her container as well as the quality of SWMD operator's work.

To relieve the City of a portion of the cost of purchasing these carts, the SWMD recommends amending Chapter 39, Section 62 to include a fee to be assessed to residents needing to replace their garbage and/or recycling cart more frequently than once every 10 years. The initial fees would be \$23.84 for the delivery or retrieval of cart; \$40.14 for cart cleaning; and the actual contracted cost of the cart at the time of replacement. The current cost of a cart is \$49.88.

To support this recommendation SWMD reviewed the 311 LAGAN cases regarding container related requests for past fiscal years. During this review, it was found that multiple residents requested replacement carts more than 10 separate times over two years.

In addition, SWMD has observed an ongoing trend of residents improperly acquiring additional garbage and/or recycling carts. When residents fail to properly enroll those carts in the extra capacity program, and pay the associated monthly fee, the extra material collected increases both collection and disposal costs for the City. When improperly acquired carts are identified there is an additional cost to SWMD in the retrieval and cleaning of those carts so that they may be reused. The recommended retrieval fee, and cart cleaning fee would offset this cost to the department.

The anticipated goal of this program will be for residents to take better care of City property and reduce the number of incidences of habitual reports of container replacements, and to recoup expenses for improperly acquired containers. The proposed changes were presented the Council Committee for Regulatory and Neighborhood Affairs on December 14, 2017. Citizens will be notified of these changes via Citizens Net; direct mail; Next Door and other social media; and by the SWMD Community Outreach team.

The SWMD therefore recommends approving an ordinance amending Chapter 39 of the Code of Ordinances, Houston, Texas, relating to responsibility for and establishing fees associated with replacement and retrieval of city solid waste containers. Proposed revisions to the existing ordinance: Amend Chapter 39, Section 62 by adding new Items (2) through (5). The related fees will be incorporated into the City Fee Schedule and subject the annual CPI adjustments. The amended Chapter 39, Section 62 will address the responsibility for maintaining City solid waste containers, the retrieval and cleaning of improperly acquired City Solid Waste Containers, and the fees associated with those activities.

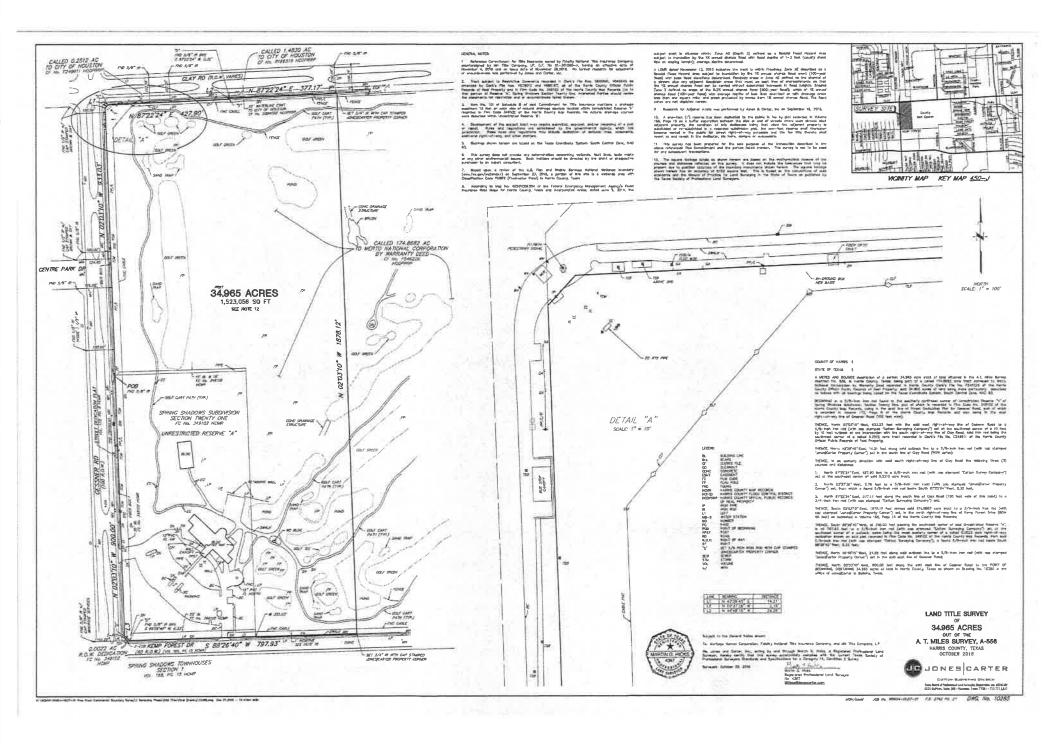
EXHIBIT 1 VICINITY MAP

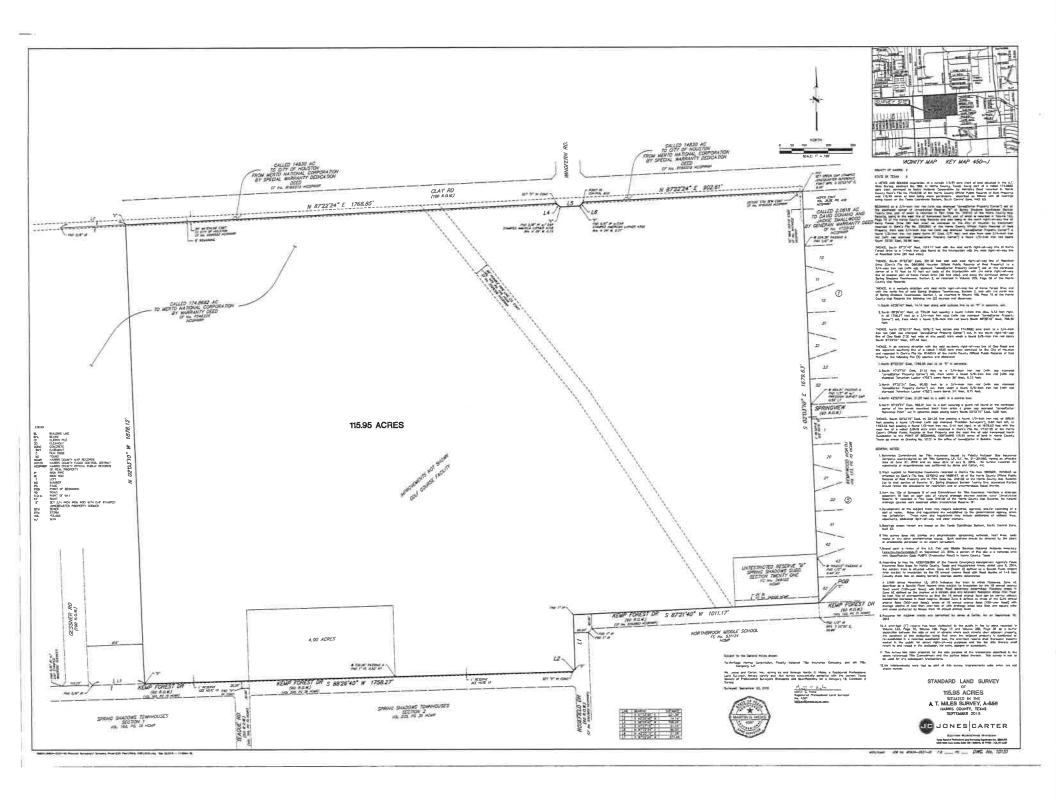

Attached are the restrictions that we spoke about. The property owner will restrict the property east of the commercial tract as follows:

- (Section 1) Restricts Pinecrest Tracts II-V (discussed as Phases II-V) against the use of multifamily residential for 30 years (1/1/18-12/31/47). It clarifies that duplex homes, zero-lot-line homes, patio homes or townhomes are NOT deemed as being restricted.
- (Section 2) Limits Tracts II-V to single family homes for 6 years (1/1/18-12/31/23), and clarifies that duplex homes, zero-lot –line homes, patio homes and townhomes ARE permitted.
- (Section 3) We have the right to remove up to 30 acres in the northwest corner from the single family use requirement. We cannot specifically describe that Phase V land because we don't have a legal description by tract. I estimated at 30 acres (Phase V on the general plan looks bigger than the other tracts even though Meritage is required on each takedown to purchase at least 20 acres which would then leave approximately 20 acres in Phase V). If given some time before recording, we could get with Meritage and get a surveyor out there and then describe with the excluded tract with a specific legal description.

Just some other statements/commitments we have made include:

- The MUD allows the development to provide 16.1 acre feet detention above the city's required detention for the single family and commercial development.
- The MUD allows for a higher quality single-family residential development and a commercial center targeted for residential supportive retail.
- An amenitized linear detention pond creating a park setting with walking trails are accessible to the public.
- The initial MUD Board includes 2 residents that reside in Spring Shadows and live near the development. Board members will eventually transition to homeowners and the commercial property owner in the MUD.
- This project could not support the added detention, recreational facilities and lower density (and quality of homes) without the MUD.

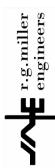
VICINITY MAP

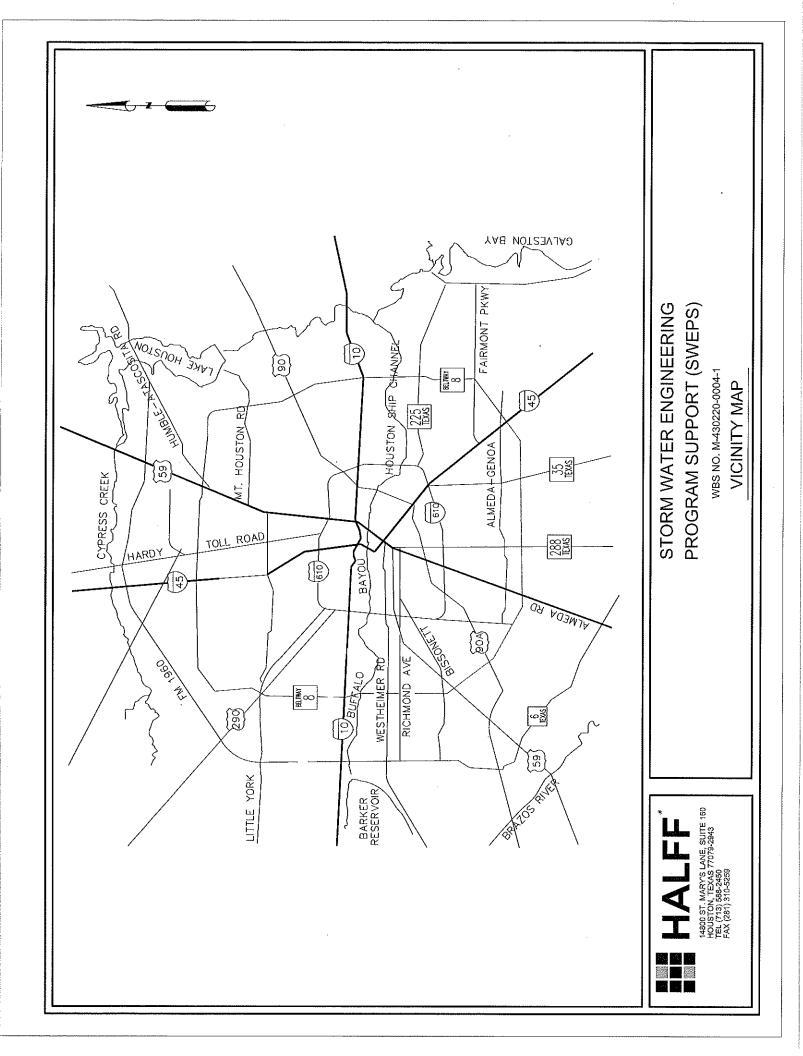

Background:

SUBJECT: Accept Work for Northside Sewer Relief Tunnel Rehabilitation Area No. 5.

RECOMMENDATION: (SUMMARY) Pass a motion to approve the final Contract Amount of \$9,106,698.06 or 7.78% under the original Contract Amount, accept the Work and authorize final payment.

PROJECT NOTICE/JUSTIFICATION: This project was part of the City's ongoing program for Northside Sewer Relief Tunnel Rehabilitation. It was required to rehabilitate Phase II of Area No. 5 of the tunnel, which had moderate to severe corrosion, and to protect it from future corrosion. The rehabilitation of Phase I, under a previously awarded contract, is complete.

DESCRIPTION/SCOPE: The project consisted of the rehabilitation, by slip lining, of 3,130 linear feet of 132-inch inside diameter monolithically cast-in-place reinforced concrete sanitary sewer with 120-inch fiberglass reinforced polymer mortar pipe. Included are diversion pumping, the rehabilitation of two manholes, and the rehabilitation of the Clinton Drive Lift Station's junction box. Binkley & Barfield, Inc. designed the project with 540 calendar days allowed for construction. The project was awarded to Oscar Renda Contracting, Inc. with an original Contract Amount of \$9.875.282.00.

LOCATION: The project area is generally bounded by IH-10 on the north, Buffalo Bayou on the south, Hirsh Street on the east and Bayou Road on the west. The project is located in Key Map Grids 494J, K and L.

<u>CONTRACT COMPLETION AND COST:</u> The Contractor, Oscar Renda Contracting, Inc., has completed the work under the subject Contract. The project was completed beyond the established completion date with an additional 154 days approved by Change Order No 1. 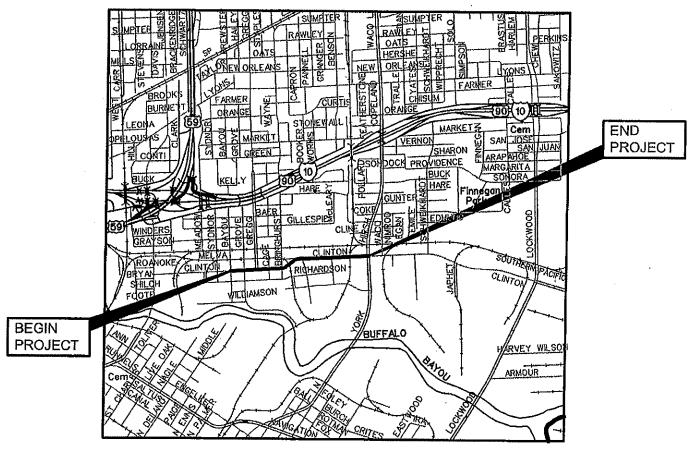

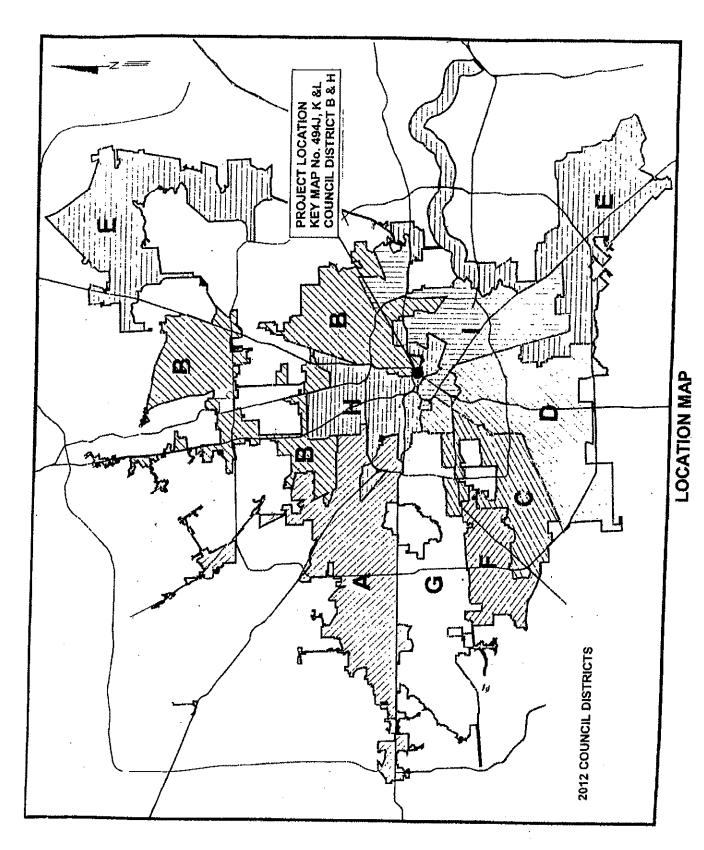
