This project is part of the City's regionalization program and is in compliance with the Harris-Galveston Subsidence District requirement to implement the City's long-range water supply plan. The subject water line easement is needed for the Northeast Transmission Line segment of the program.

This eminent domain proceeding involves the acquisition of fee simple title to a parcel of land containing a total of 170,909 square feet (3.9235 acres). The property is owned by Forgings 24/7 Inc. and is located in the area of Smith Road near Aldine Bender in Northeast Houston. Efforts by Houston Public Works to negotiate the property purchase failed, and the matter was referred to the Legal Department to initiate eminent domain proceedings to acquire the needed property.

A contested Special Commissioners' hearing was convened, and the Special Commissioners ordered an award of \$435,000.00. With Council approval, the City Attorney deposited this award into the registry of the court.

The parties submitted new appraisals to be used at trial. The City's new appraisal of value for the entire property acquisition to be presented at trial is now \$374,888.00. The landowner's new appraisal of value for the entire property acquisition to be presented at trial is now \$723,737.00.

The parties then proceeded to court-ordered mediation. At mediation, the parties agreed to an increase of \$110,000.00 above the special commissioners' award to fully settle the condemnation proceeding.

We recommend that the City Attorney be authorized by Motion to settle this condemnation proceeding for an additional \$110,000.00 above the already-deposited special commissioners' award which will bring the total compensation for this property acquisition to \$545,000.00.

#### Specific Explanation:

The Chief Information Officer and the Chief Procurement Officer recommend that City Council approve spending authority in an amount not to exceed **\$30,726,542.47** for the purchase of enterprise licenses and software maintenance for all City of Houston users and endpoints through Texas Department of Information Resources (DIR). Additionally, it is also recommended that authorization be given to issue purchase orders as necessary to the DIR vendor, **SHI Government Solutions, Inc.** for various departments.

This council action will provide citywide spending authority through 9/30/2022; allow departments to comply with license trueup requirements; and add security and data protection tools for all City departments.

#### Background:

In 2009, HITS, on behalf of the City of Houston, negotiated and entered into a tiered, multi-year Microsoft Enterprise License Agreement to purchase licenses and software maintenance for the fleet of City PCs. The purpose of this agreement was to continue the process of updating the City's technology to current software standards and ensure that the City remains in compliance with stringent software licensing requirements. This agreement was divided into 5 separate tiered agreements.

## Background:

**SUBJECT: AMENDING** Ordinance Number 2017-841, passed on October 25, 2017, to include the acquisition of redesigned Parcel KY17-031 for the EASEMENT ACQUISITIONS FOR 108-INCH WATER LINE FROM ALDINE WESTFIELD TO WILLIS STREET PROJECT by dedication, purchase, or condemnation.

**RECOMMENDATION:** (Summary) It is recommended City Council amend Ordinance Number 2017-841, passed on October 25, 2017, to authorize and approve the acquisition of redesigned Parcel KY17-031 for the EASEMENT ACQUISITIONS FOR 108-INCH WATER LINE FROM ALDINE WESTFIELD TO WILLIS STREET PROJECT by dedication, purchase, or condemnation.

### **SPECIFIC EXPLANATION:**

The EASEMENT ACQUISITIONS FOR 108-INCH WATER LINE FROM ALDINE WESTFIELD TO WILLIS STREET PROJECT provides for the design and construction of transmission and distribution lines to convey treated water from surface water facilities. This project is part of the City's regionalization program and is in compliance with the Harris-Galveston Subsidence District requirement to implement the City's long-range water supply plan. The subject water line easement parcels are needed for the Northeast Transmission Line segment of the program.

By Ordinances 2018-505, passed June 20, 2018, and 2017-841, passed on October 25, 2017, City Council authorized and approved the acquisition of parcels by dedication, purchase, or condemnation for the EASEMENT ACQUISITIONS FOR 108-INCH WATER LINE FROM ALDINE WESTFIELD TO WILLIS STREET PROJECT. Since those ordinances passed, Parcel KY17-031 has been revised. Therefore, it is recommended that Ordinance Number 2017-841 be amended to reflect the aforementioned redesign of Parcel KY17-031.

This action authorizes payment for costs of land purchases/condemnations, relocation assistance expenses, appraisal fees, title policies/services, recording fees and other acquisition costs in connection

with negotiations to settle purchases; finds a public necessity for the project; and approves and authorizes the condemnation of the land and improvements thereon. If negotiations to acquire the property cannot be concluded as dedication or purchase or for any reason for which acquisition by condemnation is warranted, this action authorizes the City Attorney to file or cause Eminent Domain proceedings to be filed and acquire land, rights-of-way and/or condemnation proceedings. Parcels with a consideration that exceeds the spending authority threshold set by State law will be submitted to City Council as they are finalized. #### SPECIFIC EXPLANATION:

The EASEMENT ACQUISITIONS FOR 108-INCH WATER LINE FROM ALDINE WESTFIELD TO WILLIS STREET PROJECT provides for the design and construction of transmission and distribution lines to convey treated water from surface water facilities. This project is part of the City's regionalization program and is in compliance with the Harris-Galveston Subsidence District requirement to implement the City's long-range water supply plan. The subject water line easement parcels are needed for the Northeast Transmission Line segment of the program.

By Ordinances 2018-505, passed June 20, 2018, and 2017-841, passed on October 25, 2017, City Council authorized and approved the acquisition of parcels by dedication, purchase, or condemnation for the EASEMENT ACQUISITIONS FOR 108-INCH WATER LINE FROM ALDINE WESTFIELD TO WILLIS STREET PROJECT. Since those ordinances passed, Parcel KY17-031 has been revised. Therefore, it is recommended that Ordinance Number 2017-841 be amended to reflect the aforementioned redesign of Parcel KY17-031.

This action authorizes payment for costs of land purchases/condemnations, relocation assistance expenses, appraisal fees, title policies/services, recording fees and other acquisition costs in connection with negotiations to settle purchases; finds a public necessity for the project; and approves and authorizes the condemnation of the land and improvements thereon. If negotiations to acquire the property cannot be concluded as dedication or purchase or for any reason for which acquisition by condemnation is warranted, this action authorizes the City Attorney to file or cause Eminent Domain proceedings to be filed and acquire land, rights-of-way and/or condemnation proceedings. The Chief of Police for the Houston Police Department (HPD) recommends that City Council approve an Interlocal Agreement between the City of Houston and Harris County. The City of Houston, through HPD, applied for and received the Internet Crimes Against Children Task Force - Houston Metropolitan Area Grant from the Office of the Governor's Criminal Justice Division (Ordinance No. 2019-0026, January 16, 2019). This grant allows HPD to continue to reduce the exploitation of children by expanding the number of affiliate law enforcement agencies and personnel dedicated to investigating and prosecuting Internet-related crimes against children. The grant period is for 18-months ending August 31, 2020.

The target geographical area of the grant program is the Houston Metropolitan Area, which includes incorporated as well as unincorporated areas of Harris County, Texas; and all areas of Brazoria, Chambers, Fort Bend, Galveston, Liberty, Montgomery and Waller Counties. As the lead agency, HPD is entering into an Interlocal Agreement with Harris County which will complete the special condition requirement of the grant for this year's funding. Pursuant to the Interlocal Agreement, the City of Houston will use \$155,786 in grant funds to reimburse Harris County for salaries and benefits of its investigator/detective participating in the Internet Crimes Against Children Task Force.
