GSD's In-House Renovation Group will provide the labor and expertise required to install the donated units.

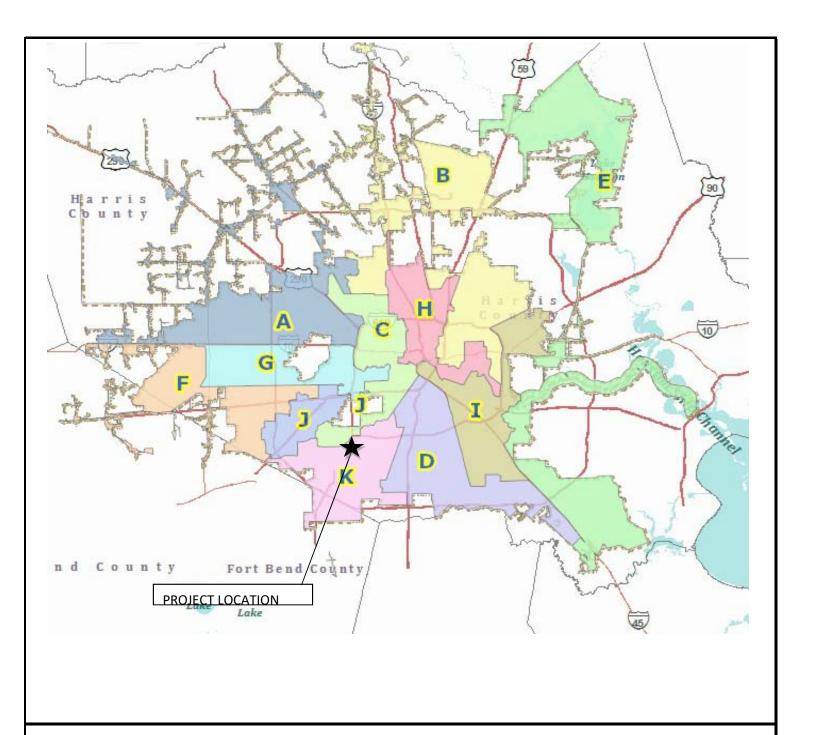

Background:

RECOMMENDATION: Appropriate additional funds for the TOC/JOC Contracting Program for FY2019.

SPECIFIC EXPLANATION: The General Services Department (GSD) utilizes task order and job order contracts to facilitate minor architectural and engineering design services; mechanical, electrical and plumbing services; roof consulting services; construction, repairs, rehabilitations, or alterations of facilities for its client departments. Having these contracts in place allows the City to expedite smaller facility construction projects and can help the City respond quickly to facility needs. Funds are allocated to design task order contracts or construction job order contracts as work orders are issued. Accordingly, GSD recommends that City Council appropriate an additional \$2,938,842.00 to the TOC/JOC Contracting Program for professional and construction services for General Government, Police, Health, Library, Solid Waste Management, and Parks and Recreation Departments for FY 2019.

BACKGROUND: The TOC/JOC Program is funded through supplemental allocations from various departmental budgets or appropriations from various bond funds, up to the maximum contract amount, as departments identify projects and specific funding for each project. Fees for each TOC project is negotiated based upon the size and complexity of the tasks involved. JOC

work orders are issued and approved in accordance with pre-described and pre-priced tasks as established by the *R.S. Means Facilities Construction Cost Data* book.

PROJECT LOCATIONS: Citywide

PROJECT DESCRIPTION: See attached list.

PREVIOUS HISTORY AND PROJECT SCOPE: On November 14, 2018, Ordinance No. 2018-0901, Council appropriated \$12,606,000.00 for the TOC/JOC Contracting Program for FY2019 for professional and construction services for the General Government, Health, Police, Library, Fire, and Parks and Recreation Departments.

TOC CONTRACTORS: Currently, GSD utilizes ten TOC contractors: Collaborate Arch, LLC (Collaborate); English & Associates Architects, Inc. (English); Prozign, Inc. (Prozign); CSF Consulting, L.P. (CSF); Jaymark Engineering Corporation (Jaymark); Walter P. Moore and Associates, Inc. (WPM); Hunt & Hunt Engineering Corporation (Hunt&Hunt); Infrastructure Associates, Inc. (Infrastructure); Building Envelope Consultants, LLC.(BEC); and Wiss, Janney, Elstner Associates, Inc.(WJEA).

On December 18, 2013, Ordinance No. 2013-1201, Council approved an architectural services task order contract with Collaborate, English, and Prozign, for a term of three years with two one-year renewal options. Each contract has a maximum contract amount of \$1,500,000 except for Collaborate, which is set at \$2,000,000, and was authorized by Council on September 23, 2015, by Ordinance No. 2015-0901; and BEC, which is set at \$2,000,000, and was authorized by Council on March 22, 2017, by Ordinance No. 2017-0207. GSD has negotiated new architectural services task order contracts and will request Council approval in a separate Council action.

On April 6, 2016, Ordinance No. 2016-0264, Council approved a professional engineering services task order contract with CSF, Jaymark, WPM, Hunt & Hunt, and Infrastructure, for a term of three years with two one-year renewal options. Each contract has a maximum contract amount of \$1,000,000.

On May 29, 2019, Ordinance No. 2019-0391, Council approved a building envelope consulting services task order contract with BEC; WPM; and WJEA for a term of three years with three one-year renewal options. Each contract has a maximum contract amount of \$2,500,000.

JOC CONTRACTORS: Currently, GSD utilizes four JOC contractors. On June 17, 2015, Ordinance No. 2015-0610, Council awarded a job order contract to Jamail & Smith Construction, LP (Jamail); Kellogg Brown & Root LLC (KBR); Horizon International Group (Horizon); and P^2MG, LLC (P2MG), for a term of two-years with three one-year renewal options. Background:

RECOMMENDATION: Appropriate additional funds for the TOC/JOC Contracting Program for FY2019.

SPECIFIC EXPLANATION: The General Services Department (GSD) utilizes task order and job order contracts to facilitate minor architectural and engineering design services; mechanical, electrical and plumbing services; roof consulting services; construction, repairs, rehabilitations, or alterations of facilities for its client departments. Having these contracts in place allows the City to expedite smaller facility construction projects and can help the City respond quickly to facility needs. Funds are allocated to design task order contracts or construction job order contracts as work orders are issued. Accordingly, GSD recommends that City Council appropriate an additional \$2,938,842.00 to the TOC/JOC Contracting Program for professional and construction services for General Government, Police, Health, Library, Solld Waste Management, and Parks and Recreation Departments for FY 2019.

BACKGROUND: The TOC/JOC Program is funded through supplemental allocations from various departmental budgets or appropriations from various bond funds, up to the maximum contract amount, as departments identify projects and specific funding for each project. Fees for each TOC project is negotiated based upon the size and complexity of the tasks involved. JOC work orders are issued and approved in accordance with pre-described and pre-priced tasks as established by the *R.S. Means Facilities Construction Cost Data* book.

PROJECT LOCATIONS: Citywide

PROJECT DESCRIPTION: See attached list.

PREVIOUS HISTORY AND PROJECT SCOPE: On November 14, 2018, Ordinance No. 2018-0901, Council appropriated \$12,606,000.00 for the TOC/JOC Contracting Program for FY2019 for professional and construction services for the General Government, Health, Police, Library, Fire, and Parks and Recreation Departments.

TOC CONTRACTORS: Currently, GSD utilizes ten TOC contractors: Collaborate Arch, LLC (Collaborate); English & Associates Architects, Inc. (English); Prozign, Inc. (Prozign); CSF Consulting, L.P. (CSF); Jaymark Engineering Corporation (Jaymark); Walter P. Moore and Associates, Inc. (WPM); Hunt & Hunt Engineering Corporation (Hunt&Hunt); Infrastructure Associates, Inc. (Infrastructure); Building Envelope Consultants, LLC.(BEC); and Wiss, Janney, Elstner Associates, Inc. (WJEA).

On December 18, 2013, Ordinance No. 2013-1201, Council approved an architectural services task order contract with Collaborate, English, and Prozign, for a term of three years with two one-year renewal options. Each contract has a maximum contract amount of \$1,500,000 except for Collaborate, which is set at \$2,000,000, and was authorized by Council on September 23, 2015, by Ordinance No. 2015-0901; and BEC, which is set at \$2,000,000, and was authorized by Council on March 22, 2017, by Ordinance No. 2017-0207. GSD has negotiated new architectural services task order contracts and will request Council approval in a separate Council action.

On April 6, 2016, Ordinance No. 2016-0264, Council approved a professional engineering services task order contract with CSF, Jaymark, WPM, Hunt & Hunt, and Infrastructure, for a term of three years with two one-year renewal options. Each contract has a maximum contract amount of \$1,000,000.

On May 29, 2019, Ordinance No. 2019-0391, Council approved a building envelope consulting services task order contract with BEC; WPM; and WJEA for a term of three years with three one-year renewal options. Each contract has a maximum contract amount of \$2,500,000.

The Cyberlab is the system that tracks the HHD laboratory testing. This agreement provides that Aspyra will perform the following services: 1) all repairs necessary to keep the equipment in good operating condition in accordance with the applicable functional specifications; 2) repair or replace specified parts, and 3) improve, modify, enhance and maintain the software.

The HHD laboratory performs approximately 264 different types of tests for hospitals, clinics, other governmental entities and HHD public health surveillance programs. It is one of 11 Laboratory Response Network (LRN) labs in Texas with biosafety level (BSL) 3 capabilities. HHD laboratory provides expertise in areas such as testing for biological agents, testing samples for influenza, advanced viral and bacterial identification. Background:

S36-Q25260.A1- Approve an ordinance authorizing a first amendment to Contract No. 460013235 between the City of Houston and Walker Parking Consultants/Engineers, Inc. (Approved by Ordinance No. 2015-640 passed June 24, 2015) for Project Management Services for Automatic Parking Guidance System to extend the contract term from July 8, 2019 to July 8, 2022 for the Administration and Regulatory Affairs Department.

Specific Explanation:

The Director of Administration and Regulatory Affairs and the Chief Procurement Officer recommend that City Council approve an ordinance authorizing a first amendment to the contract between the City of Houston and Walker Parking Consultants/Engineers, Inc. to extend the contract term from July 8, 2019 to July 8, 2022 for Project Management Services for Automatic Parking Guidance System for the Administration and Regulatory Affairs Department.

This original contract was awarded on June 24, 2015 by Ordinance 2015-640 for a total four-year term in the original amount of \$250,000.00. Expenditures as of June 14, 2019 totaled \$177,617.78. No additional spending authority is required. All other terms and conditions of the contract shall remain the same.

The Scope of work requires the Contractor to provide all personnel, materials, and supervision necessary to provide project management services, which includes, but is not limited to assessment and design for a pilot project to implement an Automated Parking Guidance System in downtown parking structures and on-street parking spaces.

Background::

In order to execute the final milestones of the Project Management Services contract with Walker Parking Consultants, the City must have approval from TxDOT to publish the RFP for the automated parking guidance system. Walker assisted with the development of the RFP documents. The RFP was first submitted to TxDOT for approval. TxDOT informed the City that it would need to provide construction drawings for the

installation of the signs. In coordination with Houston Public Works, drawings were developed over a sixmonth period and submitted to TxDOT for approval along with the RFP. At this time, TxDOT determined that instead of an RFP, the City should issue a low bid request, essentially treating what is a technology project as a construction project. Module Number 1 Programmable Logic Controllers and software, 3. Addition of a new raw sludge thickener and a new basin drain pump station at Treatment Module Number 2, 4. Replacing High Service Pumping Station switchgears with new synchronous motor controllers, 5. Bypass modification for sedimentation basin drain piping for Treatment Module Number 2, 6. Replacing Electrical Substation Transformers, 7. Providing electronically completed Technical Asset Data forms, and 8. Sludge dredging of the Process Overflow Basin. The Project was awarded to Industrial TX Corp., with an original Contract amount of \$13,230,000.00.

SCOPE OF THIS AMENDMENT AND FEE: Under the scope of the First Amendment, the Contractor will accomplish the following: additional work added to the contract includes Treatment Module 1 Settling Basin A and B and bypass valve for Transfer Pump 3161. The current contract also calls for installation of soft starters and programming for the high service pumps and motors. additional work for rehabilitation of high service pumps, transfer pumps and treatment modules. It is beneficial for the City to add rehabilitation of high service pumps and motors along with the associated electrical work so only a single shut down is required to perform all the work. The City deleted the scope of work for rehabilitation of High Service Pumps (HSP) Nos. 5101, 5102, 5104, 5105, 5106, and Transfer Pumps Nos. 3161 and 3162 from the previous Contract SEWPP Sedimentation Basins A & B Improvements (TM1), Flocculators Rehabilitation Basins A & B (TM1), Rehabilitation of Transfer and Distribution Pumps & Motors and On-Call Miscellaneous Engineering Services due to the Southeast Water Purification Plant (SEWPP) Drinking Water Operations' (DWO) inability to release the existing high service pumps and motors for rehabilitation, as referenced in the previous contract due to high water demand period. 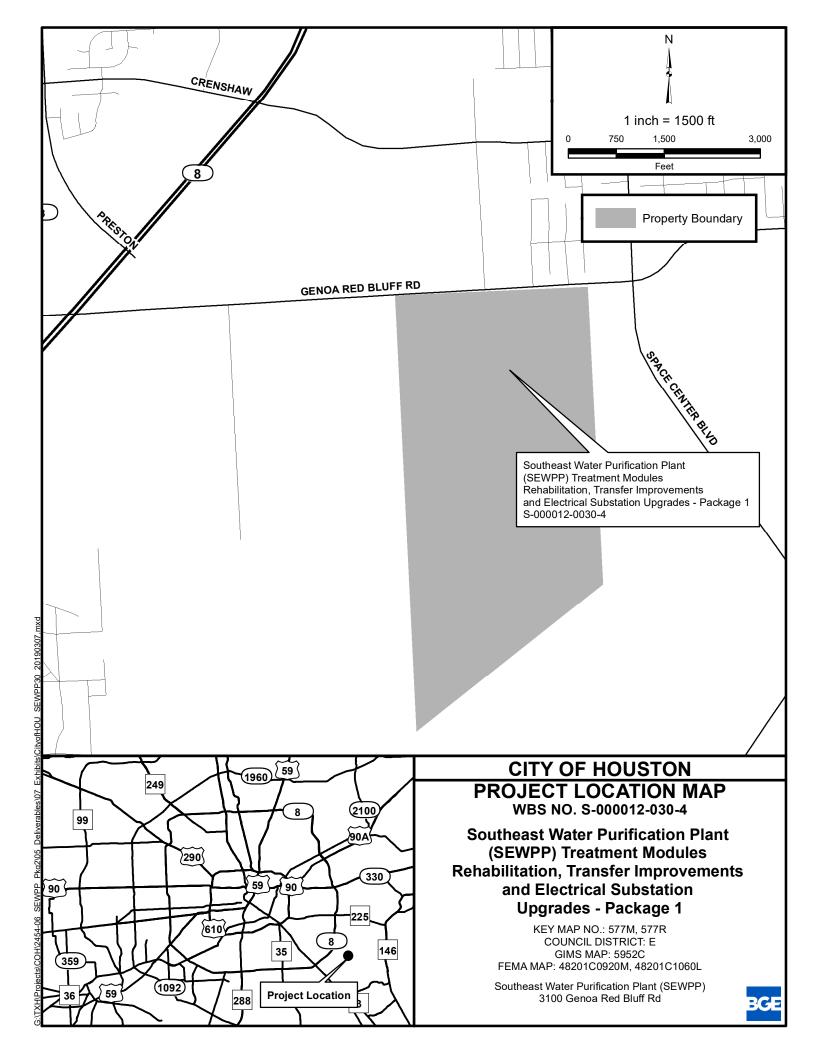

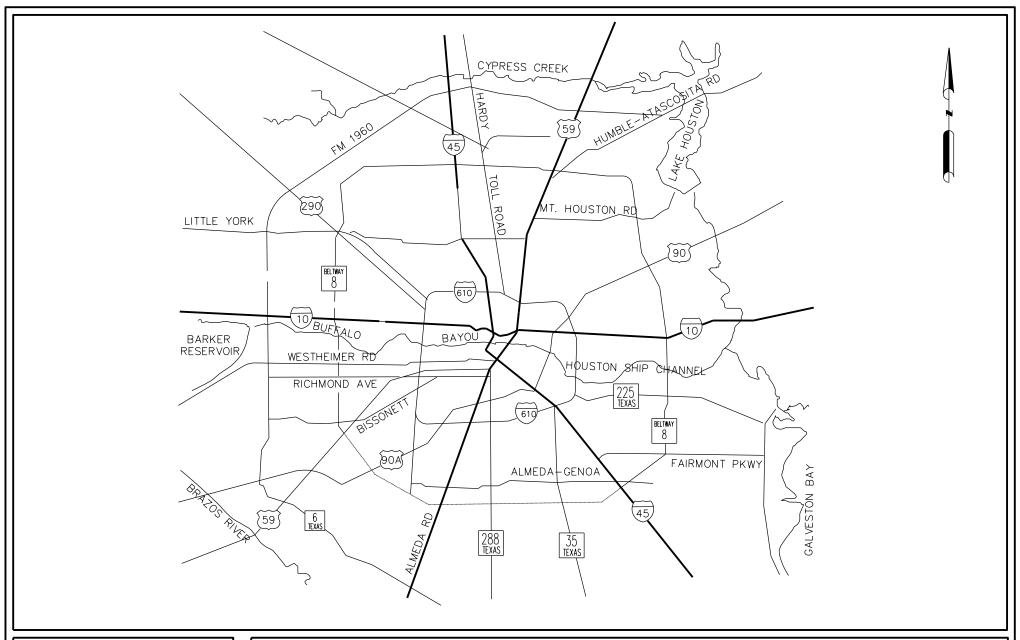

SUBJECT: First Amendment to Professional Engineering Services Contract between the City and AECOM Technical Services, Inc.

RECOMMENDATION: (SUMMARY) Approve First Amendment to the Professional Engineering Services Contract for Greens Road from John F. Kennedy Boulevard to US 59 (North) with AECOM Technical Services Inc. and appropriate funds.

PROJECT NOTICE/JUSTIFICATION: This project is part of the Street and Traffic Control Capital Improvement Plan (CIP) program. This program is required to improve traffic flow/circulation, reduce congestion, and eliminate potential hazards.

<u>DESCRIPTION/SCOPE:</u> This project consists of removal of an existing two-lane asphalt roadway with open ditch drainage and replacement with a four-lane concrete pavement with divided boulevard section with curbs. Also included are underground storm sewer system, off-site storm water detention facilities, and replacement of sanitary and water lines. Federal funding participation is approved by Houston Galveston Area Council (HGAC) under the 2013-2016 Transportation Improvement Program (TIP) for \$9.68 million (80% of the estimated construction cost).

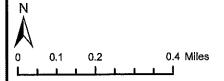

Background:

RECOMMENDATION: Award construction contract and appropriate funds for the project.

SPECIFIC EXPLANATION: The General Services Department (GSD) recommends that City Council award a construction contract to Millis Development and Construction, LLC on the proposal amount of \$2,716,212.00 to provide construction services for Squatty Lyons Park for the Houston Parks and Recreation Department.

PROJECT LOCATION: 1701 Chamberlain (413 U)

PROJECT DESCRIPTION: The scope of work consists of renovating three baseball fields including replacement of fences/backstops, dugouts, field repair and regrading, irrigation and sport lighting for two of the fields. Other amenities for the park include new parking lot; a prefab building for restrooms/storage/concession; new playground; paving; fencing; site amenities; security lighting; and landscaping and irrigation.

The contract duration for this project is 270 calendar days from the date of the Notice to Proceed. Clark Condon Associates, Inc. is the design consultant for this project.

PROPOSALS: On December 14 and 21, 2018, GSD advertised a Request for Competitive Sealed Proposals (CSP) for construction services for Squalty Lyons Park. The CSP contained selection criteria that ranked respondents on experience, key personnel, safety and Hire Houston First. The Statements of Qualifications were due on January 10, 2019, and thirteen firms responded. GSD evaluated the respondents and five of the thirteen firms received sufficient points and were requested to submit proposals. Four firms submitted proposals. Millis Development and Construction, LLC submitted the lowest proposal and offers the best value for the City based on the advertised criteria.

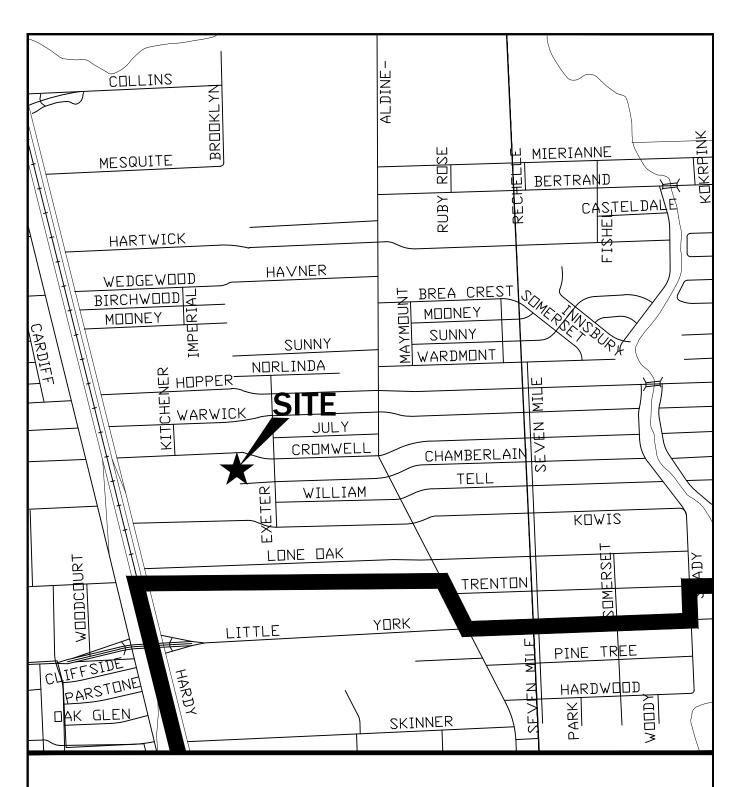
