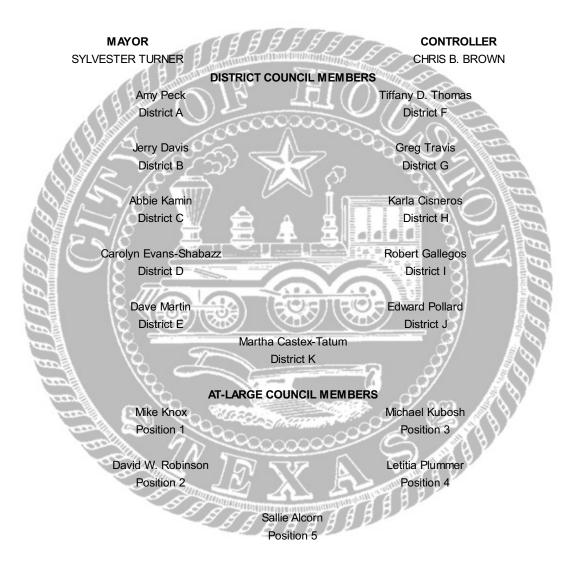

Eleven (11) amendments were submitted by private sector applicants, four (4) by public sector applicants, including one (1) from Harris County, one (1) from Waller County, and two (2) from the City of Houston. The City of Houston grouped their amendments together; the Southeast Houston Mobility Plan incorporated 48 separate amendments and the Downtown/Midtown request incorporated 56 separate amendments, for a total of 104 City proposed Amendments. There were four (4) amendments that were subsequently withdrawn by the applicants: two (2) from the private sector and two (2) from the public sector. Three amendments were deferred for further review and consideration. These amendments are listed below:

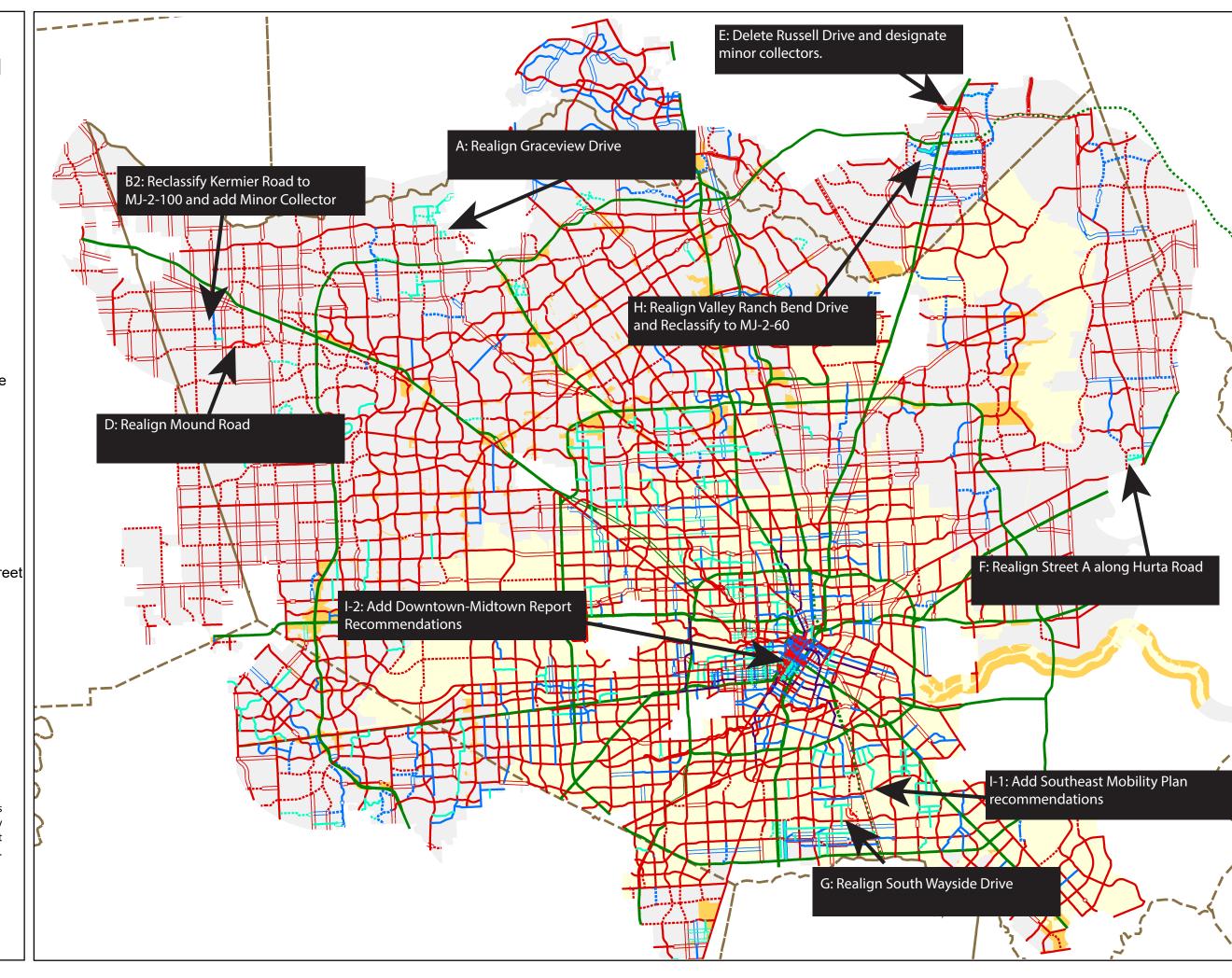

Summary:

RESOLUTION declaring the second Monday of October as Indigenous Peoples' Day

Background:

October 12, 1492, marks one of the most significant dates to all indigenous people of the Americas – the beginning of the colonization of indigenous people that forever changed their identity, cultures and achievements. The area around present-day Houston was home to many different groups, bands, and tribes of Indigenous Peoples likely dating as far back as 9,000 years ago, and the City of Houston acknowledges and honors these members of the community. The City of Houston recognizes and values the historic, cultural, and contemporary significance and contributions made to this community by all our region's past and present Indigenous Peoples.

Indigenous Peoples' Day was first proposed in 1977 by a delegation of Native Nations to the United States-sponsored International Conference on Discrimination Against Indigenous Populations in the Americas. A growing number of cities and states across the United States have recognized the second Monday of October as Indigenous Peoples' Day as an alternative to the federally recognized Columbus Day.

Officially recognizing Indigenous Peoples' Day on the second Monday of October provides a more balanced representation of our region's cultural and diverse history and constitutes a small act of restitution for the hardships endured by Indigenous Peoples since the onset of European colonization of the Americas.

It is recommended that the City Council adopt a resolution 1) declaring the second Monday in October as Indigenous Peoples' Day, 2) affirming the City's willingness to participate in annual Indigenous Peoples' Day celebrations and activities and promote the wellbeing and growth of the City's American Indian and Indigenous Community, and 3) encouraging other businesses, organizations, and public institutions to recognize Indigenous Peoples' Day.

When the Houston Bike Plan was adopted in 2017, the City committed to making Houston a safer, more accessible, bike-friendly city by 2027. Approval of the ordinance will authorize ARA's ParkHouston division to issue citations to vehicles parked in and blocking a dedicated bicycle lane, defined as "a dedicated portion of the roadway separated from motor vehicle traffic with striping and/or physical delineation intended for the exclusive use of bicyclists." The prohibition will not apply to on-street bikeways where travel lanes are shared by vehicles and bicyclists and where the City permits on-street parking (e.g., Washington Avenue). Currently, ParkHouston officers can only issue citations to vehicles parked in bicycle lanes where signage such as "no parking" and "tow-away zone" is posted. The new violation code will not require signage for citation issuance when a vehicle is illegally parked in the dedicated bicycle lane. Vehicles parked illegally in a dedicated bicycle lane can only be towed if in conformity with section 2308.353 of the Texas Occupations Code, which requires signage stating the parking is prohibited in the right-of-way.

A specific bicycle lane parking violation is necessary to:

- 1. Protect the investment the City is making in the build-out of the bikeway network;
- 2. Provide safe travel lanes for bicyclists and the vehicles in adjacent traffic lanes;
- 3. Clarify the data and allow the City to accurately track enforcement of this violation;
- 4. Demonstrate to the public that parking in a protected bicycle lane is a serious infraction; and
- 5. Demonstrate the City's commitment to its Vision Zero goal to eliminate traffic deaths and serious injuries by 2030.

For mid to large cities, the average fine for parking in a bicycle lane is around \$100. Pursuant to section 26-10 of the City's Code of Ordinances, the proposed section 26-100 will be a civil offense within the

fine range of \$1.00 - \$200.00. While the authority to set the parking violation fine lies with the Presiding Judge of Municipal Courts, ARA is suggesting a fine of \$100 with a delinquent fine of \$50.

The proposed ordinance was posted online for a public comment period from July 17 to August 17. During this time, 341 public comments were received, 94% of which were in support of the ordinance.

The City's Bicycle Advisory Committee, Planning & Development Department (PD), and the Municipal Courts Department have all reviewed and provided feedback for the ordinance. The ordinance will go into effect immediately. ARA and PD are collaborating on a campaign to educate the general public about parking in bicycle lanes. Vehicles that park in a dedicated bicycle lane in violation of new section 26-100 will receive a warning and a flyer on the first instance. Subsequent violations will be subject to citation.

Specific Explanation:

The Director of Houston Public Works and the Chief Procurement Officer recommend that City Council approve an ordinance awarding a **three-year contract**, **with two -one-year options** to Angel Brothers Enterprises, Ltd. on its sole bid meeting specifications for asphaltic pavement overlay services in the amount not to exceed **\$2,974,055.00** for Houston Public Works.

The scope of work requires the contractor to furnish all labor, materials, equipment and supplies, and shall perform all work necessary for asphaltic pavement overlay services citywide. The work will consist of using asphaltic material for repairing pavement failures, filling excavated and/or damaged areas of roadways, for the mitigation of pavement hazards, and/or improvement of existing pavement.

This Invitation to Bid (ITB) was advertised in accordance with the requirements of the State of Texas bid laws. Three prospective bidders downloaded the solicitation document from SPD's e-bidding website, and one bid was received. Prior to issuing the solicitation, the Strategic Procurement Division canvassed the City's registered vendor database, as well as the market, to identify potential bidders who could possibly provide the type of services needed. Subsequent to the receipt of the bids, prospective bidders were contacted to determine the reason for the limited response to the ITB. Some potential respondents advised that they did not have the staff nor expertise to provide asphaltic pavement overlay services.

M/WBE Subcontracting:

This Invitation to Bid was issued as a goal-oriented contract with an 19% MWBE participation level. **Angel Brothers Enterprises**, **Ltd.** has designated the below-named companies as its certified MWBE subcontractors.

The U.S. Department of Homeland Security provides grants to enhance the capacity of state and local governments to respond to incidents of terrorism and natural disasters. The Homeland Security Grant Program includes both the Urban Area Security Initiative (UASI) and State Homeland Security Grant Program (SHSP) The UASI program specifically addresses the unique needs of high risk urban areas with funding to develop an enhanced and sustainable capacity to prevent, protect against, respond to and recover from threats or acts of terrorism. TIRZ budgets to be presented to City Council on September 30, 2020 for consideration and approval on are listed below:

TIRZ #11 – GREENSPOINT (DISTRICT B) was created to facilitate the revitalization of Greenspoint from a blighted area suffering from significant social and economic stress to a viable mixed-use community through the financing of public infrastructure, parks and recreational projects, public parking, flood control, workforce housing and environmental/remediation mitigation projects.

The projected incremental property tax revenue is \$13.3M, which comprises \$5.8M from Aldine ISD, \$5.8M from City increment, \$873K from Lone Star Community College and \$737K from Spring ISD. The FY21 budget is \$12.1M and allocates \$9.2M for project costs including Greens road street and drainage improvements (\$1.9M), N. Houston Skate and Bike Park Maintenance (\$1.2M), landscaping of Kuydendahl road (\$740K) and North Division Police Station at Greenspoint Public Safety Campus (\$1.3M). The budget also includes \$2.9M in transfers, which is primarily allocated to municipal services (\$2.6M).

FY20 – FY24 CIP: \$40.2M **FY21 – FY25 CIP:** \$33.5M

Projects ADDED for FY21 – FY25:

• Landscaping on Kuykendahl Road between Rankin and Entrance to Bike Park

TIRZ #27 – MONTROSE (DISTRICT C) was created for the purpose of leveraging the expenditure of public funds for eligible project costs including the planning, engineering and construction of new streets, water distribution facilities, wastewater collection facilities, storm drainage improvements, roadway and street reconstruction projects, cultural and public facility improvements, parks and other related improvements. The FY21 budget is \$5.5M and allocates \$5.1M for project costs. Projects include Waugh/Commonwealth/Yaokum street improvements (\$2.6M), Woodhead neighborhood safety improvements (\$495K), Hawthorne neighborhood safety improvements (\$335K), and Montrose drainage improvements (\$314K). The budget also includes \$381K in transfers, which comprises \$184K for administration fees and \$196K municipal services.

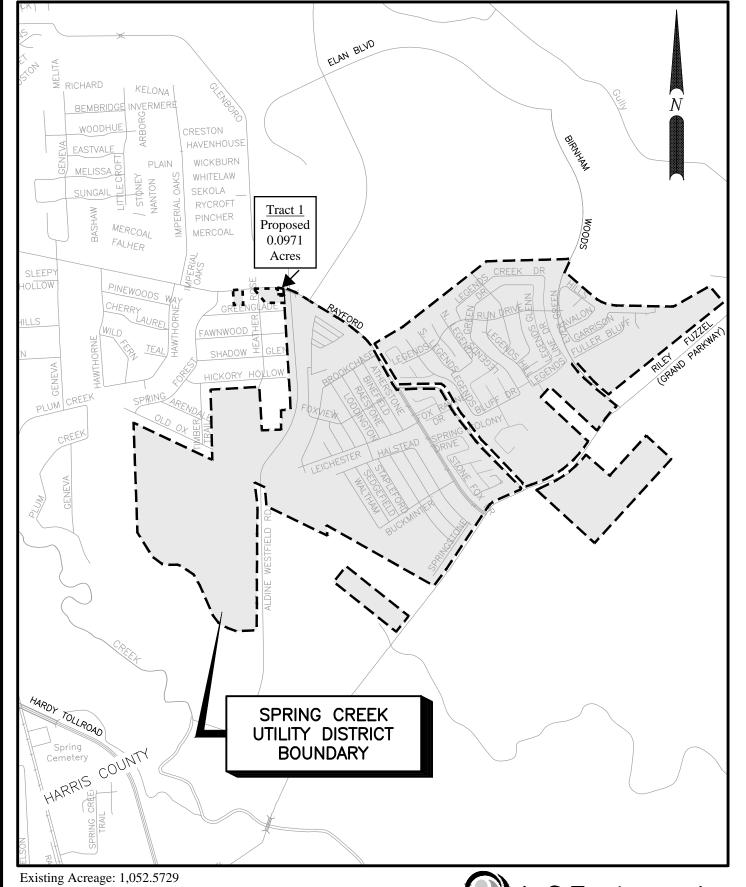

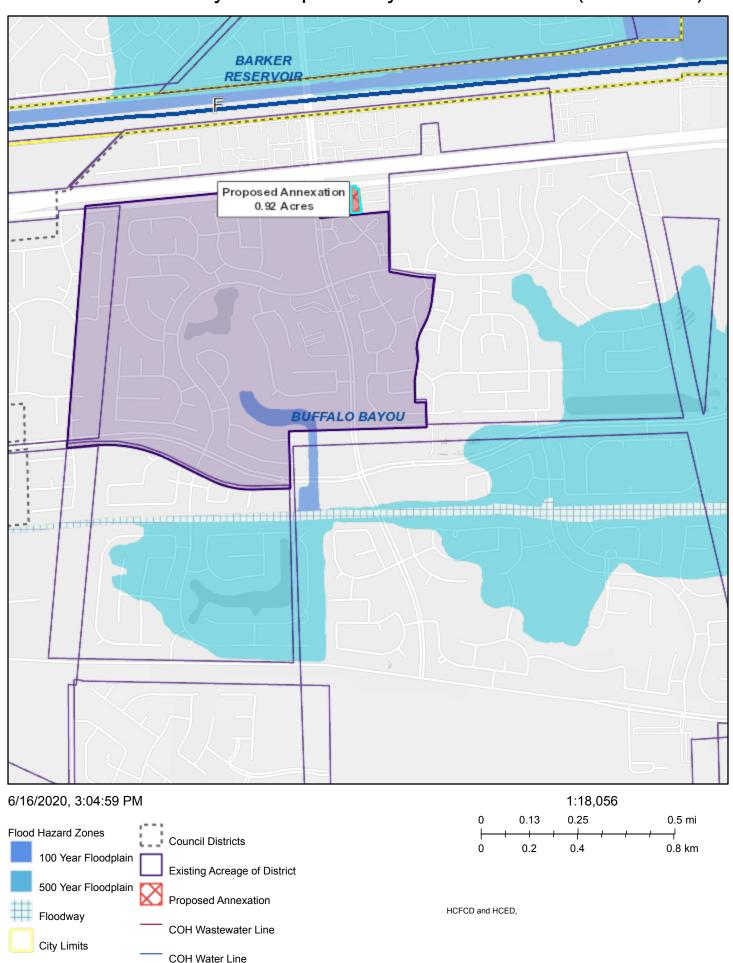

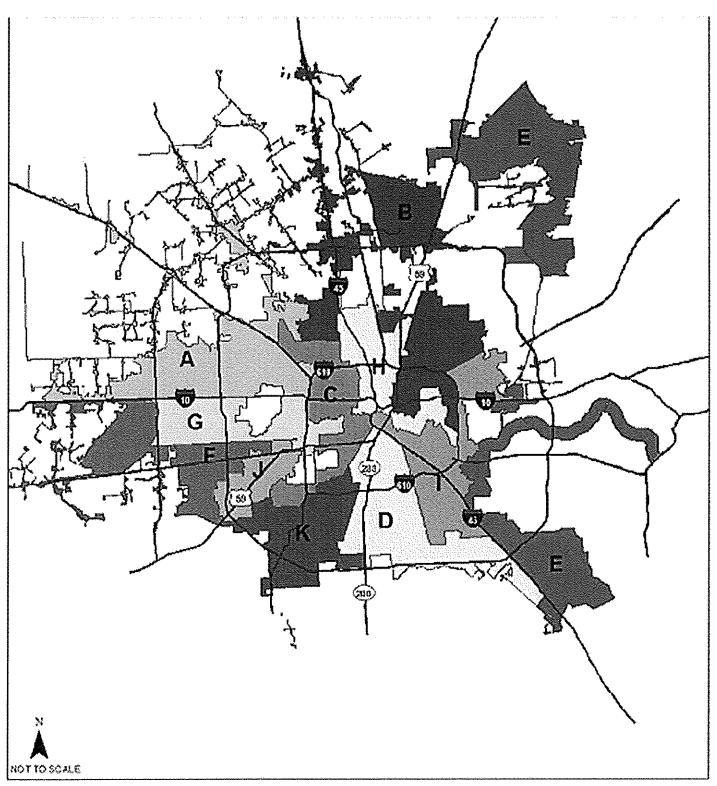
