Background:

RECOMMENDATION: Award construction contract and appropriate funds for the project.

SPECIFIC EXPLANATION: The General Services Department (GSD) recommends that City Council award a construction contract to Jerdon Enterprise, L.P. on the proposal amount of \$1,484,908.24 to provide construction services for Edgewood Park for the Houston Parks and Recreation Department.

PROJECT LOCATION: 5803 Bellfort Street

PROJECT DESCRIPTION: The scope of work consists of new playground units and swings, exercise stations with shade cover, picnic areas, pavilion, sprayground, lighting, concrete walking trail and sidewalks, seat walls, ornamental fencing, native trees with irrigation, drinking fountain, bike racks and benches, refurbishment for the existing basketball court, ADA parking and driveway entry. This project is funded in part by a Texas Parks and Wildlife Department Grant.

The contract duration for this project is 270 calendar days from the date of the Notice to Proceed.

M2L Associates, Inc. is the design consultant for this project.

PROPOSALS: On February 19 and February 26, 2021, GSD advertised a Request for Competitive Sealed Proposals (CSP) for construction services for Edgewood Park. The CSP contained selection criteria that ranked respondents on experience, key personnel, safety and Hire Houston First. The Statements of Qualifications were due on March 11, 2021, and four firms responded. GSD evaluated the respondents and all four firms received sufficient points and were requested to submit proposals. Four firms submitted proposals. Jerdon Enterprise, L.P. submitted the lowest responsive proposal and offers the best value for the City based on the advertised criteria.

The appropriation of \$63,739,154.96 results from tax increment payments received in tax year 2020 from HISD, Spring ISD, Humble ISD and Lone Star College for transfer to the various TIRZs that the ISDs and Lone Star College participate.

As shown in the attached spreadsheet, \$1,144,049.38 will be transferred to the City's Affordable Housing Fund; \$375,000 will be transferred to the General Fund; \$18,788,855.67 will be paid to HISD for Educational Facilities Project Costs and \$12,622,147.65 will be paid to Humble ISD for Educational Facilities Project Costs for a total of \$31,411,003.32 for Educational Facilities Project Costs. The various redevelopment authorities will be paid \$30,809,102.26 on behalf of the TIRZs.
