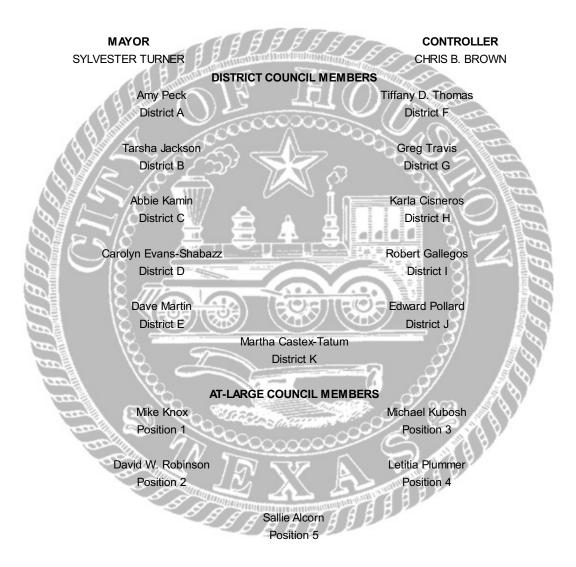

Background:

SUBJECT: Accept work for FY2019 Drainage Rehab Work Orders #4.

RECOMMENDATION: (SUMMARY) Pass a motion to approve the Final Contract Amount of \$5,982,088.89 or 0.30% under the revised Contract Amount, accept the Work and authorize final payment.

<u>PROJECT NOTICE/JUSTIFICATION:</u> This project was part of the City of Houston (City) Local Drainage Project and was required to meet local storm water drainage system improvements and repairs citywide.

PREVIOUS HISTORY: The original contract was approved on December 5, 2018 by Ordinance 2018-0978. This project consisted of local storm water drainage system improvements citywide. It also addressed certain large—scale storm water drainage system repairs. The project was awarded to PM Construction & Rehab, LLC, with an Original Contract Amount of \$3,000,000.00 and an additional appropriation of \$3,000,000.00, for a revised total contract amount of \$6,000,000.00. The contract duration for this project was 730 calendar days.

LOCATION: The projects were at 22 various locations in Council Districts A, B, C, D, G, H, J and K.

CONTRACT COMPLETION AND COST: The Contractor, PM Construction & Rehab, LLC, has completed the work under the subject Contract. The project was completed on time. The final cost of the project, including overrun and underrun of estimated unit price quantities is \$5,982,088.89 a decrease of \$17,911.11 or 0.30% under the total contract amount.

The increased cost is a result of the difference between planned and measured quantities.

M/WSBE PARTICIPATION: The advertised M/WBE contract goals for this project were 11% MBE and 7% WBE (18% total). The M/WBE goals approved for this project were 7% MBE, 7% WBE and 4% SBE (18% total). 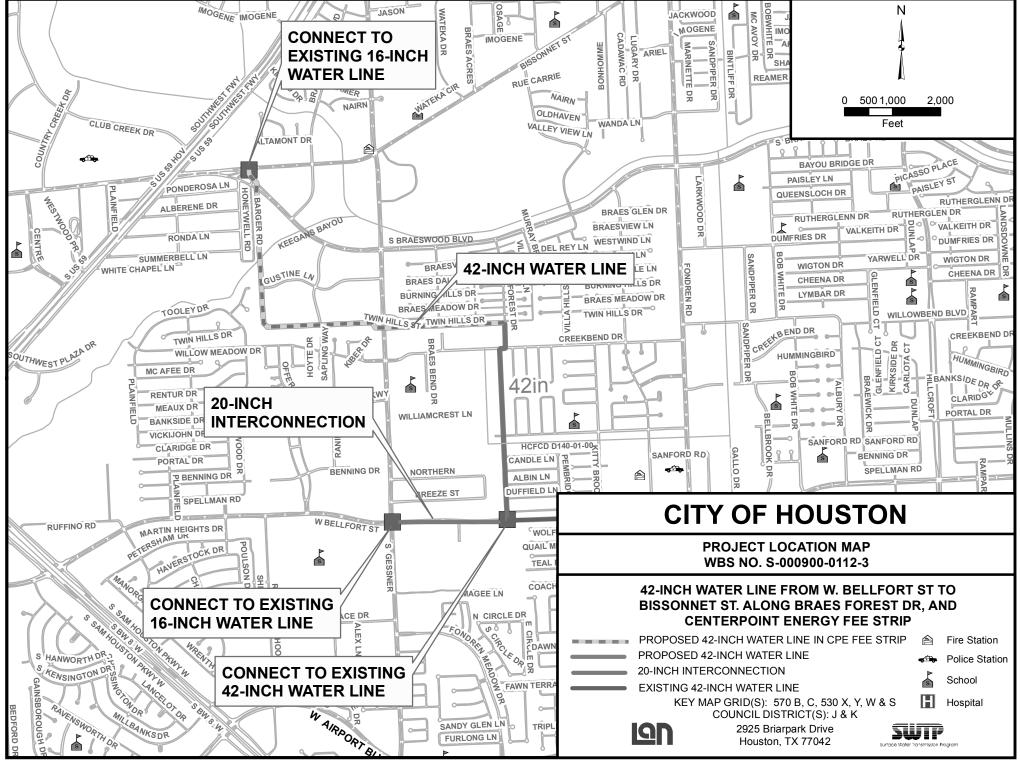

Background:

The Administration & Regulatory Affairs Department (ARA) recommends that City Council adopt an ordinance approving the CenterPoint Energy Resources Corp., d/b/a CenterPoint Energy Entex and CenterPoint Energy Texas Gas (CenterPoint or Company) Tax Cut and Jobs Act (TCJA) Refund and compliance filing. CenterPoint provides natural gas distribution services in the Houston metropolitan area, serving approximately 430,000 residential, 26,000 small general service and 1,000 large volume general service customers in Houston. The City of Houston (City or Houston) exercises original jurisdiction over the rates, operations, and services of CenterPoint under the provisions of the Texas Utilities Code for customers inside city limits.

On July 27, 2021, CenterPoint filed with the City a compliance filing and notice of intent to reflect a net refund for the Houston Division pursuant to Section 104.111 of the Gas Utility Regulatory Act. In 2019, City Council approved CenterPoint's TCJA Rider which returns to customers the UEDIT (unprotected excess deferred income taxes) resulting from the TCJA — \$17.8 million over a three-year period. The TCJA reduced the federal corporate income tax from 35% to 21% effective January 1, 2018. In accordance with its TCJA Rider, CenterPoint is to file with the City a compliance filing, on or before August 1 each year during the term of the rider, to include a true-up of the TCJA refund amounts.

CenterPoint is proposing to refund approximately \$4.1 million to customers during year three (2022) of the three-year TCJA Rider. This includes an approximate \$196,000 true-up adjustment to account for an overage in the amount refunded to customers in year two. If adopted, residential customers would experience a \$0.22 monthly refund to their bills effective on or after January 1, 2022:

The City's rate expert reviewed CenterPoint's filing. The rate expert determined that the Company's proposed TCJA refund, and compliance filing, are reasonable and recommends that the City approve the refund proposed by CenterPoint.

ORDINANCE approving and authorizing Amendment No. 3 to Grant Contract for Sexual Risk Avoidance Education Program between City and **TEXAS HEALTH AND HUMAN SERVICES COMMISSION**; approving the acceptance and disbursement of Grant Funds thereunder

Background:

The Houston Health Department (HHD) requests City Council approval of a grant contract amendment number three between the City and the Texas Department of State Health Services (DSHS) for the City's Sexual Risk Avoidance Education Program services. The contract term continues through September 30, 2023. Funding for the contract under Amendment Number three will be increased by \$150,000 for Fiscal Year 2022 (10/1/2021 – 9/30/2022) and \$150,000 for Fiscal Year 2023 (10/1/2022 – 9/30/2023). The total not-to-exceed amount for the contract is \$750,000. City matching funds are not required.

The original grant contract was processed and fully executed under **Contract No. C78172 NCA (No Council Action)** on October 4, 2019 because the amount of the Fiscal Year 2019 award was \$150,000 and therefore did not require council approval. On 9/28/2020, Amendment Number one was processed with no additional funding. On 11/2/2020, Amendment Number two to the Contract was fully executed with the award amount of \$150,000 for Fiscal Year 2021. Funding for the contract under Amendment Number three will be increased by \$150,000 for Fiscal Year 2022 and \$150,000 for Fiscal Year 2023, which put the total grant award through 9/30/2023 at \$600,000. Pursuant to the updated AP 4-1 (updated on August 17, 2020) city council approval is now required for grants over \$400,000.00 for the entire grant contract period.

HHD also requests City Council to authorize the Mayor to execute all related contracts, agreements, amendments and documents with the approval as to form of the City Attorney in connection with the grant assistance program and to authorize the Director or his designee to act as the City's representative with the authority to apply for, to accept and expend subsequent supplemental awards, if any, and to extend the term and/or budget and project period not to exceed five years, if extended by DSHS during the project period and if it does not require cash matching funds.

The main objective under this contract grant agreement is to educate youth between the ages of 10 to 19 on how to refrain from related risky sexual behaviors. The program is designed to teach youth the benefits associated with personal responsibility, goal setting, healthy decision-making,

focusing on the future and preventing youth risk behaviors such as underage drinking and illicit drug use.

Funding for the contract under Amendment Number three will be increased by \$150,000 for Fiscal Year 2022 (10/1/2021 – 9/30/2022) and \$150,000 for Fiscal Year 2023 (10/1/2022 – 9/30/2023). The main objective under this contract grant agreement is to educate youth between the ages of 10 to 19 on how to refrain from related risky sexual behaviors. The program is designed to teach youth the benefits associated with personal responsibility, goal setting, healthy decision-making, focusing on the future and preventing youth risk behaviors such as underage drinking and illicit drug use.

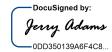

Specific Explanation:

Summary:

ORDINANCE approving and authorizing Professional Services Agreement between **BEVERIDGE & DIAMOND PC** and City of Houston relating to contamination of property and groundwater in the vicinity of Kashmere Gardens, The Fifth Ward, Denver Harbor and Trinity Gardens; establishing a maximum contract amount - \$900,000.00 - Property and Casualty Fund

Background:

The City Attorney recommends City Council approve an Ordinance authorizing an agreement between the City of Houston ("City") and Beveridge & Diamond PC ("Firm") for professional legal services with a maximum contract amount of \$900,000.00.

This request relates to the contamination of property and groundwater in the vicinity of Kashmere Gardens, the Fifth Ward, Denver Harbor and Trinity Gardens, arising from a former creosote operation located on property owned by Union Pacific Railroad ("UPRR"). The site is in a Voluntary Cleanup Program administered by the Texas Commission on Environmental Quality ("TCEQ"), who issued a Hazardous Waste Permit to UPRR. The City of Houston anticipates that it will seek a Contested Case Hearing before the TCEQ regarding the current draft permit in order to effectively protect the health, safety, and environment of Houston residents. The City believes that TCEQ should require UPRR to more fully address the soil and groundwater for the benefit and well-being of Houston residents in the vicinity and for the protection of the City's property and infrastructure, including underground storm sewer pipes. The Texas Department of State Health Services has also identified elevated cancer rates in the vicinity of the UPRR property.

The City is concerned for the health, safety, environmental protection, and well-being of Houston residents and is committed to advancing environmental justice for the community.

The City would benefit from the expertise of lawyers who routinely handle matters before the TCEQ and have experience in federal environmental laws, including the Resource Conservation and Recovery Act ("RCRA") and the Comprehensive Environmental Response Compensation, and Liability Act ("CERCLA").

The Firm's attorneys are environmental law specialists who provide comprehensive environmental regulatory support. Their attorneys have expertise in representing municipal government entities and private corporations in environmental enforcement, including TCEQ proceedings and RCRA and CERCLA matters

The City Attorney recommends engaging the Firm to represent the City because the Firm and its attorneys are pre-eminent in their representation of governmental and corporate entities in environmental law matters.

Hire Houston First: This procurement is exempt from the Citv's Hire Houston First Ordinance based on the department's determination that compliance with the ordinance would unduly interfere with contract needs.

Pay or Play: The Agreement requires compliance with the City's Pay or Play ordinance regarding health benefits for employees of City contractors. The Firm provides health benefits to eligible employees in compliance with City policy.

Background:

Request for Proposals (RFP) received July 15, 2021 for S94-T29922- Approve an ordinance awarding a contract to Alere Toxicology Services, Inc. in the maximum contract amount of \$2,602,722.00 for alcohol and controlled substance testing services for the Human Resources Department.

SPECIFIC EXPLANATION:

The Director of the Human Resources Department and the Chief Procurement Officer recommend that City Council approve an ordinance awarding a **three (3) year contract, with two (2) one-year options** to renew to **Alere Toxicology Services, Inc.** in the maximum contract amount of \$2,602,722.00 for alcohol and controlled substance testing services for the Human Resources Department. The Director of the Human Resources Department may terminate this contract at any time by giving thirty (30) days written notice to the contractor, with a copy of the notice to the CPO.

The scope of work requires the procurement of a laboratory certified by the Substance Abuse and Mental Health Services Administration (SAMHSA) as part of the U.S. Department of Health and Human Services(DHHS) to perform alcohol and controlled substance testing services to detect the presence of drugs, including but not limited to, the following groups: amphetamines, cocaine, opiates, phencyclidine, and marijuana. It is the policy of the City of Houston ("City") to achieve a drug-free workforce and to provide a workplace that is free from the use of illegal drugs, substance abuse, and alcohol abuse.

The Request for Proposals (RFP) was advertised in accordance with the requirements of the State bid laws and as a result, proposals were received from Alere Toxicology Services, Inc., DISA, Fastest Labs of Central Houston, Pre-Employ, and RN Expertise, Inc. The Evaluation Committee consisted of members from the Human Resources Department, and the Housing and Community Development Department. The Proposals were evaluated based on the following Criteria:

- · Responsiveness of Proposal
- · Technical Competence/Requirements
- · Price Proposal

Alere Toxicology Services, Inc. received the highest overall score and was deemed to be the best qualified supplier to meet the requirements as outlined in the RFP.

MWBE Subcontracting:

The Request for Proposal was advertised with a 11% goal for MWBE participation. Alere Toxicology Services, Inc. has designated the below-name company as its certified M/WBE subcontractor.

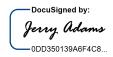

The Legal Department has issued a \$50,000.00 purchase order to enable the Firm to begin work immediately. City Council is being asked to approve an additional \$275,000.00 in the contract before City Council.

The former HCDD Director has made allegations relating to affordable housing matters, and one particular project, resulting in potential loss of confidence in City processes for supporting affordable housing projects. The City Attorney recommends engaging the Firm to conduct a thorough internal investigation because the Firm has the necessary experience and ability to conduct such an investigation and to report on any potential illegality, fraud, conflicts of interest, and/or violations of procedures, practices, or policies.

The Firm's attorneys are experienced and highly capable of analyzing the documents and policies involved, conducting thorough witness interviews, and they have successfully handled similar complex internal investigations. The lead attorney is a former federal and state prosecutor as well as a civil litigator, and is highly qualified and experienced in the area of complex internal investigations. He will be supported by other highly experienced former prosecutors and civil litigators who have expertise in conducting internal investigations. The Firm has sufficient experienced lawyers and support staff to handle this investigation.
