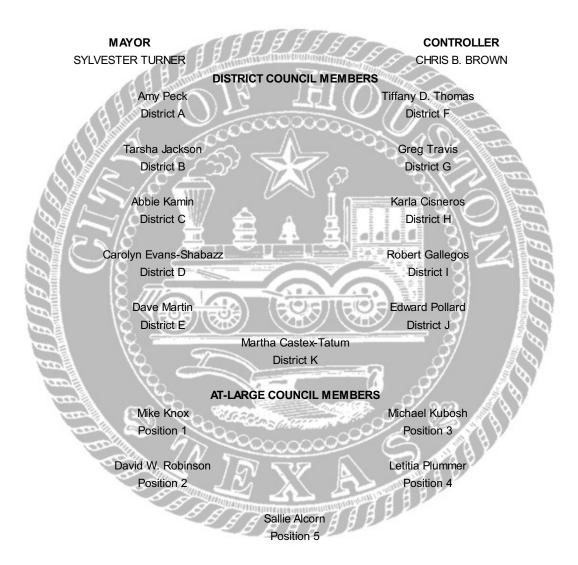

Background:

In 2017, the State Legislature changed the annexation laws in Texas. The changes significantly limited a municipality's options for conducting full purpose (also called general purpose) annexations, however, have had no effect on a municipality's ability to annex for limited purposes through a Strategic Partnership Agreement (SPA) with utility districts. Such agreements allow the City of Houston to annex all or part of a district for limited purposes. The City is then able to charge a sales tax and provide specific, limited services to the area. The City cannot levy a property tax in areas annexed for limited purposes.

Since the inception of the Strategic Partnership Agreements in 2000, the City of Houston has executed such agreements with 242 utility districts. Without exception, these agreements have been the result of a request by the district itself, and state law requires that the district approve the agreement prior to City Council's consideration of it. At the beginning of a new "round" of annexations, the City will send a general announcement to area districts, and those that are interested respond. When a district enters into an agreement with the City for the first time, a new Strategic Partnership Ordinance is created. Subsequent ordinances between the same district and the City to add territory or to change boundaries are approved as amendments to existing agreements.

These agreements have created net revenue of approximately \$35.9 million to the City in FY 2021, and because the split is usually 50/50, these agreements have led to around \$35.9 million being redistributed back into the community through the utility districts. While the City does not monitor the expenditures of each district, we are aware that most districts use their funds to supplement existing district services, which effectively lowers utility and tax rates. In some instances, districts have used the proceeds to fund regional parks and other public amenities. Through these agreements, the City has maintained a good working relationship with the utility districts in the Houston area.

The City is required to hold two public hearings in accordance with Section 43.0751(d) of the Texas Local Government Code, which states in pertinent part:

Before the governing body of a municipality or a district adopts a strategic partnership agreement, it shall conduct two public hearings at which members of the public who wish to present testimony or evidence regarding the proposed agreement shall be given the opportunity to do so.

The hearings called by this ordinance are for amendments to existing agreements, with the following utility districts:

- Harris County MUD No. 55
- Kingsbridge MUD
- Spring Creek Utility District
- Willow Point MUD

The Planning and Development Department recommends holding the public hearings on November 10, 2021 and November 17, 2021 in the City Hall Council Chambers. The recommended date for passing the SPA and the limited purpose annexation ordinances is December 8, 2021.

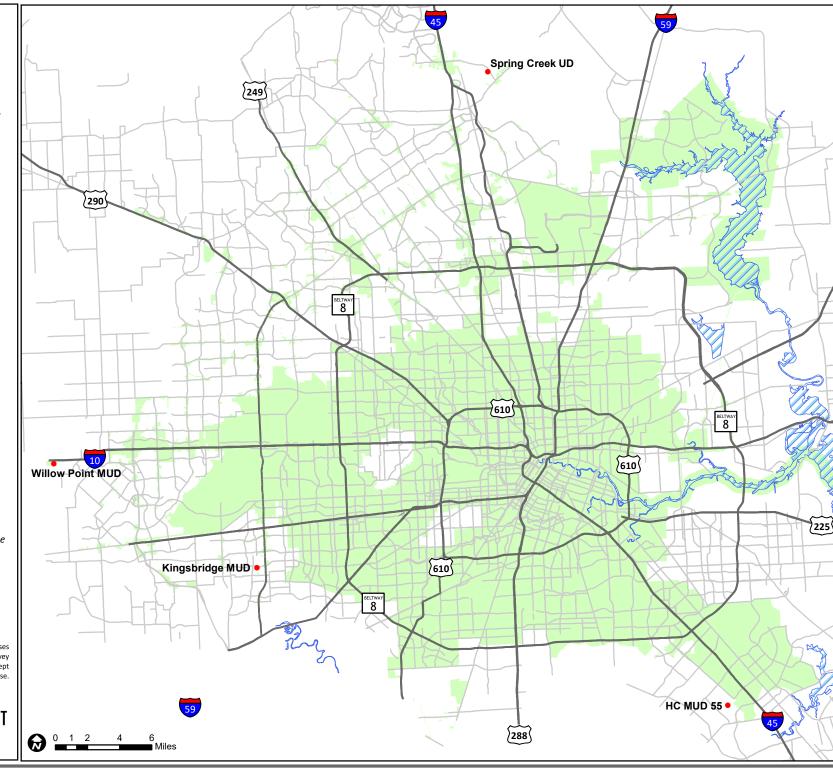

Background:

In 2017, the State Legislature changed the annexation laws in Texas. The changes significantly limited a municipality's options for conducting full purpose (also called general purpose) annexations, however, have had no effect on a municipality's ability to annex for limited purposes through a Strategic Partnership Agreement (SPA) with utility districts. Such agreements allow the City of Houston to annex all or part of a district for limited purposes. The City is then able to charge a sales tax and provide specific, limited services to the area. The City cannot levy a property tax in areas annexed for limited purposes.

Since the inception of the Strategic Partnership Agreements in 2000, the City of Houston has executed such agreements with 242 utility districts. Without exception, these agreements have been the result of a request by the district itself, and state law requires that the district approve the agreement prior to City Council's consideration of it. At the beginning of a new "round" of annexations, the City will send a general announcement to area districts, and those that are interested respond. When a district enters into an agreement with the City for the first time, a new Strategic Partnership Ordinance is created. Subsequent ordinances between the same district and the City to add territory or to change boundaries are approved as amendments to existing agreements.

These agreements have created net revenue of approximately \$35.9 million to the City in FY 2021, and because the split is usually 50/50, these agreements have led to around \$35.9 million being redistributed back into the community through the utility districts. While the City does not monitor the expenditures of each district, we are aware that most districts use their funds to supplement existing district services, which effectively lowers utility and tax rates. In some instances, districts have used the proceeds to fund regional parks and other public amenities. Through these agreements, the City has maintained a good working relationship with the utility districts in the Houston area.

The City is required to hold two public hearings in accordance with Section 43.0751(d) of the Texas Local Government Code, which states in pertinent part:

Before the governing body of a municipality or a district adopts a strategic partnership agreement, it shall conduct two public hearings at which members of the public who wish to present testimony or evidence regarding the proposed agreement shall be given the opportunity to do so.

The hearings called by this ordinance are for amendments to existing agreements, with the following utility districts:

- Harris County MUD No. 55
- Kingsbridge MUD
- · Spring Creek Utility District
- Willow Point MUD

The Planning and Development Department recommends holding the public hearings on November 10, 2021 and November 17, 2021 in the City Hall Council Chambers. The recommended date for passing the SPA and the limited purpose annexation ordinances is December 8, 2021.

Background:

The Housing and Community Development Department (HCDD) recommends Council approval of an Ordinance authorizing an Agreement between the City of Houston (City) and NHPF Caroline Conduit, LLC (Borrower), a nonprofit partner of Magnificat House Inc. (MHI) joined by The NHP Foundation (Owner), for a \$15,000,000.00 Community Development Block Grant - Disaster Recovery 2017 (CDBG-DR17) grant, for the new construction of a permanent supportive housing community for the homeless located at 3300 Caroline Street, Houston, TX 77004.

Since 1968, MHI has offered an alternative to the streets by providing shelter, meals, a sense of community and guidance for unsheltered Houstonians. The new construction at 3300 Caroline Street will be a four-story elevator-served building consisting of 149 efficiency apartments, shared space for supportive programs and office space for MHI staff. With an anticipated Housing Assistance Payment (HAP) subsidy contract from the Houston Housing Authority, all residents will pay no more than 30% of their monthly adjusted income in rent.

Conveniently located in Midtown, 3300 Caroline Street is a transit-oriented development within walking distance to light rail and several major bus lines, thus enabling access to key neighborhood services and employment opportunities. The development will provide residents with a safe, quality, supportive place to call home in their neighborhood.

3300 Caroline Street is funded through CDBG-DR17 program funds awarded by the United States Department of Housing and Urban Development, through the Texas General Land Office to provide affordable rental units for low-to moderate-income households in accordance with the City's Harvey Multifamily Program Guidelines.

The City of Houston loan term and affordability period will be 40 years and will commence when the construction period is completed. Funding for 3300 Caroline Street will be as follows:

With an anticipated Housing Assistance Payment (HAP) subsidy contract from the Houston Housing Authority, all residents will pay no more than 30% of their monthly adjusted income in rent.

Conveniently located in Midtown, 3300 Caroline Street is a transit-oriented development within walking distance to light rail and several major bus lines, thus enabling access to key neighborhood services and employment opportunities. The development will provide residents with a safe, quality, supportive place to call home in their neighborhood.

3300 Caroline Street is funded through CDBG-DR17 program funds awarded by the United States Department of Housing and Urban Development, through the Texas General Land Office to provide affordable rental units for low-to moderate-income households in accordance with the City's Harvey Multifamily Program Guidelines.

In consideration of this contract term, The Alliance will continue to perform the financial counseling services under the terms and conditions of the original agreement for payment by GHCF. 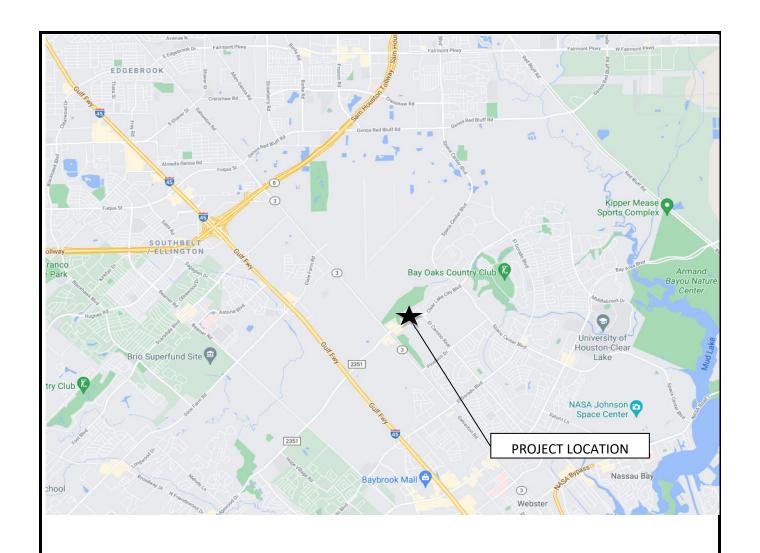

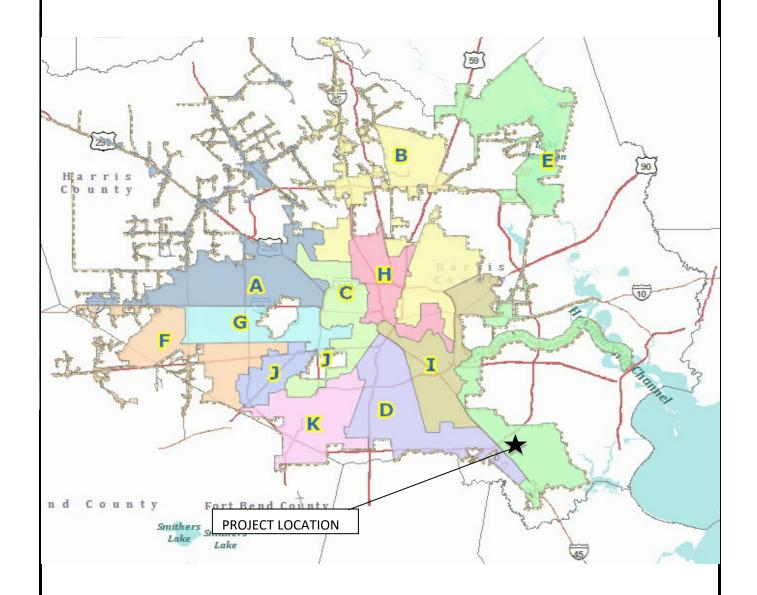

The City was authorized to participate in MUAs with TXDOT between 1974 and 2020 using Ord. No. 73-2145, the "Master Agreement" ordinance. A few examples of the Master Agreement use include parking lots under the elevated highways downtown and recreational trails along the bayous that pass under TXDOT rights-of-way. In 2021, TXDOT notified the City that it would no longer accept the Master Agreement as a valid authorization for a new MUA. As a result, the City must approve a new ordinance to align the authorization with the current MUA process, forms, and agreement conditions that TXDOT has revised over the decades since the Master Agreement was first approved.

Existing agreements executed using the Master Agreement will remain valid and unchanged by this new ordinance. Going forward, any new MUA or amendment to a MUA will rely on the authorization granted by this new ordinance.

This ordinance does not include any funding obligations on the part of the City. Any funding from the City related to a MUA must be considered through the applicable allocation or approval processes in accordance with the City Charter.

In 2021, TXDOT notified the City that it would no longer accept the Master Agreement as a valid authorization for a new MUA. As a result, the City must approve a new ordinance to align the authorization with the current MUA process, forms, and agreement conditions that TXDOT has revised over the decades since the Master Agreement was first approved.

Existing agreements executed using the Master Agreement will remain valid and unchanged by this new ordinance. Going forward, any new MUA or amendment to a MUA will rely on the authorization granted by this new ordinance.

This ordinance does not include any funding obligations on the part of the City. Any funding from the City related to a MUA must be considered through the applicable allocation or approval processes in accordance with the City Charter.

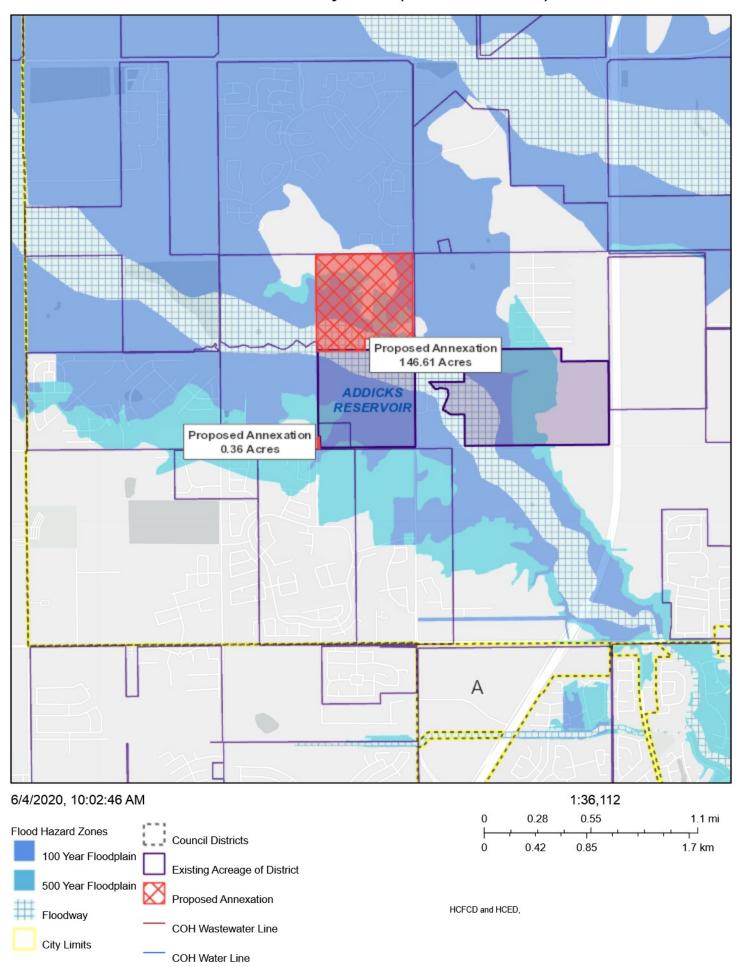

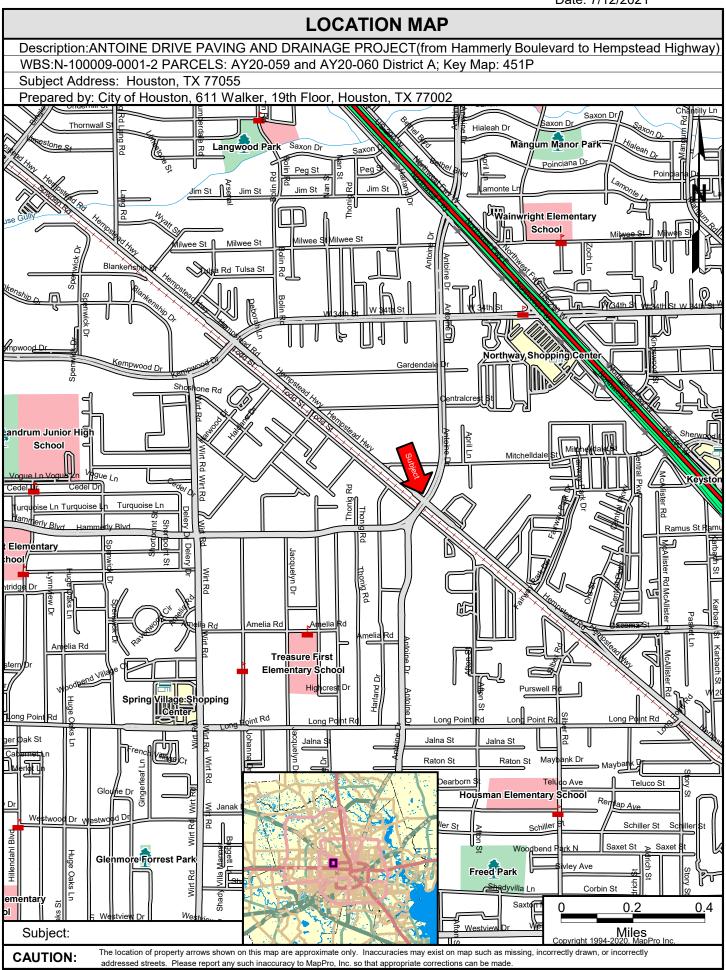

SPECIFIC EXPLANATION:

The City and Harris County Flood Control District (the "Parties") entered into an Interlocal Agreement, Ordinance 2020-0286, passed and adopted on April 1, 2020 (the "Agreement"), whereby the Parties have agreed to exchange certain drainage facilities and real property interests within their respective inventories as part of an Asset Exchange Program (the "Program"). Pursuant the Program, the City, from time to time, will transfer selected open channels to the District for future ownership and maintenance. In exchange, the City, from time to time, will accept selected enclosed storm sewer systems for future ownership and maintenance.

The Program recognizes the Parties share overlapping jurisdiction for planning, implementing, and maintaining flood damage reduction and drainage infrastructure. The District's expertise lies in design, construction, and maintenance of primary drainage systems such as open channels and detention basins, while the City has expertise in design, construction and maintenance of enclosed storm sewer systems. The City has determined that the exchange of drainage facilities and real property interests with the District will benefit the public interest of the City and help with effectively maintaining its public purpose.

All initial costs to make any repairs necessary to bring an accepted drainage facility and property into compliance with the accepting Party's standard criteria, and all costs to maintain the facility and property shall be borne by the accepting Party. Under no circumstances will the City or the District be obligated to appropriate or expend any funds for, or in the performance of the Agreement.

The Agreement establishes the processes and procedures necessary to facilitate an exchange, which include, but are not limited to i) identification, ii) inspection, iii) survey of encroachments (if any), iv) encroachment removal, and v.) final inspection (the "pre-exchange activities"). The pre-exchange activities for the subject parcels have been completed, and the City now desires to assign, or convey the following interests and properties to the District:

Assignment to the District for Channel D126-00-00. In 1967, Johnnie E. Attaway and L.C. Owens, President and Secretary respectively of Kirkwood Development Co. Inc. dedicated a 20 foot-wide drainage easement adjacent to the lots thereon, in that certain instrument filed and recorded on July 19, 1967, under Clerk's File No. C519113 of the Harris County Real Property Records. The City of Houston assigns the portion of this easement beginning 235 feet west of Belle Park Dr continuing west to South Kirkwood Road to Harris County Flood Control District, and the City retains the portion of the same easement beginning 235 feet west of Belle Park Drive continuing east to Brays Bayou.

SPECIFIC EXPLANATION:

The City and Harris County Flood Control District (the "Parties") entered into an Interlocal Agreement, Ordinance 2020-0286, passed and adopted on April 1, 2020 (the "Agreement"), whereby the Parties have agreed to exchange certain drainage facilities and real property interests within their respective inventories as part of an Asset Exchange Program (the "Program"). Pursuant the Program, the City, from time to time, will transfer selected open channels to the District for future ownership and maintenance. In exchange, the City, from time to time, will accept selected enclosed storm sewer systems for future ownership and maintenance.

The Program recognizes the Parties share overlapping jurisdiction for planning, implementing, and maintaining flood damage reduction and drainage infrastructure. The District's expertise lies in design, construction, and maintenance of primary drainage systems such as open channels and detention basins, while the City has expertise in design, construction and maintenance of enclosed storm sewer systems. The City has determined that the exchange of drainage facilities and real property interests with the District will benefit the public interest of the City and help with effectively maintaining its public purpose.

All initial costs to make any repairs necessary to bring an accepted drainage facility and property into compliance with the accepting Party's standard criteria, and all costs to maintain the facility and property shall be borne by the accepting Party. Under no circumstances will the City or the District be obligated to appropriate or expend any funds for, or in the performance of the Agreement.

The Agreement establishes the processes and procedures necessary to facilitate an exchange, which include, but are not limited to i) identification, ii) inspection, iii) survey of encroachments (if any), iv) encroachment removal, and v.) final inspection (the "pre-exchange activities"). The pre-exchange activities for the subject parcels have been completed, and the City now desires to assign, or convey the following interests and properties to the District:

Assignment to the District for Channel D126-00-00. In 1967, Johnnie E. Attaway and L.C. Owens, President and Secretary respectively of Kirkwood Development Co. Inc. dedicated a 20 foot-wide drainage easement adjacent to the lots thereon, in that certain instrument filed and recorded on July 19, 1967, under Clerk's File No. C519113 of the Harris County Real Property Records. The City of Houston assigns the portion of this easement beginning 235 feet west of Belle Park Dr continuing west to South Kirkwood Road to Harris County Flood Control District, and the City retains the portion of the same easement beginning 235 feet west of Belle Park Drive

continuing east to Brays Bayou.

Therefore, it is recommended that an ordinance be passed approving the assignment and transfer of a 20 foot-wide drainage easement to Harris County Flood Control District as part of the Asset Exchange Program.

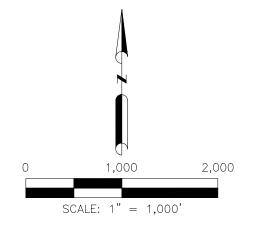

The purpose is to reduce sanitary sewer overflows, which is accomplished by renewal/rehabilitation of deteriorated collection systems.
