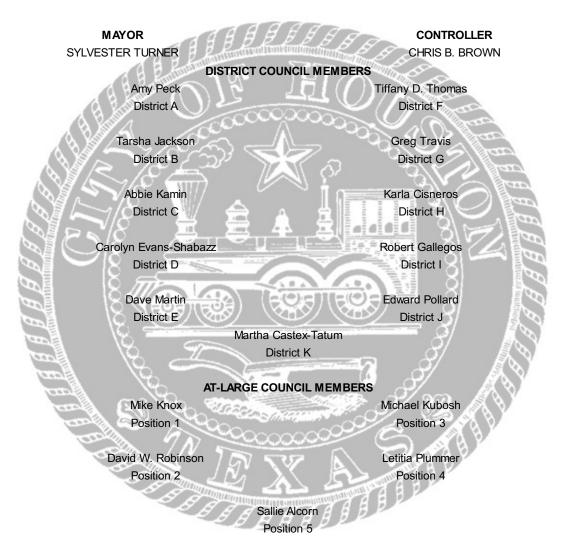

Background:

State law sets forth detailed requirements for the process of setting ad valorem tax rates, including public hearings, newspaper publications, and actions of the governing body. These requirements include minimum and maximum time periods for each step in the process.

Prior Council Action:

Motion 2021-0462 (8/4/2021)

Amount and Source of Funding:

No-New Revenue Tax Rate and Voter-Approval Tax Rate

Section 26.04 (e) of the Tax Code requires that the No-New Revenue Tax Rate and the Voter-Approval Tax Rate be reported to the governing body of each taxing unit. The No-New Revenue Tax Rate for Tax Year 2021 is \$\$0.535192 on each \$100 of taxable value and the Voter-Approval Tax Rate is \$0.566495 on each \$100 of taxable value. These numbers are based on Certified Initial Roll information from the Harris County Appraisal District, Fort Bend County Appraisal District, and the Montgomery County Appraisal District.

Public Hearing

Section 26.05(d) of the Tax Code provides that a taxing unit may not adopt a tax rate that exceeds the lower of the No-New-Revenue Tax Rate and the Voter-Approval Tax Rate until the governing body has held a public hearing. The proposed tax rate for Tax Year 2021 will exceed the lower of the No-New-Revenue Tax Rate and Voter-Approval Tax Rate. Background:

RECOMMENDATION:

Pass a resolution approving 1) the creation of the Houston Spaceport Development Corporation, 2) the Bylaws of the Corporation, 3) the confirmation of individuals nominated for appointment to the Corporation's Board of Directors.

SPECIFIC EXPLANATION:

During the last decade, Texas has emerged as a growing player in the aerospace industry, particularly with respect to development for commercial space activity. In recognition of this, the 80th Texas Legislature passed legislation creating Chapter 507 of the Texas Local Government Code (Spaceport Development Corporations), which allows political subdivisions to create spaceport development corporations (SDCs).

One of the primary benefits of SDCs is the ability for authorizing entities to apply for and accept space grant funds under the Texas Spaceport Trust Fund for eligible projects. During the 87th Texas Legislature, \$10 million was designated in Section XI of the Governor's adopted budget for the Spaceport Trust Fund.

An SDC may be developed by a county, a municipality with a population of two million or more, or a combination of one or more municipalities and one or more counties. Currently, three SDCs exist and compete for state funding--Cameron County Spaceport Development Corporation, McClennan County Spaceport Development Corporation, and Midland Spaceport Development Corporation.

Roads, utilities, and building structures are all eligible for reimbursement as needed based on the particulars of the grant agreement that is put into effect between the Office of the Governor and any potential grantee. In past project, funds have been used for items such as road, storage structures, launch pad-related costs, fencing, fuel storage, exhaust diverters, water lines, and other

needed utilities.

In accordance with Chapter 507, the Houston Airport System desires to form an SDC to maximize economic development opportunities at Houston Spaceport to benefit the city, the region, and the state of Texas. The SDC will engage experts from different disciplines, adding tremendous value to the development efforts.

The Houston Spaceport Development Corporation will be governed by a Board of seven Directors, appointed by the Mayor to serve two-year terms. The Board of Directors will elect a presiding officer from among its members.

Background:

The Housing and Community Development Department (HCDD) recommends Council approval of an Ordinance authorizing a Loan Agreement between the City of Houston (City) and Houston Area Community Development Corporation, joined by NHH Savoy, Ltd. (Borrower), providing \$13,200,000.00 of Community Development Block Grant - Disaster Recovery 2017 (CDBG-DR17) funds, for the land acquisition and new development of New Hope Housing Savoy, to be located at approximately 6301 Savoy Drive, Houston, TX 77036.

New Hope Housing Savoy will be a 120-unit four story elevator- accessible affordable rental development serving families. The property will provide a mix of one-, two-, and three-bedroom units serving low- to moderate- income households at 30%, 50%, 60%, and 80% of the Area Median Income. The development is designated as supportive housing to provide safe homes for individuals with disabilities and families at risk of homelessness. Building on a solid 26-year track record of creating quality affordable rental developments, New Hope Housing Savoy will be the eleventh property in the Borrower's portfolio and the third property serving families.

This project is funded by CDBG-DR17 program funds awarded by the United States Department of Housing and Urban Development, through the Texas General Land Office to provide affordable rental units for low to moderate income households, in accordance with the City's Harvey Multifamily Program Guidelines, implemented by HCDD.

The loan and affordability period will be 40 years and will commence when the construction period is completed. Loan will be non-amortizing throughout both the construction and affordability period. Following project completion, the outstanding principal balance of the note shall accrue at 1% interest. Borrower will pay an annual installment of interest from available cash flow.

Background:

The Houston Health Department (HHD) requests City Council approval of a grant contract amendment number four between the City and the Texas Commission on Environmental Quality (TCEQ) for the City's air monitoring stations. The contract term continues through August 31, 2022. Funding for the contract under Amendment Number 4 will be increased by \$118,403.15 for FY2022 for a maximum contract amount to be reimbursed by TCEQ of \$437,104.82. City matching funds are not required.

The original grant contract was processed and fully executed under **Contract No. C77614 NCA (No Council Action)** on May 14, 2018 because the amount of the FY19 award was \$90,883.31 and therefore did not require council approval. The FY20 award was \$98,740.48 and processed on May 28, 2019. FY20 & FY21 subsequent awards were \$129,077.88 and processed on May 11, 2020. Pursuant to the updates AP 4-1 (updated on August 17, 2020) city council approval is now required for grants over \$400,000 for the entire grant contract period. The FY22 award is \$118,403.15 which will make the grant total \$437,104.82 and, therefore, requires Council approval.

HHD also requests City Council to authorize the Mayor to execute all related contracts, agreements, amendments and documents with the approval as to form of the City Attorney in connection with the grant assistance program and to authorize the Director or his designee to act as the City's representative with the authority to apply for, to accept and expend subsequent supplemental awards, if any, and to extend the term and/or budget and project period not to exceed five years, if extended by TCEQ during the project period and if it does not require cash matching funds.

This contract requires the City to continue to operate and maintain two (2) air monitoring stations in Houston, Texas. The data collected is used specifically to measure the Particular Matter (PM) in the air. The Federal Clean Air Act requires the Environmental Protection Agency (EPA) to set air quality standards, including those for PM, to protect both public health and the public welfare. The work reports and invoices for cost reimbursement are forwarded to TCEQ monthly. The contract revenue is intended to reimburse the City for costs incurred in operating the monitoring stations and collecting air quality data.

Background:

SUBJECT: A motion to set a public hearing date for September 22, 2021 regarding the designation for the Chewy, Inc. Reinvestment Zone for tax abatement purposes.

<u>RECOMMENDATION</u>: A motion to set a public hearing date for September 22, 2021 regarding the designation of the Chewy, Inc. Reinvestment Zone for tax abatement purposes.

SPECIFIC EXPLANATION:

Section 312.002, Texas Tax Code requires cities to adopt tax abatement guidelines and criteria before entering into tax abatement agreements or designating an area as a reinvestment zone. That Section also provides that cities' tax abatement guidelines and criteria expire after two years.

City Council renewed the tax abatement guidelines and criteria on December 16th, 2020 by Ordinance No. 2020-1091. Chapter 312 allows tax abatement agreements within a designated reinvestment zone and requires that the City hold a public hearing before it can adopt an ordinance designating an area as a reinvestment zone.

On August 19, 2021, the Harris County Municipal Utility District No. 421 ("MUD") sent a letter of intent to enter into a tax abatement agreement with Chewy, Inc. Since MUDs do not have the authority to create an abatement reinvestment zone, the MUD is requesting that the City create a tax abatement zone to facilitate the MUD's tax abatement. There will be no direct financial impact to the City for this action since the MUD will be granting the tax abatement.

Chewy, Inc., (the "Company") is proposing the development of a new regional e-commerce fulfillment facility. The project site will be the parcels identified with Harris County Appraisal District account numbers 0410530000090 and 0410530000067. The Company plans to invest approximately \$100 million to develop the Project, which will include \$50M for building purchase and improvements, \$3M for leasehold improvements, \$46M for Machinery & Equipment and \$1M for furniture and fixtures. The Company also intends to create 1,200 jobs.

The City has reviewed the Company's tax abatement application. The proposed date of the public

hearing is September 22, 2021. The hearing notice will be published in the Houston Chronicle 7 days prior to the public hearings as statutorily required in Chapter 312.201(d) of the Texas Tax Code.
