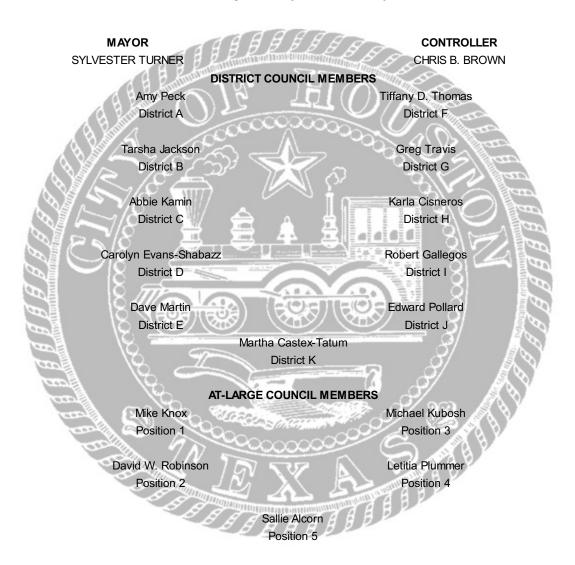

### **Background:**

**SUBJECT:** Adopt an Ordinance approving an Additional Appropriation for Change Order No. 3 for Neighborhood Street Reconstruction No. 460 (Subproject 1), Granberry Street, East 10th Street.

**RECOMMENDATION:** (Summary) Adopt an Ordinance approving an Additional Appropriation of \$36,281.40 for Neighborhood Street Reconstruction No. 460 (Subproject 1), Granberry Street, East 10th Street.

<u>PROJECT NOTICE/JUSTIFICATION:</u> This project is part of the Capital Improvement Plan and is required to replace existing residential streets that have deteriorated beyond economical repair and normal maintenance.

PREVIOUS HISTORY AND SCOPE: City Council approved the original Contract on August 14, 2019 under Ordinance No. 2019-0625. The scope of services under the Original Contract consisted of construction for concrete paving with storm drainage, curbs, sidewalks, driveways, street lighting, and necessary underground utilities. This project was designed by Cobb, Fendley & Associates, Inc. with 150 calendar days allowed for Construction. This project was awarded to Conrad Construction Co., LTD with an original Contract Amount of \$1,182,117.00.

**LOCATION:** This project area is generally bound by East 10th Street on the north, East 5th Street on the south, Granberry Street on the east, and Heights Boulevard on the west. **ADDITIONAL APPROPRIATION:** An approval is requested for an additional appropriation of \$36,281.40 in excess of the original contract value and extension of 40 days of contract time for additional work described in Change Order No. 3; provide additional funds necessary to complete construction due to the additional scope of the realignment of storm boxes and work on water service line adjustments. This scope of

work is necessary to complete the execution of this project due to the inspection results.

The total requested appropriation is \$38,131.40 to be appropriated as follows: \$36,281.40 for contract services and \$1,850.00 for CIP Cost Recovery.

The requested appropriation will cover the additional work identified.

HIRE HOUSTON FIRST: The proposed contract requires compliance with the City's 'Hire Houston First (HFF) ordinance that promotes economic opportunity for Houston business and supports job creation. In this case, Conrad Construction Co., LTD. is a designated HHF company, but they were the successful awardee without application of the HHF preference.

**PAY OR PLAY PROGRAM**; The proposed contract requires compliance with the City's 'Pay or Play' ordinance regarding health benefits for employees of City contractors. In this case, the Contractor provides health benefits to eligible employees in compliance with City policy.

**M/WBE PARTICIPATION:** The M/WBE goal established for this contract is 19.88%. The original Contract is in the amount of \$1,182,117.00. The Consultant has been paid \$1,228,525.37 (103.93%) to date. Of this amount, \$289,287.00 (23.55%) has been paid to M/WBE sub-consultants to date. Assuming approval of the requested additional appropriation, the contract amount will increase to \$1,218,398.40. According to Office of Business Opportunity, the Contractor's to date MWBE/SBE performance is 23.47%.

**FISCAL NOTE:** No significant Fiscal Operating impact is anticipated as a result of this project.

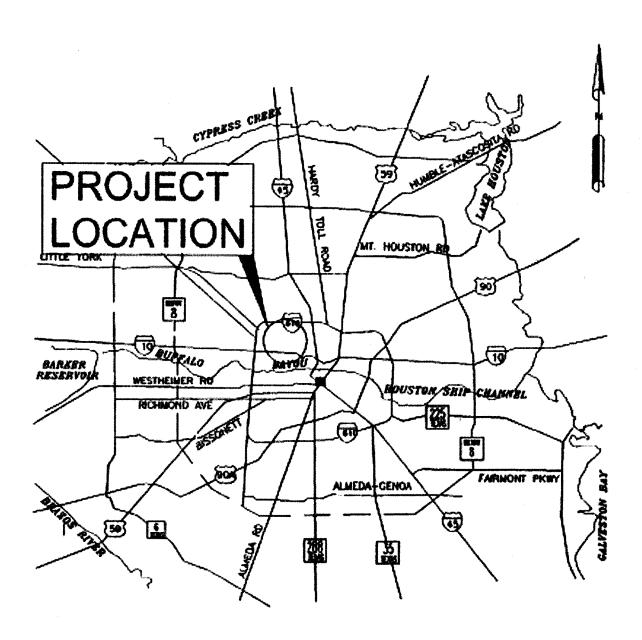

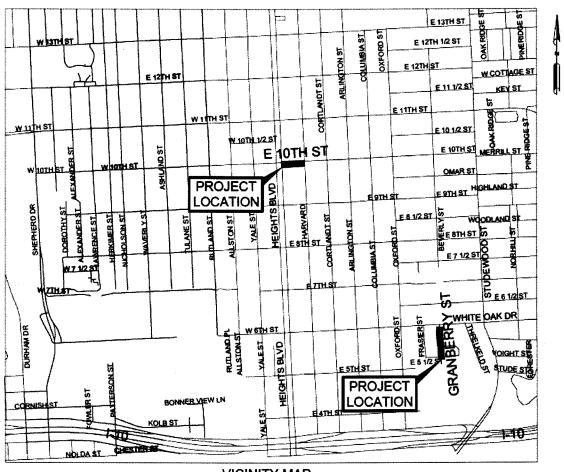

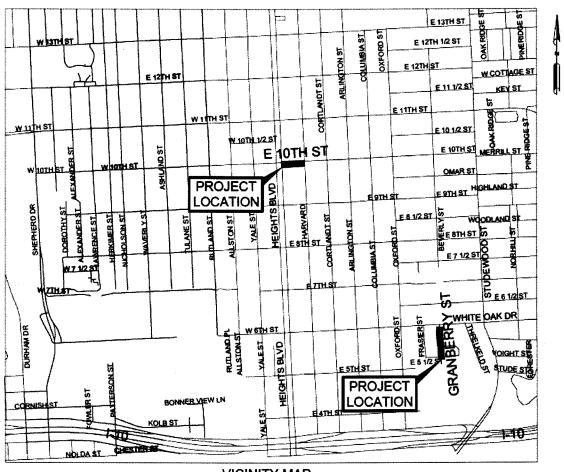

The City and CWA entered into an Operating Contract ("Operating Contract") approved by City Council on November 4, 2015 by Ordinance 2015-1072, pursuant to which CWA agreed to operate and maintain the Luce Bayou System Project and to transport, convey, and deliver the water of the City, for and on behalf of the City, through the Luce Bayou System Project on an annual cost basis.

Section 205 of the Operating Contract requires CWA to prepare and submit to the City an annual operating budget setting forth in detail proposed expenditures for the operation, maintenance, administration, capital improvements, and renovation and repair costs associated with the Luce Bayou System Project. CWA presented the City with the proposed 2022 operations and maintenance ("O&M") budget for the Luce Bayou System Project in the amount of \$4,998,100.00. This budget reflects a funding increase of \$1,289,400.00 as compared to CWA's Luce Bayou 2021 budget of \$3,708,700.00, which was approved by City Council on January 27, 2021, Motion Number 2021 0034.

This increase is to support the additional activities and responsibilities that CWA will encounter during 2022 in the following categories:

- Field Salaries Increase in staffing required to operate and maintain the Conveyance System as all components (canals, pipelines, maintenance station, equipment and pumping station) become operational during 2022.
- Contract Labor and Equipment- Cost of providing additional Security Services at the pump station and maintenance facility as the facilities and equipment become the responsibility of CWA.
- Utilities- Increase in electrical costs as the pump station becomes operational during 2022.
- Administrative Expenses Administrative expenses (pension, social security, etc.) will increase as more employees are hired.
- General Operating Expenses (Insurance)- Property insurance will increase as the facilities and equipment are transferred to CWA's responsibility. Employee insurance will increase as more staffing is added along with anticipated increase in medical and dental insurance policies.

Houston Public Works (HPW) met with CWA officials to review the submitted budget and concluded that the budget presented by CWA is reasonable given the work proposed.

The funds are allocated in the HPW budget according to CWA's annual budget submittal during the month of October. CWA's Fiscal Year 2022 starts on January 1, 2022 and ends on December 31, 2022. Six months of CWA's budget are allocated to the City's FY22 Budget (January 2022 to June 2022), and the remaining six months are allocated to the City's FY23 Budget (July 2022 to December 2022). Payments made to CWA are based upon documented actual monthly O&M expenditures.

<u>SPECIFIC EXPLANATION</u>: The contractor, Gadberry Construction Company Inc. has completed all the work required under the contract in the amount of \$1,472,443.95 for the construction of the Parking Operations Office Building at William P. Hobby Airport (HOU). The final contract amount includes 11 change orders for a net value of \$4,682.95.

The change in Construction Services included additional General Conditions costs associated with the increased scope of construction, the extension of the approved construction schedule, and the unused portions of the Schedule of Values.

During construction, the project was managed and inspected by Houston Airport System (HAS) personnel.

It is now requested that City Council pass a motion to approve the final contract amount of \$1,472,443.95, or 0.32% over the original contract amount of \$1,467,761.00 and under the 10% contingency amount, accept the work, and authorize final payment.

#### **MWBE Participation:**

The advertised M/WBE contract goals for this project were 6% MBE and 4% WBE (10% total). The M/W/SBE participation plan approved for this project was 18.05% MBE, 2.04% WBE, and 4.58% SBE (24.67% total). According to the HAS-OBO, the actual participation achieved on this project was 21.03% MBE, 0% WBE, and 5.27% SBE (26.3% total). The standard for meeting MWSBE participation goals is the demonstration of Good Faith Efforts (GFE). The Contractor's M/W/SBE performance on this project was rated Satisfactory. Gadberry Construction exceeded the MBE and SBE goals and utilized all listed M/SBE contractors. However, the Contractor fell short of the WBE goal, did not utilize the listed goal credit subcontractor, did not leverage the

deviation process, and did not replace the WBE participation on the contract. Although the Contractor exceeded the M/SBE goals, the lack of a GFE to utilize a WBE subcontractor resulted in a Satisfactory, rather than an Outstanding, rating. The Contractor's overall MWSBE performance meets the intent and spirit of the City's MWSBE program.

The project provides for the design and construction of the required improvements as well as structural, mechanical, and electrical components at lift stations.

This eminent domain proceeding involves the acquisition of easement interest to one parcel of land containing a total of 7033 square feet. The property is located at 9330 South Main Street in the City of Houston. The property is owned by Alta Med Main LP. Prior to sending the matter to the Legal Department, the City attempted to negotiate a purchase of the property, but those efforts were unsuccessful. # **Background:**

**SPECIFIC EXPLANATION:** The Director of the General Services Department (GSD) recommends that City Council appropriate \$169,473.15 out of the Miscellaneous Capital Projects/Acquisitions CP Series E Fund (4039) for the issuance of a purchase order to Kraftsman L.P. dba Kraftsman Commercial Playgrounds and Water Parks (Kraftsman) to provide construction services for the Cullen Park Sprayground for the Houston Parks and Recreation Department.

SPD will bring forward another Council item to authorize the issuance of the purchase order.

In August 2017, Hurricane Harvey caused significant damage to the Cullen Park Sprayground, which is located within the Addicks Reservoir. Approximately eight feet of surface water flooded the reservoir and the sprayground remained underwater for eight days, damaging the sprayground electrical control panel and manifold valves and rendering the sprayground inoperable.

**PROJECT DESCRIPTION:** The scope of work requires the contractor to provide all supervision, labor, materials, equipment and delivery costs necessary to remove and replace the electrical control panel and cabinet, valve manifolds and enclosure, backflow preventer with new reduced pressure zone backflow preventer and enclosure, above-ground spray features with new in-ground sprayers and three activators with one pedestal activator. Work includes install of concrete pad, refinish and reset in-ground spray features, grind and resurface sprayground surface, replace joint sealant, flush out all features and drain lines and install post for mounting

electrical equipment to a higher elevation to prevent future flood damage.

The existing sprayground system consists of a combination of Kraftsman KraftKoat™ and Water Odyssey™ proprietary replacement parts. 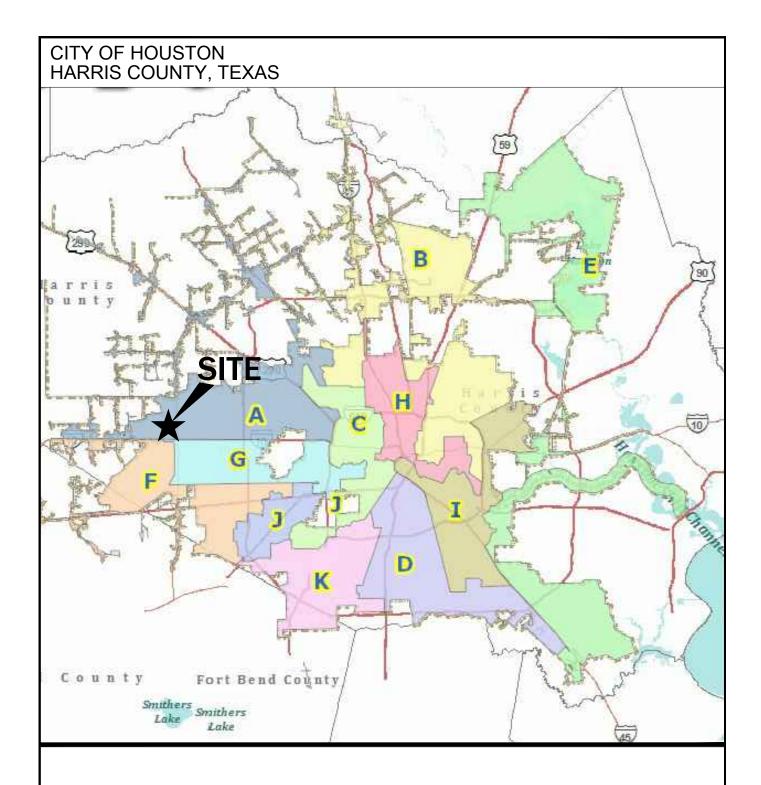

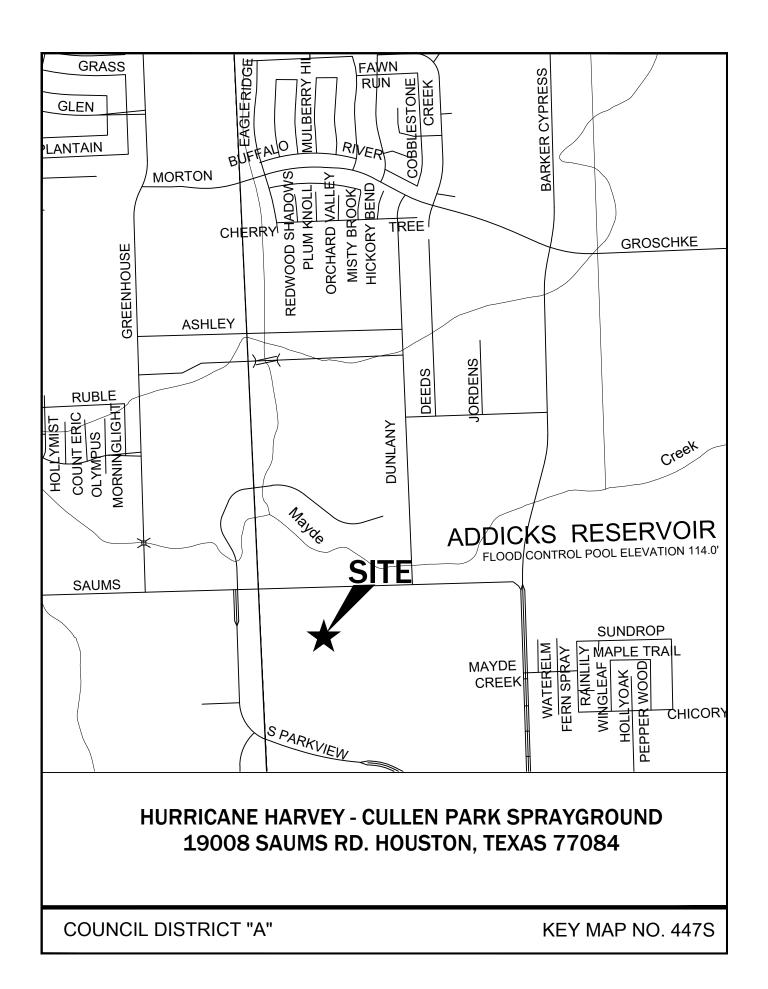

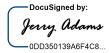

Enact an ordinance appropriating \$39,950,000.00 from the Airports Improvement Fund (Fund 8011) and approving and authorizing a Ground Lease and Use Agreement between Axiom Space, Inc. and the City of Houston through the Houston Airport System for an Aerospace Operations and Technology Facility at Houston Spaceport at Ellington Airport (EFD).

#### **SPECIFIC EXPLANATION:**

The City procured and completed initial construction of certain infrastructure improvements on 153 acres of Houston Spaceport to facilitate development and occupancy by aerospace companies to stimulate and grow aerospace development in the region. Axiom Space, Inc. (Axiom) then entered into a Memorandum of Agreement (MOA) No. 4600016692, authorized by Ordinance No. 2021-0407, to begin planning and design of an aerospace operations and technology facility on land along Enterprise Shuttle Street as an initial tract, along with additional land as an option tract, all being subject to adjustment by the parties in order to optimize Project Development.

Axiom will commence construction in multiple phases. The first component will be a high bay building for assembly and build-out of certain space station modules. Axiom will construct a high bay building for space station modules, followed by other facilities including integration labs, manufacturing area, maintenance hangar, bonded storage and office space. The option tract, if exercised, will accommodate additional aerospace facilities.

2. Rentals and Reimbursement:

In exchange for tenant improvements vesting in the City on a brick-by-brick basis, eligible capital costs, supported by proper documentation, shall be reimbursed to Axiom on a monthly basis, subject to appropriation of funds, and a rental rate methodology has been established to achieve cost recovery.

- a) <u>Due Diligence and Construction Period</u>. From the effective date of the MOA until the later of completion of facility construction (as defined in the lease) and the runway usability date, the rental rate shall be \$100.00 per month.
- b) Ground Rent During the Initial Term. If Axiom exercises the Option Tract, Axiom will pay ground rent at the appraised value, with rental adjustments every five years thereafter throughout the term. The expiration of the Option Tract shall run concurrently with the Initial Tract.
- c) <u>Cost Recovery Rent During the Initial Term.</u> Beginning with the first year following the Due Diligence and Construction Period, rent for the Initial Tract shall be charged as follows:
  - i. For lease years 1-10, rent shall be charged in an amount that permits project costs to be recovered from Axiom at the rate of 5% of the total cost reimbursed by City, escalated annually 2.5% throughout the initial ten lease years.
  - ii. For lease years 11-20, rent shall be

charged at the rate of 10% of the total cost reimbursed by City.

d) Option Period Rent. Rent for the option periods shall be at fair market value of land plus improvements set by independent appraisal, with 15% escalations every five years, thereafter throughout the remainder of the Lease term.

3. Term: Axiom shall be obligated to an initial 20-year term for up

to \$40 Million in reimbursable project costs. Axiom shall have the right to exercise up to two additional 10-year option periods, provided that the total term may not

exceed 40 years.

In exchange for tenant improvements vesting in the City on a brick-by-brick basis, eligible capital costs, supported by proper documentation, shall be reimbursed to Axiom on a monthly basis, subject to appropriation of funds, and a rental rate methodology has been established to achieve cost recovery.

a) <u>Due Diligence and Construction Period</u>. From the effective date of the MOA until the later of completion of facility construction (as defined in the lease) and the runway usability date, the rental rate shall be \$100.00 per month.

b) <u>Ground Rent During the Initial Term</u>. If Axiom exercises the Option Tract, Axiom will pay ground rent at the appraised value, with rental adjustments every five years thereafter throughout the term. The expiration of the Option Tract shall run concurrently with the Initial Tract.

- c) <u>Cost Recovery Rent During the Initial Term.</u> Beginning with the first year following the Due Diligence and Construction Period, rent for the Initial Tract shall be charged as follows:
  - i. For lease years 1-10, rent shall be charged in an amount that permits project costs to be recovered from Axiom at the rate of 5% of the total cost reimbursed by City, escalated annually 2.5% throughout the initial ten lease years.
  - ii. For lease years 11-20, rent shall be charged at the rate of 10% of the total cost reimbursed by City.
- d) Option Period Rent. Rent for the option periods shall be at fair market value of land plus improvements set by independent appraisal, with 15% escalations every five years, thereafter throughout the remainder of the Lease term.

3. Term:

Axiom shall be obligated to an initial 20-year term for up to \$40 Million in reimbursable project costs. Axiom shall have the right to exercise up to two additional 10-year option periods, provided that the total term may not exceed 40 years.

4. Other:

An MWBE goal is estimated to be 24% for design and 30% for construction of the project, to be further defined in coordination with the Office of Business Opportunity.

The Novel Coronavirus (COVID-19) has been recognized globally as a contagious respiratory virus. On March 13, 2020, Governor Greg Abbott declared a State of Disaster for all counties in Texas, pursuant to Section 418.014 of the Texas Tax Code, citing: (1) more than 30 confirmed cases of COVID-19 located in multiple Texas counties (2) more than 50 Texans with pending tests for COVID-19 in Texas and (3) the altered schedules and, in some instances, the closings of some schools, universities, and other governmental entities.

The Declaration further acknowledges the priority of coordinating preparedness efforts across State agencies and working with local partners to promote appropriate mitigation efforts and the criticality to take additional steps to prepare for, respond to, and mitigate the spread of COVID-19 for the protection of the health and welfare of Texans.

After declining case numbers throughout the fall of 2021, the newest COVID-19 variant has caused a rapid increase in the number of cases throughout the Houston region and there remains the need to provide adequate shelter to those in self-quarantine. At the beginning of the pandemic, to address the need to accommodate and provide shelter for Houstonians in self-quarantine, City Council approved a lease agreement and extensions with HAZARI, LLC located at 9902 Gulf Freeway, Texas. The initial lease was for a six-month period, with three optional 90-day extensions. All options were consumed on 31 March 2021. Council approved a new lease per Ordinance No. 2021-248 reducing the room totals to 32, or roughly 25 percent of hotel capacity, for a 90-day duration. The lease included three options to extend for 90-day increments, the first two of which have been consumed. The lease also provided for the option to increase the number of rooms taken in 25% increments.

Because of the rapidly increasing number of COVID-19 cases in the Houston region, this ordinance both approves the funding for the third and final extension option and increases by 25% the City's total number of rooms taken to 64 rooms, or 50% of the total hotel capacity. The total cost of this final option from January through March 2022 is \$289,350.00.

City Council approval is recommended to address this continuing health emergency and to protect residents, first responders, and health professionals mitigate the risk of spreading the COVID 19 virus.

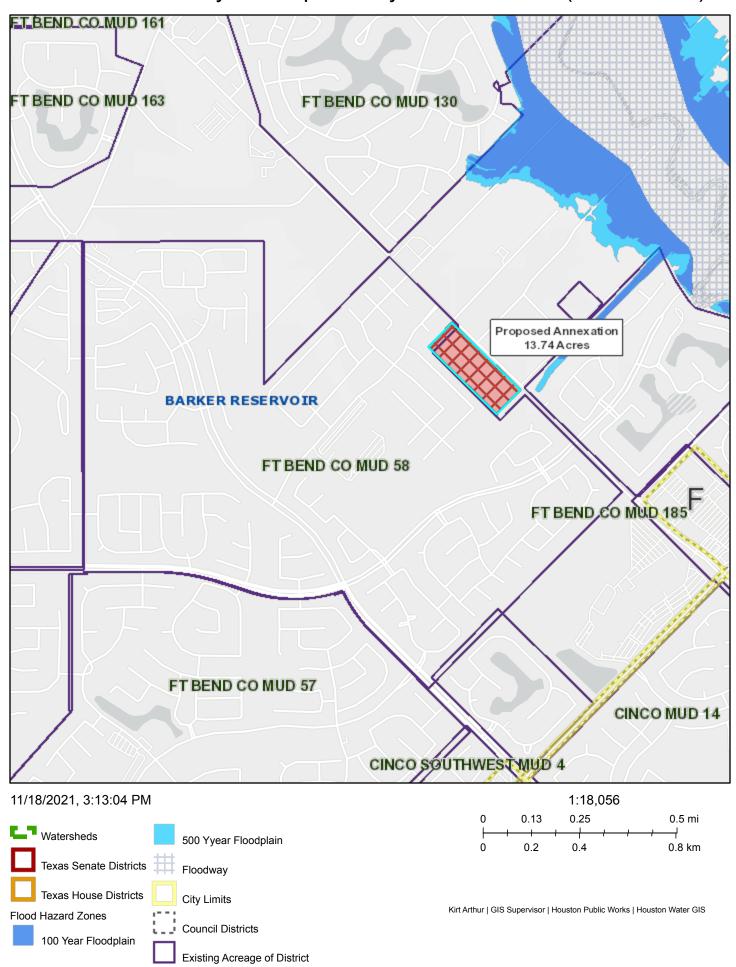

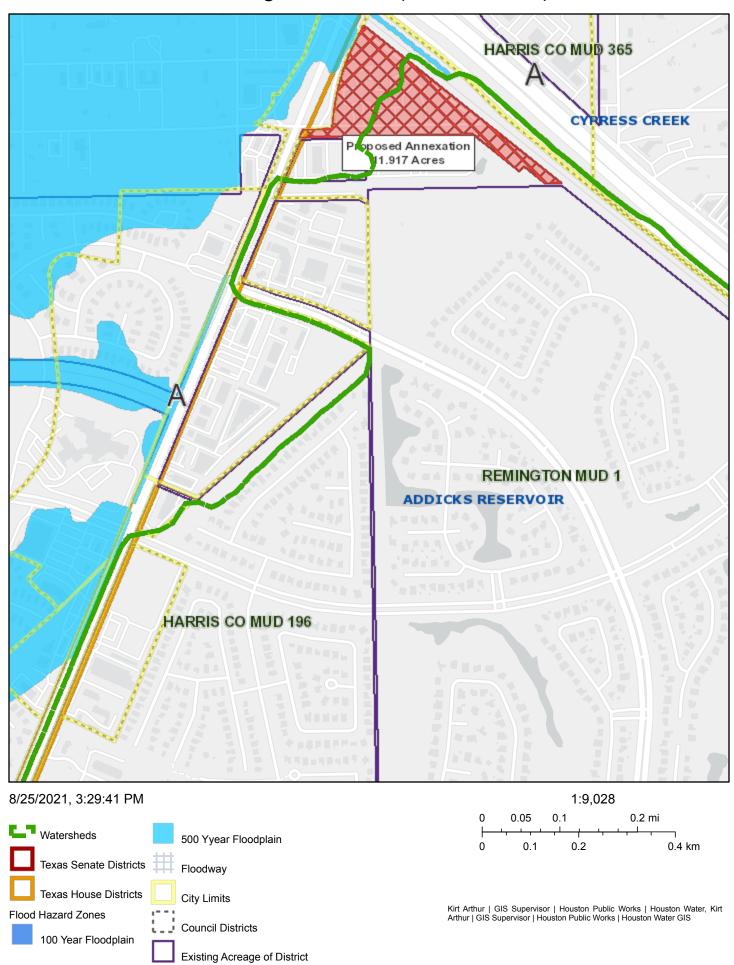

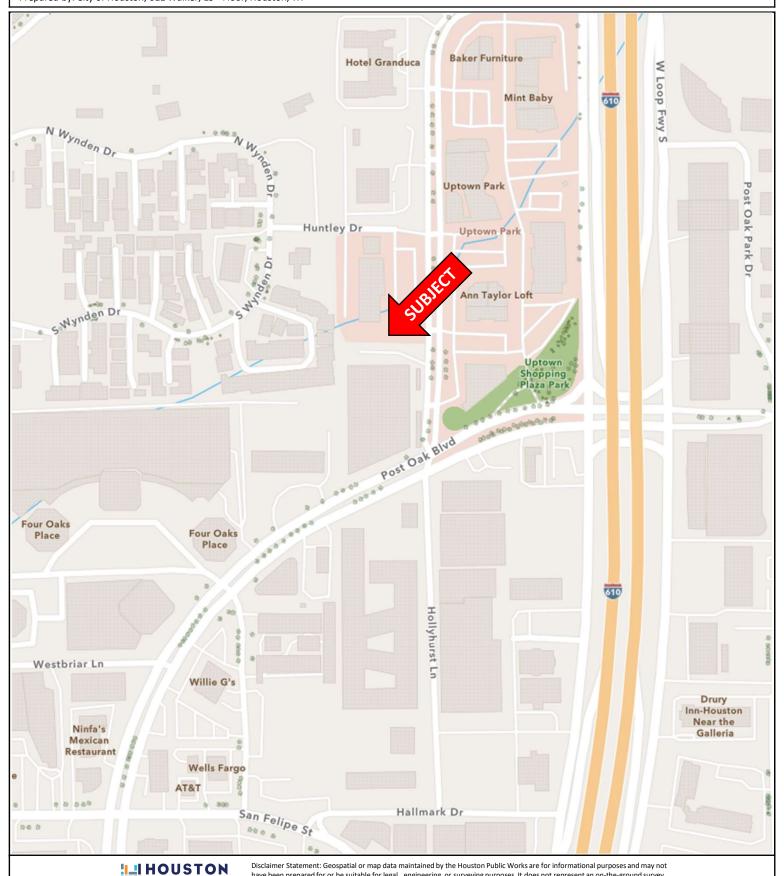

# **Background:**

**PROJECT NOTICE/JUSTIFICATION:** This project is part of the Capital Improvement Plan (CIP) Program. This program is required to provide professional engineering services to address necessary local storm water drainage system and roadside ditch improvements and repairs citywide.

<u>DESCRIPTION/SCOPE</u>: This project consists of professional engineering services to resolve localized storm water drainage problems that have been nominated by Transportation and Drainage Operations. The project scope is established by each work order. The work orders are prioritized based on a range of factors from public safety to level-of-service.

**LOCATION:** The projects are located throughout the City.

**PREVIOUS HISTORY AND SCOPE:** City Council approved the original contract on April 1, 2020 under Ordinance No. 2020-0270. The scope of work under the original contract consisted of Professional Engineering Services for LDP work orders. 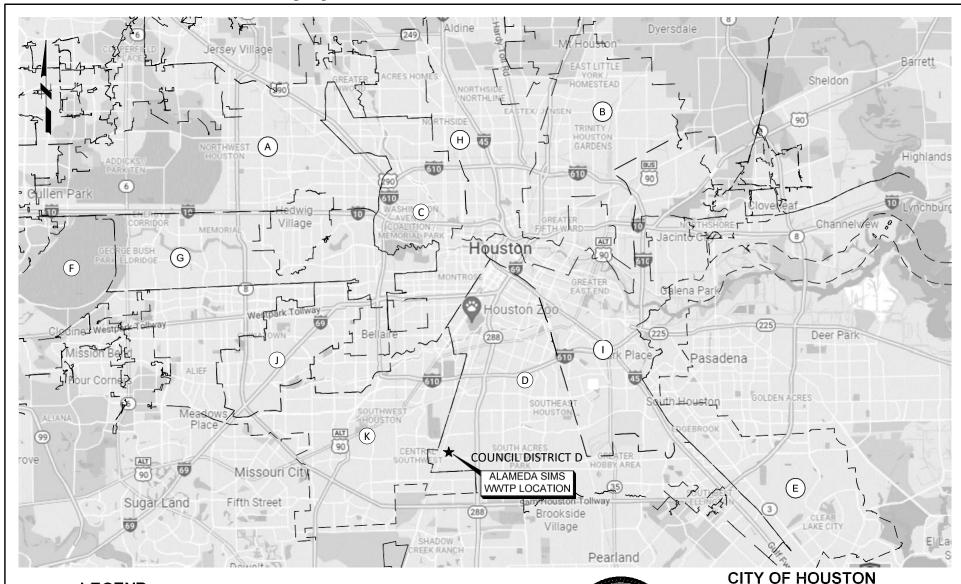

#### **Background:**

<u>SUBJECT:</u> First Amendment to Professional Engineering Services Contract between the City and GC Engineering, Inc. for University Boulevard Paving and Drainage from Kirby Drive to Main Street, now from Kirby Drive to Morningside Drive as Sub-Project 1.

**RECOMMENDATION:** Approve First Amendment to the Professional Engineering Services Contract with GC Engineering, Inc. and appropriate funds.

**PROJECT NOTICE/JUSTIFICATION:** This project is part of the Street and Traffic Capital Improvement Plan (CIP) and is required to meet City of Houston standards as well as improve traffic circulation, mobility, and drainage service area. Deterioration of existing pavement and future traffic volume requires that the roadway be reconstructed.

**<u>DESCRIPTION/SCOPE:</u>** This project consists of the design of approximately 5,800 linear feet of roadway reconstruction. The proposed project improvements include a two-lane undivided concrete roadway on University Boulevard from Kirby Drive to Main Street with curbs, storm sewer system, sidewalks, driveways, street lighting, traffic control and necessary underground utilities.

**LOCATION:** The project area is generally bound by Rice Boulevard on the north, West Holcombe Boulevard on the south, Morningside Drive on the east and Kirby Drive on the west.

**PREVIOUS HISTORY AND SCOPE:** City Council approved the original Contract on April 29, 2015 under Ordinance No. 2015-0369. The scope of services under the Original Contract consisted of Phase I - Preliminary Design, Phase II - Final Design, Phase III - Construction Phase Services and Additional Services. Under this Contract, the Consultant accomplished Phase I - Preliminary Design.

SCOPE OF THIS AMENDMENT AND FEE: Under the scope of the First Amendment, the Consultant will accomplish the following: Phase II - Final Design, Phase III - Construction Phase Services and Additional Services. This Amendment will also include changes to the original project by dividing it into 2 sub-projects. This sub-project will extend from Kirby Drive to Morningside Drive and consists of the design of approximately 1100 linear feet of an undivided two-lane concrete roadway. The design will include improvements to the storm sewer system, sidewalks, driveways, street lighting, traffic control and necessary underground utilities. This sub-project includes new configurations at every major intersection, scenic street design elements, Greenbriar intersection pavement examination, and significant business owner coordination.

A fee of \$16,299.00 is budgeted for Basic Services and \$141,089.47 for Additional Services.

The total requested appropriation is \$165,257.89 to be appropriated as follows: \$157,388.47 for contract services and \$7,869.42 for CIP Cost Recovery.

**PAY OR PLAY PROGRAM:** The proposed contract requires compliance with the City's 'Pay or Play' ordinance regarding health benefits for employees of City contractors. In this case, the Contractor provides health benefits to eligible employees in compliance with City policy.

**M/WBE PARTICIPATION:** The M/WBE goal established for this project is 24%. The original Contract amount totals \$924,462.07. The Consultant has been paid \$656,534.00 (71.02%) to date. Of this amount, \$208,760.20 (31.80%) has been paid to M/WBE subconsultants to date. Assuming approval of the requested additional appropriation, the contract amount will increase to \$1,081,850.54. The Consultant proposes the following plan to meet the M/WBE goal.

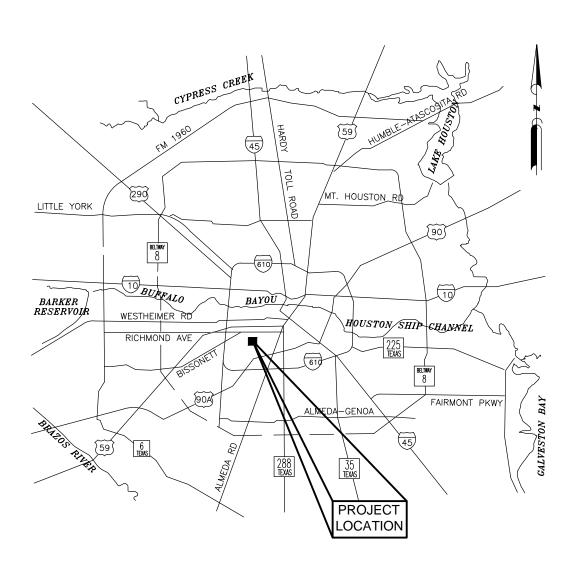

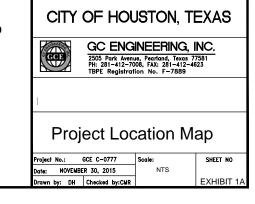

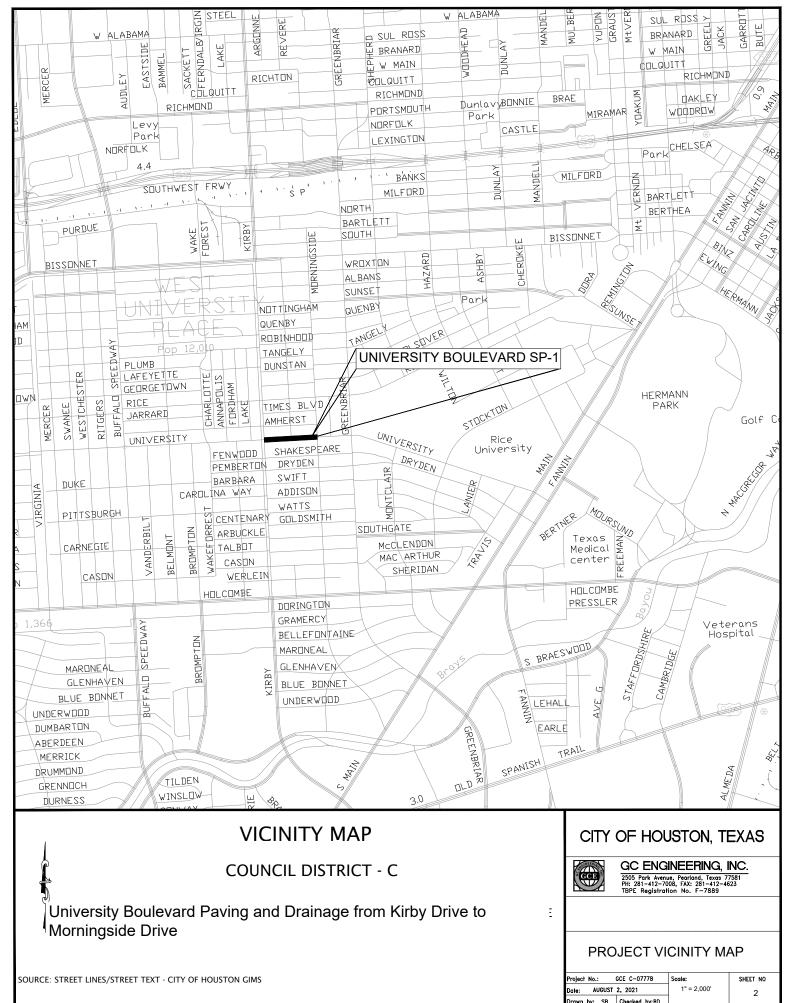


LOCATION MAP COUNCIL DISTRICT - C

Oral arguments were held on November 10 and we expect an opinion to be published sometime before the end of the current term in June 2022.

This ordinance creates a 60-day review period, beginning when the opinion is published, during which new sign permits would not be issued. This would allow the City to make any necessary amendments to the Houston Sign Code required by the Supreme Court's opinion, and for HPW to make the changes necessary to its operations, website, and forms to implement the changes. In the event that the court's decision is favorable and no amendments to the Sign Code are required, Council could end the review period and Sign Administration could resume normal activities.
