

Summary:

RECOMMENDATION from City Attorney for settlement of eminent domain proceedings styled City of Houston v. Southbound Ventures LLC, et al; located at 10880 West Bellfort, Cause No.1157149, the West Bellfort Paving and Drainage Improvement Project, Parcel AY18-058 - \$400,000.00 - **DISTRICT F - THOMAS**

Background:

The West Bellfort Paving and Drainage Project intends to improve drainage, reduce the risk of structural flooding, and improve traffic circulation by providing for the design and construction of storm drainage improvements, necessary concrete paving, curbs, sidewalks, driveways, and underground utilities as well as providing for shared use paths along the project and the replacement of traffic signals.

This eminent domain proceeding involves the acquisition of one street widening and drainage easement containing a total of 153 square feet of land, plus the closure of a non-compliant driveway which provided the primary point of ingress and egress to the property from Wilcrest Drive. The property is located at 10880 West Bellfort Street in the City of Houston. The property is owned by Southbound Ventures LLC. Prior to sending the matter to the Legal Department, the City attempted to negotiate a purchase of the property, but those efforts were unsuccessful. The matter was then referred to the Legal Department to initiate eminent domain proceedings to acquire the needed property.

A Petition in Condemnation was filed, a Special Commissioners' hearing was convened, and the Special Commissioners ordered an award of \$222,033.00. With Council approval, the City Attorney deposited this award into the registry of the court.

The Defendant then filed an Objection to the award of the special commissioners and the litigation was docketed for a jury trial setting. The court also ordered the parties to attend mediation. At the conclusion of the mediation, the court-appointed mediator recommended a Mediator's Settlement Proposal. Both parties agreed to the proposal and the result was an increase of \$177,967.00 above the award of the special commissioners to fully settle the litigation, which resulted in a final compensation total of \$400,000.00 for the property condemned and possible damages due to the

closure of the driveway.

Summary:

Authorize the City Attorney, by Motion, to settle the condemnation matter of *City of Houston v. Southbound Ventures LLC, et al;* Cause No.1157149, for an additional \$177,967.00 above the award of the special commissioners for a total compensation of \$400,000.00. Funding will be provided by a previously approved blanket appropriation ordinance.

Background:

The West Bellfort Paving and Drainage Project intends to improve drainage, reduce the risk of structural flooding, and improve traffic circulation by providing for the design and construction of storm drainage improvements, necessary concrete paving, curbs, sidewalks, driveways, and underground utilities as well as providing for shared use paths along the project and the replacement of traffic signals.

This eminent domain proceeding involves the acquisition of one street widening and drainage easement containing a total of 153 square feet of land, plus the closure of a non-compliant driveway which provided the primary point of ingress and egress to the property from Wilcrest Drive. The property is located at 10880 West Bellfort Street in the City of Houston. The property is owned by Southbound Ventures LLC. Prior to sending the matter to the Legal Department, the City attempted to negotiate a purchase of the property, but those efforts were unsuccessful. The matter was then referred to the Legal Department to initiate eminent domain proceedings to acquire the needed property.

A Petition in Condemnation was filed, a Special Commissioners' hearing was convened, and the Special Commissioners ordered an award of \$222,033.00. With Council approval, the City Attorney deposited this award into the registry of the court.

The Defendant then filed an Objection to the award of the special commissioners and the litigation was docketed for a jury trial setting. The court also ordered the parties to attend mediation. At the conclusion of the mediation, the court-appointed mediator recommended a Mediator's Settlement Proposal. Both parties agreed to the proposal and the result was an increase of \$177,967.00 above the award of the special commissioners to fully settle the litigation, which resulted in a final compensation total of \$400,000.00 for the property condemned and possible damages due to the closure of the driveway.

Authorize the City Attorney, by Motion, to settle the condemnation matter of *City of Houston v. Southbound Ventures LLC, et al;* Cause No.1157149, for an additional \$177,967.00 above the award of the special commissioners for a total compensation of \$400,000.00. Funding will be provided by a previously approved blanket appropriation ordinance.

Background:

The West Bellfort Paving and Drainage Project intends to improve drainage, reduce the risk of structural flooding, and improve traffic circulation by providing for the design and construction of storm drainage improvements, necessary concrete paving, curbs, sidewalks, driveways, and underground utilities as well as providing for shared use paths along the project and the replacement of traffic signals.

This eminent domain proceeding involves the acquisition of one street widening and drainage easement containing a total of 153 square feet of land, plus the closure of a non-compliant driveway which provided the primary point of ingress and egress to the property from Wilcrest Drive. The property is located at 10880 West Bellfort Street in the City of Houston. The property is owned by Southbound Ventures LLC. Prior to sending the matter to the Legal Department, the City attempted to negotiate a purchase of the property, but those efforts were unsuccessful. The matter was then referred to the Legal Department to initiate eminent domain proceedings to acquire the needed property.

A Petition in Condemnation was filed, a Special Commissioners' hearing was convened, and the Special Commissioners ordered an award of \$222,033.00. With Council approval, the City Attorney deposited this award into the registry of the court.

The Defendant then filed an Objection to the award of the special commissioners and the litigation was docketed for a jury trial setting. The court also ordered the parties to attend mediation. At the conclusion of the mediation, the court-appointed mediator recommended a Mediator's Settlement Proposal. Both parties agreed to the proposal and the result was an increase of \$177,967.00 above the award of the special commissioners to fully settle the litigation, which resulted in a final compensation total of \$400,000.00 for the property condemned and possible damages due to the closure of the driveway.

The Director of Fleet Management and the Chief Procurement Officer recommend that City Council approve the purchase of nine (9) semi-tractor and trailers through the Interlocal Agreement for Cooperative Purchasing with the Houston-Galveston Area Council (HGAC) in the total amount of **\$1,756,711.00** for the Solid Waste Management Department and that authorization be given to issue a purchase order to the HGAC contractor **Houston Freightliner Inc.** The funding for these vehicles is included in the FY2022 Capital Improvement Plan.

The nine (9) 35,000-lb Gross Vehicle Weight Rating (GVWR) semi -tractor power units will be equipped with a "fifth wheel" for hauling 57-cubic yard open bed trailers to be used by the Department for daily bulk waste collection operations.

These semi-tractor and trailers have been vetted and approved by the Fleet Management Department. It has been established that there are no opportunities to effectively incorporate the use of alternative fuel vehicles.

These semi-tractor power units will come with a full three-year/36,000-mile bumper-to-bumper warranty and truck bodies will come with a full one-year warranty. The life expectancy of these vehicles is seven years or 100,000 miles. These new vehicles will meet the EPA's current emission standards for low emission vehicles. These vehicles will replace existing vehicles that have reached their life expectancy and will be sent to auction for disposal.



 - To Parks & Recreation in the amount of \$10.5 million to reflect Houston Zoo payment,
 - To various departments in the amount of \$6.7 million to reflect the HOPE Meet and Confer Agreement for municipal employees,
 - To Solid Waste Department in the amount of \$5.5 million mainly due to the following:
 - Higher overtime cost \$3.9 million,
 - Funding for vehicle tracking system \$993,328
 - Funding for Homeless Encampment Clean-up and Anti-Litter Abatement program \$510,206

To address complex financial challenges, people in financial trouble need individualized help, not just education. Counselors first conduct financial triage with clients to determine the nature of their financial situation, set goals, and establish a specific plan of action with each client-focused in one or more of four primary domains: banking, increasing savings, reducing debt, and building credit. The current agreement expires April 30, 2022. The Third Amendment will extend the agreement through April 30, 2023. The Mayor's Office of Complete Communities (MOCC) requests City Council approval of a Third Amendment to the agreement between the Cities for Financial Empowerment (CFE) Fund, Greater Houston Community Foundation (GHCF), and the City of Houston (COH).

In November of 2019, the Houston City Council approved an ordinances to implement the Financial Empowerment Centers (FEC) program in the Complete Communities of Acres Home and Magnolia Park-Manchester. The FEC delivers professional, one-on-one financial counseling as a free city service and offers cities a tangible strategy to help those most in need of critical one-on-one assistance and to build community financial stability. To address complex financial challenges, people in financial trouble need individualized help, not just education. In the FEC, specially trained counselors work with clients on asset building, banking access, consumer protection, financial responsibility of home ownership, qualification for affordable housing, and financial education. Counselors first conduct financial triage with clients to determine the nature of their financial situation, set goals, and establish a specific plan of action with each client-focused in one or more of four primary domains: banking, increasing savings, reducing debt, and building credit. Clients may also be referred to other supportive services that will enhance the quality of life of that individual.

The current agreement expires April 30, 2022. The Third Amendment will extend the agreement through April 30, 2023. In consideration of this contract extension, the City will continue to provide financial counseling services through its nonprofit partner, The Alliance, under the terms and conditions of the original agreement. The Mayor's Office of Complete Communities is working with the Strategic Procurement Division on a new procurement for a new contract for professional financial counseling services for the FEC.

PROJECT NOTICE/JUSTIFICATION: This project is part of the Street and Traffic Capital Improvement Plan (CIP) and is required to meet City of Houston standards as well as improve traffic circulation, mobility, and drainage in the service area.

DESCRIPTION/SCOPE: This project consists of the design of new concrete roadways for the construction of Hillcroft Avenue and Court Road Extension, which includes the Fort Bend Parkway Frontage Roads (northbound and southbound) between the existing toll road ramps (approximately 4,350 linear feet each) and extension of Court Road from Quailynn Road east to proposed southbound Fort Bend Parkway frontage road, with concrete curbs, sidewalks, street lighting, storm sewer system and underground utilities.

LOCATION: The project area is generally bound by West Fuqua Street on the north, McHard Road on the south, Blue Ridge Road on the east and Hillcroft Avenue on the west.

SCOPE OF THIS ADDITIONAL APPROPRIATION AND FEE: The requested additional appropriation will accomplish the following: Phase III – Construction and Additional Services to include construction administration services, lowering of an abandoned oil/gas well due to conflict with a detention basin, and bridge construction oversight. A fee of \$23,600.00 is budgeted for Basic Services and \$59,720.00 for Additional Services.

The total requested appropriation is \$87,486.00 to be appropriated as follows: \$83,320.00 for contract services and \$4,166.00 for CIP Cost Recovery.

The proposed Change Order No. 13 is in the amount of \$887,635.45 or 7.83% above the original contract amount and extends the contract time by 120 days. This will increase the original contract amount to \$12,225,069.45, leaving the 5% contingency balance for completing the remaining work.

M/WBE PARTICIPATION: The MWBE goal established for this contract is 20%. The original contract amount was \$11,337,434.00. The Consultant has been paid \$10,916,455.08 (96.29%) to date. Of this amount, \$1,587,898.00 (14.55%) has been paid to the M/WBE subconsultants to date. Assuming the approval of Change Order No. 13, the Contract Amount will increase to \$12,225,069.45. The Consultant proposes the following plan to meet the M/WBE goal.

1.01 DESCRIPTION OF CHANGES

ITEM 1 SCOPE: Exploratory excavations to locate the existing 14-inch force main along Galveston Road and stand by cost for equipment.

JUSTIFICATION: The Construction plans call for the installation of discharge manhole, blow off manholes, ARV manholes, and plug valve manholes at Sta. 7+12.07, Sta. 20+05.80, Sta. 25+40.75, Sta. 38+05.80, Sta. 46+42.17, Sta. 56+05.88, Sta. 57+13.97, and Sta. 74+19.37 along Galveston Road at Bayfield Lift Station. During critical locates, the Contractor discovered 4-inch fiber optics conduit running parallel to the existing 14-inch force main. The Contractor submitted Request for Information (RFI) No. 41 requesting guidance.

The City met with the Contractor and Engineer of Records (EOR) to evaluate contractor's request. The Project team recommended performing additional exploratory excavations to identify the existing 14-inch force main alignment and seek an alternative installation method. The EOR reviewed Contractor's findings from exploratory excavation and recommended offsetting the manholes. Work Change Directive (WCD) No. 06 was executed to expedite the work and maintain schedule of this work. The scope of this additional work includes cost of labor, material, and equipment for exploratory excavation and additional compensation for equipment idle time and cost of additional excavations for manholes relocations. The Project Manager reviewed the proposal and negotiated the scope of additional work based on the man-hours and equipment confirmed with the daily report.

The City recommends adding this scope of work to the contract. An additional eighteen (18) calendar days are required to be added to the contract time to perform this work.


The Construction plans call for the installation of discharge manhole, blow off manholes, ARV manholes, and plug valve manholes at Sta. 7+12.07, Sta. 20+05.80, Sta. 25+40.75, Sta. 38+05.80, Sta. 46+42.17, Sta. 56+05.88, Sta. 57+13.97, and Sta. 74+19.37 along Galveston Road at Bayfield Lift Station. During critical locates, the Contractor discovered 4-inch fiber optics conduit running parallel to the existing 14-inch force main. The existing force main is located about 7 to 12 feet west of the location called out in the construction drawings. The proposed 6-foot and 8-foot manholes cannot fit at the existing force main location due to obstruction caused by fiber optics conduits, storm culverts, water line, and other boxes/pedestals. Contractor utility The submitted Request for Information (RFI) No. 42 requesting quidance.

The Engineer of Record (EOR) reviewed the issue and recommended offsetting the manholes to avoid the interference with utility lines along the existing force main. Wastewater Operations (WWO) reviewed and concurred with EOR recommendations. Request for Proposal (RFP) No. 07 was issued to the Contractor for the work associated with this recommendation. Work Change Directive (WCD) No. 06 was issued to expedite the work and maintain the project schedule. The scope of this additional work includes installation of 14-inch PVC pipe by open cut with 45-degree fittings; building access bridge to install CIPP in the existing force main; and site restorations. The Project Manager reviewed the proposal and negotiated the scope of additional work based on the man-hours and equipment confirmed with the daily report.

The City recommends adding this scope of work to the contract. An additional fifty-two (52) calendar days are required to be added to the contract time to perform this work.

ITEM 3 SCOPE:

Install 16-inch Ductile Iron Pipe (DIP) gravity sanitary sewer line by open cut.

JUSTIFICATION:

The Construction plans call for the installation of 15-inch sanitary sewer line from a force main discharge manhole at Sta. 74+19 to an existing discharge manhole located on the west side of Galveston Road using open cut method. Due to the proximity of 42-inch water line, 6-inch gas line, 8-inch water line, and 4-inch fiber optics cable the Contractor indicated that installation of the proposed 15-inch sanitary sewer line by open cut at 18 feet depth can endanger the structural integrity of 42-inch water line. The Contractor submitted Request for Information (RFI) No. 44 requesting guidance.

The Engineer of Record (EOR) reviewed the issue and recommended to install 16-inch sanitary sewer line over 42-inch water line by open cut. Drinking Water Operations and Wastewater Operations reviewed proposed crossing at existing 42-inch water line crossing and concurred with the recommendation. Request for Proposal (RFP) No. 08 was issued to the Contractor for the work associated with this recommendation. Work Change Directive (WCD) No. 07 was issued to expedite the work and maintain the project schedule. The additional scope includes locating utility lines and conducting survey, installation of 16-inch Ductile Iron Pipe (DIP) gravity sanitary sewer line, installation of cement stabilized sand footings, re-routing the existing 8-inch water line, relocating a fire hydrant, and compensation for additional six weeks of bypass system. The Project Manager reviewed the proposal and negotiated the additional scope.

The City recommends adding this scope of work to the contract. An additional fifty (50) calendar days are required to be added to the contract time to perform this work.




