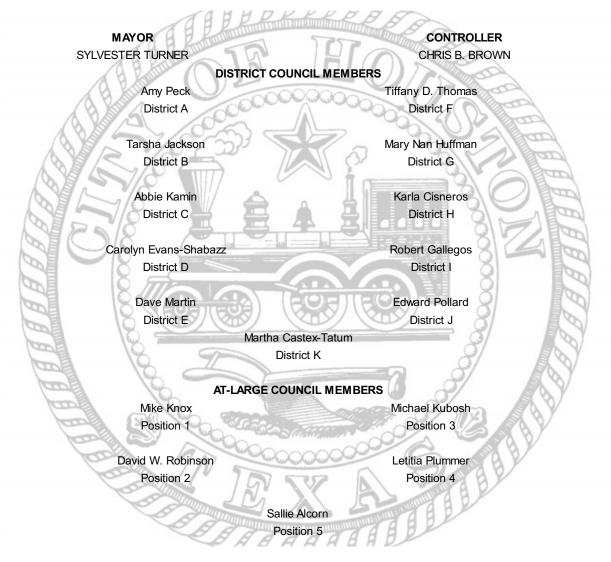

### Summary:

RESOLUTION approving the issuance and sale by **HOUSTON HOUSING FINANCE CORPORATION** of Multifamily Housing Revenue Notes (Summerdale Apartments) Series 2023

### **Background:**

The Housing and Community Development Department (HCD) recommends adoption of a Resolution approving the issuance and sale by Houston Housing Finance Corporation (the Issuer) of tax-exempt revenue bonds to finance the acquisition and construction costs of Summerdale Apartments, located at 2850 West Gulf Bank Road, Houston, TX 77088 (the Project).

On or around July 12, 2023, the Issuer's Board of Directors (the Board), intends to adopt a resolution to authorize the issuance, sale and delivery of its Multifamily Housing Revenue Notes (Summerdale Apartments) Series 2023 (the Notes), to be issued in one or more series of taxexempt bonds in an aggregate principal amount not to exceed \$38,000,000.00. The proceeds of the Notes will be loaned to Summerdale Apartments, LP (the Borrower), to provide financing for the acquisition, construction, and equipping of a 272-unit residential rental development to be known as Summerdale Apartments. The Notes are special limited obligations of the Issuer, payable solely from the revenues of the Project, and neither the faith and credit, nor the taxing power of the City of Houston are pledged to their repayment.

Section 147(f) of the United States Internal Revenue Code of 1986, as amended (the Code), and the Issuer's bylaws require the Issuer to obtain the approval of the City of Houston as the local jurisdiction wherein the Project is situated before the Notes can be issued.

The Notes are exempt from Federal income tax, and pursuant to Section 394.905, Texas Local Government Code, because the Houston Housing Finance Corporation will own fee title to the land on which the Project is located and equitable title to the improvements comprising the Project, the Project will also be exempt from ad valorem taxes.

ORDINANCE amending Ordinance No. 2020-721 to increase the maximum contract amount for Professional Services Contract between City of Houston and **ISANI CONSULTANTS**, **L.P.** for Building Standards Group Extension of Staff Services at George Bush Intercontinental Airport/Houston, William P. Hobby Airport, and Ellington Airport for the Houston Airport System - \$16,043,042.47 - Enterprise Fund - **DISTRICTS B - JACKSON; E - MARTIN and I - GALLEGOS** 

### **Background:**

### Recommendation:

Enact an ordinance amending Ordinance 2020-721 to increase the maximum contract amount to \$29,288,042.47 for Professional Services Contract with Isani Consultants, L.P. for Building Standards Group (BSG) Extension of Staff Services for George Bush Intercontinental Airport/Houston (IAH), William P. Hobby Airport (HOU), and Ellington Airport (EFD).

### Specific Explanation:

On August 26, 2020, City Council enacted Ordinance 2020-721 approving and authorizing an Agreement for Building Standards Group (BSG) Extension of Staff Services for the Houston Airport System (HAS) with Isani Consultants, L.P., and setting a maximum contract amount of \$13,245,000.00. The term of the contract is five years with one three-year option.

The Building Standards Group (BSG) in the HAS Infrastructure Division is responsible for effective and efficient building plan review, issuance and closeout of building code permitting actions, and issuance of certificates of occupancy throughout the airport system. It operates under a Memorandum of Understanding (MOU) between HAS, Houston Public Works (HPW), and the Houston Fire Department (HFD).

The Extension of Staff Services supports the BSG with resources to perform duties related to construction permitting and code enforcement. Isani Consultants, L.P., provides professional services in the roles of Building Official, Permit Coordinator, and Plans Examiner/Code Enforcement Inspector, supporting the following functions:

- Plans Examination
- Permit Coordination and Management
- Inspection
- Enforcement of Building, Plumbing, Mechanical, Electrical, and Fire Codes

Detailed scopes of work and cost estimates are prepared on an individual basis for each assignment, and task orders (Letters of Authorization (LOAs)) are executed prior to the issuance of a Notice to Proceed (NTP) on any given specific assignment. Major projects facilitated by Extension of Staff Services include the IAH Mickey Leland International Terminal (MLIT), IAH Federal Inspection Services (FIS), IAH International Terminal Redevelopment Program (ITRP) Enabling Utilities, IAH Checked Baggage Inspection System (CBIS), HOU and IAH Fuel Farm Projects, and the IAH Early Baggage Storage Building, with additional projects soon to be underway at all three airports.

In order to allow for the continuation of these critical Extension of Staff Services, it is now requested that City Council approve an increase to the maximum contract amount by \$16,043,042.47, bringing the total contract amount to \$29,288,042.47. The increase will allow sufficient capacity to support three additional years of Extension of Staff Services under the Agreement.

#### Specific Explanation:

On August 26, 2020, City Council enacted Ordinance 2020-721 approving and authorizing an Agreement for Building Standards Group (BSG) Extension of Staff Services for the Houston Airport System (HAS) with Isani Consultants, L.P., and setting a maximum contract amount of \$13,245,000.00. The term of the contract is five years with one three-year option.

The Building Standards Group (BSG) in the HAS Infrastructure Division is responsible for effective and efficient building plan review, issuance and closeout of building code permitting actions, and issuance of certificates of occupancy throughout the airport system. It operates under a Memorandum of Understanding (MOU) between HAS, Houston Public Works (HPW), and the Houston Fire Department (HFD).

The Extension of Staff Services supports the BSG with resources to perform duties related to construction permitting and code enforcement. Isani Consultants, L.P., provides professional services in the roles of Building Official, Permit Coordinator, and Plans Examiner/Code Enforcement Inspector, supporting the following functions:

- Plans Examination
- Permit Coordination and Management
- Inspection
- · Enforcement of Building, Plumbing, Mechanical, Electrical, and Fire Codes

Detailed scopes of work and cost estimates are prepared on an individual basis for each assignment, and task orders (Letters of Authorization (LOAs)) are executed prior to the issuance of a Notice to Proceed (NTP) on any given specific assignment. Major projects facilitated by Extension of Staff Services include the IAH Mickey Leland International Terminal (MLIT), IAH Federal Inspection Services (FIS), IAH International Terminal Redevelopment Program (ITRP) Enabling Utilities, IAH Checked Baggage Inspection System (CBIS), HOU and IAH Fuel Farm Projects, and the IAH Early Baggage Storage Building, with additional projects soon to be underway at all three airports.

In order to allow for the continuation of these critical Extension of Staff Services, it is now requested that City Council approve an

increase to the maximum contract amount by \$16,043,042.47, bringing the total contract amount to \$29,288,042.47. The increase will allow sufficient capacity to support three additional years of Extension of Staff Services under the Agreement.

## **Specific Explanation:**

The Director of Municipal Courts and the Chief Procurement Officer recommend that City Council approve an ordinance awarding a **three-year contract with one, one-year option** to **Brinks**, **Incorporated** in an amount not to exceed **\$822,861.90** for armored car deposit services for various departments.

A public hearing was held on June 14, 2023, and the notice of the public hearing was published in the Houston Chronicle on May 26, 2023. Additionally, pursuant to Texas Tax Code Section 312.207(d), the notice of the City Council meeting date to consider the tax abatement agreement was published in the Houston Chronicle on May 26, 2023, at least 30 days prior to the council meeting date to approve the agreement, which is scheduled for June 28, 2023.

The Project site is located at 9753 Katy Freeway, Houston TX 77024. The real property improvements subject to tax abatement is valued at approximately \$37.7 million which is calculated at 80% of the \$45.5 million investment. The Company also sought a variance to Section 44-131 of the Code of Ordinances, pursuant to Section 44-125, due to the Company initiating construction on the project
