

SPECIFIC EXPLANATION:

The contractor, Pepper Lawson Waterworks, LLC (PLW Waterworks, LLC), has completed all work required under the contract in the amount of \$18,215,372.94 for the design and construction of the Program Management Office (PMO) Building at George Bush Intercontinental Airport/Houston (IAH) (Project No. 821). The final contract amount includes 15 change orders with a net value of \$239,617.94.

The change in Construction Services included additional General Conditions costs associated with the increased scope of construction, including a reroute of the sanitary sewer line, fire suppression system install, demobilization of the temporary program management office, additional permit fees, and additional internal building elements; the extension of the approved construction schedule; and the unused portions of the Schedule of Values.

During the construction, the project was managed and inspected by the Houston Airport System (HAS) Project Management Team (PMT) personnel.

It is now requested that City Council pass a motion to approve the final contract amount of \$18,215,372.94, or 1.33% over the original contract amount of \$17,975,755.00 and under the 10% contingency amount, to accept the work, and to authorize final payment.

Background:

SUBJECT: Accept Work for Wastewater Collection System Rehabilitation and Renewal

RECOMMENDATION: (Summary) Pass a motion to approve the final contract amount of \$2,463,976.54 or 2.55% under the original contract amount, accept the Work and authorize final payment.

PROJECT NOTICE/JUSTIFICATION: This project was part of the Neighborhood Sewer Rehabilitation Program and was required to renew/replace various deteriorated neighborhood collection systems throughout the City. The project involved sanitary sewer rehabilitation by point repair method. The purpose was to reduce sanitary sewer overflows, which was accomplished by renewal/rehabilitation of deteriorated collection systems.

<u>DESCRIPTION/SCOPE</u>: This project consisted of sanitary sewer rehabilitation by point repair method. The project was awarded to rePipe Construction, LLC dba IPR South Central, LLC with 540 calendar days allowed for construction and an original contract amount of \$2,528,500.51.

LOCATION: The projects are located throughout the City of Houston.

CONTRACT COMPLETION AND COST: The contractor, rePipe Construction, LLC dba IPR South Central, LLC has completed the work under the subject contract. The project was completed within the contract time with an additional 180 days approved by Change Order No. 2. The final cost of the project, including overrun and underrun of estimated unit price quantities, is \$2,463,976.54, a decrease of \$64,523.97 or 2.55% under the original contract amount. The decreased cost is a result of the difference between planned and measured quantities.

M/WSBE PARTICIPATION: The advertised M/WBE contract goals for this project were 12.94% and 8.72% (21.66% total). The M/WBE goals approved for this project were 12.94% MBE and

8.72% WBE (21.66%). According to the Office of Business Opportunity, the actual participation achieved on this project was 18.04% MBE and 0.27% WBE (18.31% total). The standard for meeting MWBE participation goal is the demonstration of Good Faith Efforts. The Contractor's M/WBE performance on this project was rated as Satisfactory due to Good Faith Efforts for the following reasons: The Prime exceeded the MBE goal for this project. Although the Prime was unable to achieve the WBE goal, they made good faith efforts to utilize goal credit subcontractors to full capacity. Additionally, there was less manhole rehabilitation work required on the contract than originally anticipated, further affecting WBE participation. For the reasons listed, the Contractor's performance meets the intent and spirit of the City of Houston's MWBE program.










Waiver of Local Match Participation for Federal Off-System Bridge Program with TxDOT for bridge at 2400 Lazy Springs at HCFCD Ditch.



ARA – The Water Institute of the Gulf Agreement

Summary:

ORDINANCE approving and authorizing agreement between City of Houston and **THE WATER INSTITUTE OF THE GULF** to develop and pilot a Pocket Prairie and Green Stormwater Infrastructure Program for the Administration and Regulatory Affairs Department; providing a maximum contract amount - \$200,000.00 - Grant Fund

Background:

The Administration & Regulatory Affairs Department (ARA) recommends that City Council adopt an ordinance authorizing an agreement between the City of Houston (City) and The Water Institute of the Gulf (The Water Institute) to develop and pilot a Pocket Prairie and Green Stormwater Infrastructure Program (Project).

The City is one of 11 recipients of the Resilient Communities Grant Program, administered by the National Fish and Wildlife Foundation (NFWF). The grant application was prepared by the City and The Water Institute. The grant funds in the amount of \$200,000, are to be utilized for a project to demonstrate the feasibility of implementing nature-based solutions at the neighborhood scale that provide flood risk reduction and restoration benefits to flood-prone communities with limited access to green space. On December 9, 2022, NFWF and the City entered into a grant agreement obligating the City to distribute and make eligible use of the grant.

Specific Explanation

A small-scale pocket prairie is a densely planted garden of native flowers and grasses, that are one acre or less in size. Green Stormwater Infrastructure (GSI) encompasses a variety of practices primarily designed for managing stormwater runoff but that provide additional benefits such as habitat or aesthetic value. Small-scale pocket prairie and GSI sites play an important role in reducing localized flooding by absorbing rainwater where it falls. Smaller prairie features integrated into an urban environment are significant for urban wildlife and provide a means of movement for smaller species that are unable to travel prolonged distances. Implemented in neighborhoods where Houstonians live, these sites can also connect residents to broader landscape systems and educate the public about the importance of native prairie ecosystems.

The Project will seek to identify and develop five (5) conceptual designs and an implementation toolkit for small-scale pocket prairies and GSI on underutilized sites of less than one-acre in Houston. The toolkit will establish a model that can be replicated city-wide. Many areas of Houston contain abandoned or vacant properties that consist of invasive species and currently serve little to no benefit to the community, environment and surrounding natural wildlife. These areas become

prone to illegal dumping and further impact the nature and safety of communities. The project aims to provide a roadmap for how the City can transform select vacant and underutilized properties into neighborhood assets that reduce flood risk and enhance biodiversity and habitat health within the most climate-vulnerable neighborhoods in Houston.

The complete agreement scope allows The Water Institute to organize and participate in a site visit to select short-listed properties. The Water Institute will also meet with representatives from City departments, other agencies, and organizations who own or manage the properties on the short list (including but not limited to the City's Parks and Recreation Department, Houston Public Works, Houston Parks Board, Houston Land Bank) to understand their priorities and considerations that may inform the selection, design, and programming of pilot sites. The Water Institute will also lead and support the development of project outreach materials that City staff can use to engage community members to understand community priorities on design, programming, and analysis of project benefits.

The agreement will be effective on the countersign date, and shall remain in effect for two years, unless sooner terminated under the provisions of the agreement. At the sole discretion of the Director of ARA, a written request for renewal to The Water Institute at least 30 days before expiration of the then-current term and if sufficient funds are allocated, then, upon expiration of the initial term, the agreement is renewed for two successive one-year terms upon the same terms and conditions.

ARA - Ordinance Authorizing Submission of Application to USDOT for CFI Community Grant Program

Summary:

ORDINANCE approving and authorizing submission of an application for Grant Assistance to the UNITED STATES DEPARTMENT OF TRANSPORTATION ("USDOT") for the Charging and Fueling Infrastructure ("CFI") Community Grant Program for the Administration and Regulatory Affairs Department – Mayor's Office Of Resilience and Sustainability; declaring the City's eligibility for such Grant; authorizing the Director of the Administration and Regulatory Affairs Department to act as the City's representative in the application process, to apply for and accept the Grant and Funds, and expend the Grant Funds, as awarded, and to apply for and accept all subsequent awards, if any, pertaining to the Grant

Background:

The Administration & Regulatory Affairs Department recommends that City Council approve an ordinance authorizing the submission of an application for grant assistance to the United States Department of Transportation ("USDOT") for the Charging and Fueling Infrastructure ("CFI") Community Grant Program with an estimated grant value of \$15M. The anticipated project period is February 1, 2024 to December 31, 2027.

Specific Explanation

The Administration & Regulatory Affairs Department requests approval and authorization by City Council to apply for grant funds from the USDOT that will be used to deploy publicly accessible Electric Vehicle Support Equipment ("EVSE") at City-owned libraries, community centers, and parks (about 81 project locations and 366 chargers in total). This project aligns with the City's Resilient Houston (RH) strategy and Climate Action Plan (CAP).

If awarded, the City will direct 100% of CFI grant funding towards Top Priority (~13 sites) and High Priority (~14 sites) project locations (Table 1) within Justice40 (J40) Disadvantaged Communities (DAC) census tracts. The funds will also serve to strategically locate Direct Current Fast Charging (DCFC) stations based on proximity to Designated Alternative Fuel Corridors (AFCs) and high concentrations of Multi-Family Housing (MFH) units. The City of Houston will call for co-designing with the community.

In addition, the City will be attracting private sector partners through a request for proposals (RFP) process. Preference will be given to respondents whose plans include strategies such as, but not limited to:

- Priority sequencing for sites in low-to-moderate income (LMI) neighborhoods
- · Varied pricing or funding models for LMI communities
- Multimodality considerations (such as accessibility to electric bicycles)
- Extensive community engagement and input during project design to ensure site-specific plans meet community

Site priority in decreasing order:

- Top Priority: In J40 DAC census tract and within 1 mile of at least two different AFCs.
- **High Priority:** In J40 DAC census tract, within 1 mile of one AFC, and near high concentration of MFH units or charging desert.
- Medium-High Priority: In J40 DAC census tract and within 1 mile of one AFC.
- Medium Priority: Within 1 mile of at least two different AFCs.
- Low Priority: Within 1 mile of one AFC.
- Lowest Priority: Public parking.

No City funding will be requested for this project. ARA will solicit contractual support to perform funded work through an RFP. The contractor selected through the RFP will be responsible for all non-federal costs (estimated at \$14,088,833). In addition to installing the EVSE, the contractor will be responsible for owning, operating, and managing the EVSE and will share revenue with the City through a concessions agreement. If the City is selected for this award, City Council will be asked for approval to accept the award, with specific details regarding the specific amounts and sources of any required local funding match.

The estimated costs shown in Table 2 includes a cost factor multiplier of 1.55% for flood-preparedness at sites located in flood plains.

Background:

The Housing and Community Development (HCD) Department recommends Council approval of an Ordinance authorizing a Loan Agreement between the City of Houston (City) and Educational Programs Inspiring Communities, Inc. dba, The H.E.A.R.T. Program, to provide \$790,416.00 in Community Development Block Grant (CDBG) funds, towards the rehabilitation of the Workforce Training Center located at 707 Lehman. Improvements to the site include electrical and HVAC upgrades, roof replacement, plumbing, perimeter security fencing, security system, internet capability and build-out completion for the training center. The project will provide and expand employment programs and job opportunities for individuals with disabilities.

The H.E.A.R.T. Job Training Program core areas include a curriculum consisting of life and social skills, job readiness, hands-on training, on-the-job training, classroom training, repetitive practices, and community-based vocational instruction. The target population is adults 18 years of age or older who have an intellectual and diagnosed developmental disability.

The mission at H.E.A.R.T. is to promote structured independence for individuals with developmental disabilities by providing education, training, and employment programs. H.E.A.R.T. serves the special needs population to prepare future employees with disabilities for real-world, in real-world life settings for job training and placement opportunities. With needed rehab, the construction of this project will provide expanded programs for workforce employment training, training simulation to develop needed work skills, and actual on-the-job training through the utilization of major employers and their venues along with on-the-job instructors, mentors, and supervisors.










