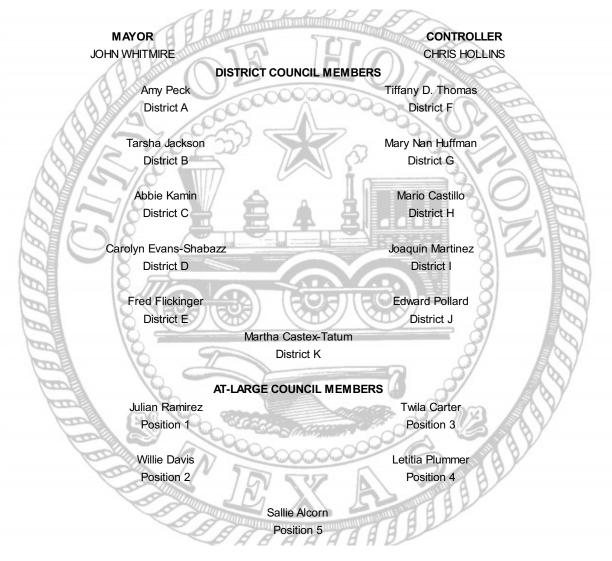

## Background: RECOMMENDATION:

Pass a motion approving calendar year 2024 membership fees for Airports Council International-North America (ACI-NA) in an amount not to exceed \$161,674.00 for the Houston Airport System.

## SPECIFIC EXPLANATION:

Airports Council International (ACI) is the trade association of airport owners and operators worldwide. Headquartered in Montreal, Canada, ACI has 646 members operating over 1,960 airports in 176 countries. ACI is comprised of five geographical regions: Africa, Asia-Pacific, Europe, Latin America-Caribbean, and North America. The North America region, which includes Canada and the United States, is represented by ACI-NA, based in Washington, D.C.

Membership in ACI-NA provides the department with 1) a means of keeping current on the latest techniques of the many functional aspects of airport management; 2) advocacy on legislative issues before the Congress and world forums; 3) a way to exchange information with other airports facing similar situations; 4) a single airport voice in dealing with the federal government; 5) representation in the bilateral negotiating process for international air routes; and 6) training and certification opportunities by a world leader in airport management and operations education. Additionally, ACI-NA was instrumental in securing federal COVID-19 relief funds and Bipartisan Infrastructure Law (BIL) funds for American airports.

Base membership dues are formula-based and are a function of an airport's passenger and cargo activity, where each enplaned and deplaned passenger and each 100 kilograms of enplaned and deplaned cargo equal one traffic unit. For 2022, Houston had 59,618,398.00 traffic units. Base dues for 2024 are \$130,174.00. International air service dues are based on enplaned international passengers; for 2022, Houston had 10,445,141 international passengers, bringing the fee to \$9,000.00. A legislative assessment of

\$15,000.00 and a policy assessment of \$7,500.00, both discounted rates, are also included. Total

dues for 2024 are \$161,674.00. This amount remains consistent with dues paid in recent calendar years.

Support of this organization provides member airports with constant communication concerning various legislative and regulatory processes and international civil aviation organizations, such as security issues impacting airports, and enables member airports to make their voices heard at critical points along the way. Benefits from membership and participation in this organization far outweigh the cost of dues and serve the best interest of the Houston Airport System in meeting the current airport needs of the community, customers, and users.

## Summary:

ORDINANCE denying the application of **CENTERPOINT ENERGY HOUSTON ELECTRIC**, **LLC**, for approval to amend its Distribution Cost Recovery Factor filed with Houston, Texas on December 14, 2023

## **Background:**

The Administration & Regulatory Affairs Department (ARA) recommends that City Council adopt an ordinance denying the application of CenterPoint Energy Houston Electric, LLC (CenterPoint or Company) for approval to amend its Distribution Cost Recovery Factor (DCRF) rate filed with the City of Houston (City or Houston). CenterPoint provides transmission and distribution services to approximately one million Houston customers, of which approximately 900,000 are residential customers. The City exercises original jurisdiction over the rates, operations, and services of CenterPoint under the provisions of the Public Utility Regulatory Act (PURA) for customers inside the city limits.

On December 14, 2023, CenterPoint filed an application for approval to amend its DCRF. CenterPoint filed this application with all cities in its service territory and with the Public Utility Commission of Texas (PUC) concurrently (PUC Docket No. 55993). Compared to current rates, CenterPoint is requesting an \$85.9 million incremental increase to its DCRF revenue requirement. With the requested increase, the total DCRF revenue requirement adjusted for load growth is \$233.5 million. Approximately \$134.2 million of the total DCRF revenue requirement is allocated to the residential class. As a result, the average residential customer using 1,000 kWh per month would experience a \$1.52 increase to the monthly bill.

PURA allows an electric utility to request approval of a DCRF application to adjust its rates for changes in certain distribution costs outside of a full base rate proceeding. Initially, the utility could file the DCRF application only once a year. However, recent amendments to PURA §36.210 now allow utilities to file a DCRF twice a year. This is CenterPoint's second DCRF application filed in 2023.

Unlike a full base rate proceeding, the City does not have the option to suspend a DCRF rate request and only has 60 days – until February 12, 2024 – to review the filing to make a determination on the reasonableness of the request. Because of the expedited nature of the filing, the City's legal counsel and utility rate experts recommend City Council adopt an ordinance denying CenterPoint's application. The utility will appeal the City's decision to the PUC, and the case will automatically be consolidated with CenterPoint's DCRF proceeding before the PUC, in

which the City will participate.

The City exercises original jurisdiction over the rates, operations, and services of CenterPoint under the provisions of the Public Utility Regulatory Act (PURA) for customers inside the city limits.

On December 14, 2023, CenterPoint filed an application for approval to amend its DCRF. CenterPoint filed this application with all cities in its service territory and with the Public Utility Commission of Texas (PUC) concurrently (PUC Docket No. 55993). Compared to current rates, CenterPoint is requesting an \$85.9 million incremental increase to its DCRF revenue requirement. With the requested increase, the total DCRF revenue requirement adjusted for load growth is \$233.5 million. Approximately \$134.2 million of the total DCRF revenue requirement is allocated to the residential class. As a result, the average residential customer using 1,000 kWh per month would experience a \$1.52 increase to the monthly bill.

PURA allows an electric utility to request approval of a DCRF application to adjust its rates for changes in certain distribution costs outside of a full base rate proceeding. Initially, the utility could file the DCRF application only once a year. However, recent amendments to PURA §36.210 now allow utilities to file a DCRF twice a year. This is CenterPoint's second DCRF application filed in 2023.

Unlike a full base rate proceeding, the City does not have the option to suspend a DCRF rate request and only has 60 days – until February 12, 2024 – to review the filing to make a determination on the reasonableness of the request. Because of the expedited nature of the filing, the City's legal counsel and utility rate experts recommend City Council adopt an ordinance denying CenterPoint's application. The utility will appeal the City's decision to the PUC, and the case will automatically be consolidated with CenterPoint's DCRF proceeding before the PUC, in which the City will participate.


