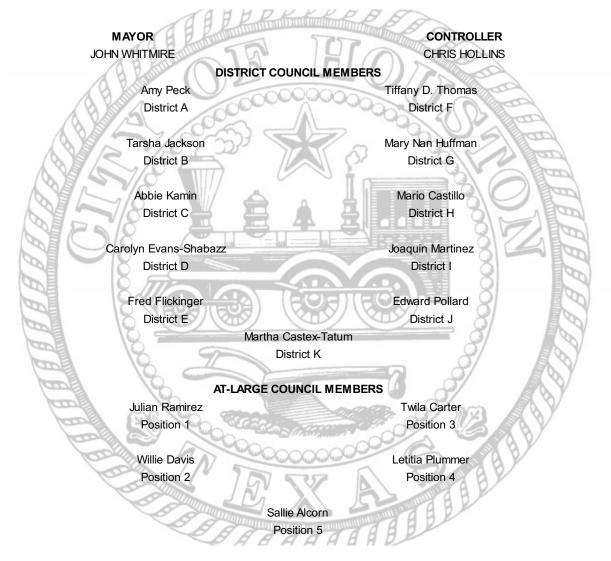

Furthermore, such legal services cannot be reasonably obtained from attorneys in private practice for the payment of hourly fees without contingency because the City will not be obligated to pay any legal fees unless the transaction successfully closes.

HHD – Texas Medical Center Assessments

Summary:

RECOMMENDATION from Director Houston Health Department for approval of payment of 2020 through 2024 Annual Assessment Fees to the **TEXAS MEDICAL CENTER** for the Houston Health Department - \$580,400.34 - General Fund

Background:

MOTION approving and authorizing payment of the annual assessment fees to the Texas Medical Center Corporation from 2020 through 2024 in the total amount of \$580,400.34.

Specific Explanation:

The Director of the Houston Health Department (HHD) recommends that City Council approve and authorize payment of the annual assessment fees to the Texas Medical Center (TMC) Corporation from 2020 through 2024 in the total amount of \$580,400.34.

HHD owns property located at 1115 S. Braeswood which previously served as the City's public health laboratory. This property is within the boundaries of the TMC, which makes HHD a TMC member. As such, HHD is required to pay annual assessments to TMC for security and maintenance. The security assessments include campus patrols, crime suppression, perimeter control, traffic control, campus vehicle assists and information, safety and emergency preparedness information to the institutions. The maintenance portion encompasses maintenance of streets, esplanades, sidewalks, parks, routine lawn care, and tree trimming.

Specific Explanation:

The Director of Administration and Regulatory Affairs (ARA) and the Chief Procurement Officer recommend that City Council approve spending authority for the purchase of spay and neuter services on feline and canine animals in the total amount of **\$1,008,000.00** to the **Houston PetSet**.

Due to rising operational costs and increased demand, Houston PetSet has implemented a pricing adjustment for spay and neuter services. Background:

The Administration & Regulatory Affairs Department (ARA) recommends that the City Council approve an ordinance amending Chapter 28, Article XIV of the City of Houston Code of Ordinances relating to boarding homes.

In July 2013, City Council approved an ordinance requiring operators of boarding home facilities within the Houston city limits to register with the City to maintain oversight. Subsequently, in March 2018, City Council approved an ordinance creating regulations and permit requirements for boarding home facilities, which was codified as Article XIV of Chapter 28 of the City of Houston Code of Ordinances ("Boarding Home Ordinance"). Section 28-451 of the Boarding Home Ordinance defines a boarding home as an establishment that:

(1) Furnishes, in one or more buildings, lodging to three or more persons with disabilities or elderly persons who are unrelated to the owner of the establishment by blood or marriage; and

(2) Provides residents with community meals, light housework, meal preparation, transportation, grocery shopping, money management, laundry services, or assistance with self-administration of medication, but does not provide personal care services as defined by Section 247.002 of the Texas Health and Safety Code to those persons.

This language mirrors the definition of a "boarding home" found in Section 260.001(2) of the Texas Health and Safety Code. The definition does not include nursing homes, assisted living facilities, or other types of facilities regulated by the State of Texas, which exemptions are enumerated in Section 28-453 of the Boarding Home Ordinance.

Since that time, there has been a substantial change in state law. Specifically, during the 88th Texas Legislature, House Bill (HB) 299 was enacted. HB 299 amended the Texas Health and Safety Code to create a voluntary accreditation for recovery houses. HB 299 went into effect on

September 1, 2023, and is now codified as Chapter 469 of the Texas Health and Safety Code. The proposed amendment is to include recovery houses as an exemption to the Boarding Home Ordinance to align with the Texas Legislature's intent concerning regulation of recovery houses.

SPECIFIC EXPLANATION: The General Services Department (GSD) utilizes task order contracts to facilitate landscape architectural design services for capital improvement projects for the Houston Parks and Recreation Department (HPARD). GSD recommends that City Council appropriate a sum of \$1,429,260.00 to the Landscape Architectural Task Order Contracting Program for professional services for HPARD.

The Landscape Architectural Task Order Contracting Program is funded through additional appropriations as HPARD identifies projects and specific funding for various design projects, which are assigned to the various contractors. Fees for each task order project are negotiated based upon the size and complexity of the task involved.

Currently, GSD utilizes four TOC consultants: (1) Clark Condon Associates, Inc. (CCA); (2) Design Workshop, Inc., (DW); (3) M2L Associates, Inc., (M2L); and (4) Kimley-Horn and Associates, Inc. (KHA).

PROJECT LOCATIONS: Citywide

PROJECT DESCRIPTION: See attached list.

PREVIOUS HISTORY: On March 25, 2020, by Ordinance No. 2020-0219, Council approved design services task order contracts with Clark Condon Associates, Inc. (CCA); Design Workshop, Inc. (DW); Lauren Griffith, Inc. (LG); M2L Associates, Inc., (M2L); and James Patterson Associates, Inc. dba White Oak Studio. (WOS) for a term of three years with two one-

year renewal options. Each contract has a maximum contract amount of \$3,000,000.00.

On October 17, 2022, WOS was purchased by Kimley-Horn and Associates, Inc. (KHA) and the City consented to the assignment of all the duties of James Patterson Associates, Inc. dba White Oak Studio to be assigned to Kimley-Horn and Associates, Inc. (KHA). Future work authorizations will be assigned to the KHA Task Order contract.

On December 14, 2022, by Ordinance No. 2022-968, Council approved an additional appropriation, in the amount of \$3,058,000.00, to the design services task order contracts with Clark Condon Associates, Inc. (CCA); Design Workshop, Inc. (DW); Lauren Griffith, Inc. (LG); M2L Associates, Inc., (M2L); and Kimley-Horn and Associates, Inc. (KHA).

As of December 31, 2023, projects previously assigned to Lauren Griffith, Inc. (LG) have been distributed to the other design firms according to the terms of the contract.

M/WBE/SBE PARTICIPATION: A 24.0% M/WBE goal has been established for each contract. To date, CCA has achieved 30.10% participation, DW has achieved 11.61% participation, LG has achieved 512.83% participation and M2L has achieved 20.55% participation. To date there is no utilization report for KHA as the design projects assigned to them have been performed by KHA (self-performed) and no work has been performed by their sub-consultants. It is anticipated that DW, M2L and KHA will achieve the goal by the completion of their respective contracts.

Emerald Forest Utility District (6.262 acres)

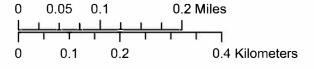

<u>SPECIFIC EXPLANATION</u>: Emerald Forest Utility District (the "District") was created through an act of the Texas Legislature in 1971, and currently consists of 809.2436 acres within Harris County. The District is within the extraterritorial jurisdiction of the City of Houston (the "City") and has petitioned the City for consent to add 6.262 acres of vacant land, proposed to be developed as multi-family residential property, to the District. The proposed annexation tract is located in the vicinity of Woodedge Drive, Jones Road, Cypress North Houston Road, and Perry Road. The addition of land to the District does not release it from the City's extraterritorial jurisdiction.

The Utility District Review Committee has evaluated the application with respect to wastewater collection and treatment, potable water distribution, storm water conveyance, and other public services.

The District has a wastewater collection system and treatment facility. The annexation tract will be provided with wastewater treatment by the Emerald Forest Utility District Wastewater Treatment Facility. Potable water is provided by the District.

The nearest major drainage facility for Emerald Forest Utility District is Greens Bayou, which flows into the Houston Ship Channel. The proposed annexation tract is not within the 100 or 500 year floodplain.

By executing the Petition for Consent, the District has acknowledged that all plans for the construction of water conveyance, wastewater collection, and storm water collection systems within the District must be approved by the City prior to their construction.

The Utility District Review Committee recommends that the subject petition be approved.

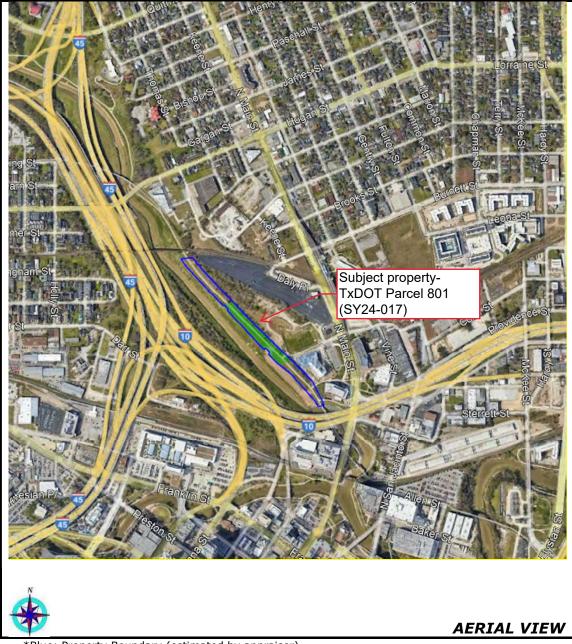

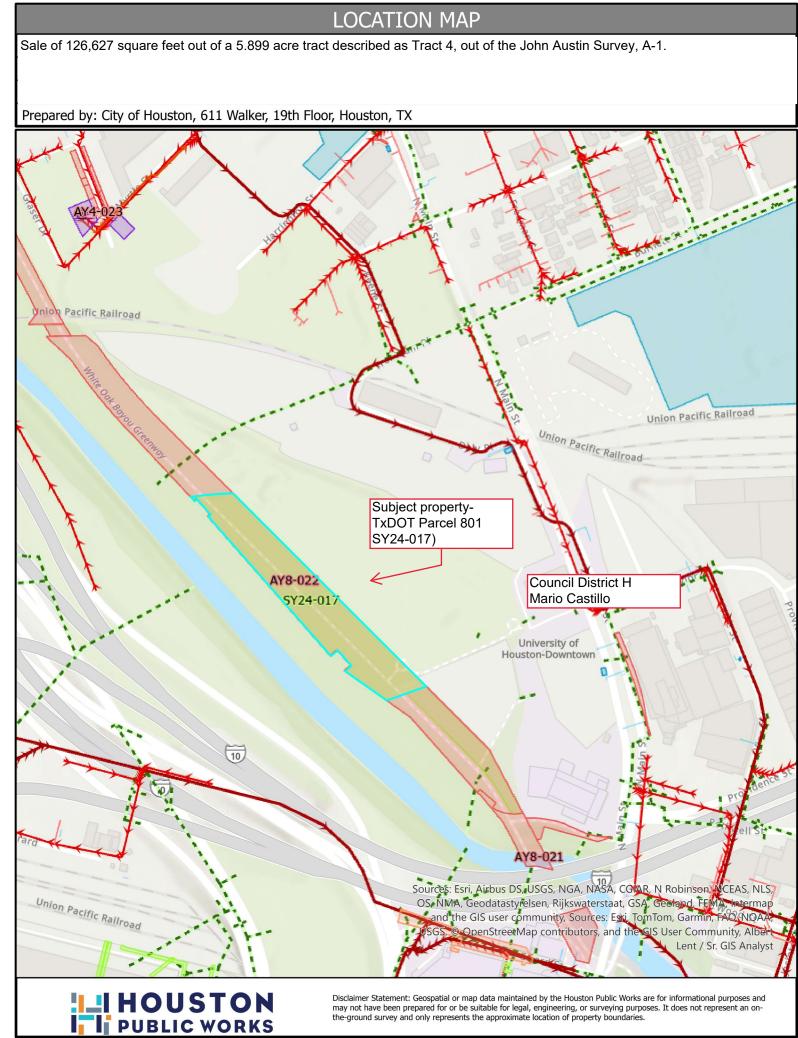

MYR - Special disaster posting - Derecho storm - May 16, 2024

Summary:

ORDINANCE authorizing the Mayor of Houston to extend or continue a proclamation of a local state of disaster for the City of Houston beyond the seven-day period after the proclamation period began due to the severe derecho storm; making certain findings related thereto; and declaring an emergency.

Background:

The City's Emergency Management Coordinator recommends City Council approve an ordinance to authorize the extension of the local state of disaster proclamation that Mayor Whitmire issued on May 17, 2024, in response to the imminent threat to the people and communities of Houston resulting from the severe weather and a derecho storm that resulted in tornadoes, hurricane-force winds, property damage, a tremendous amount of debris, due in part, to numerous downed trees, and prolonged power outages.

Chapter 418 of the Texas Government Code establishes a coordinated system for local disaster responses that ties into State and federal disaster programs. To effectuate an immediate response effort, the presiding officers of local political subdivisions are authorized to declare a local disaster by proclamation. However, Chapter 418 of the Texas Government Code requires action by the governing body for the declaration of a local state of disaster to extend more than seven days. The proposed ordinance would accomplish that purpose by extending the declaration for 12 months, while empowering the City to continue to take actions and emergency measures in support of the City's and Houstonians' response to and recovery from last week's unexpected and severe derecho storm.

Fiscal Note: There is no impact to the fiscal budget or no additional spending authority. Therefore, no Fiscal Note is required as stated in the Financial Policies.
