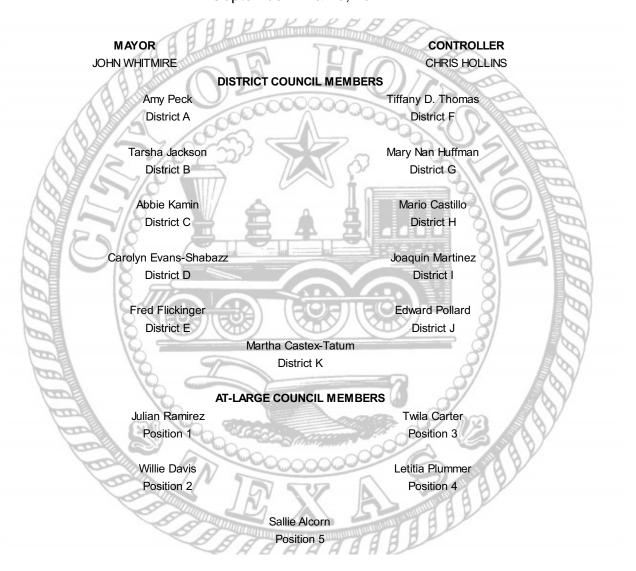

Background:

RECOMMENDATION: The General Services Department recommends approval of the final contract amount of \$354,982.39 and acceptance of work on the contract with DNB Enterprises, Inc., for Underground Storage Tank Removal (UST), Remediation, and Installation at Fire Station 82 – 4.20% below the original contract amount - **DISTRICT K – MARTHA CASTEX-TATUM**

SPECIFIC EXPLANATION: On May 31, 2023, by Ordinance No. 2023-383 City Council awarded a construction contract to DNB Enterprises, Inc., for the Underground Storage Tank Removal, Remediation, and Installation at Fire Station 82. The General Services Department recommends that City Council approve the final contract amount of \$354,982.39 or 4.20% below the original contract amount, accept the work and authorize final payment to DNB Enterprises, Inc.

SPECIFIC EXPLANATION:

The Houston Health Department (HHD) requests City Council's approval of a resolution authorizing the issuance of a Letter of Approval (LOA) to B & N Express EMS Inc. pursuant to § 773.0573 of the Texas Health and Safety Code.

During the 83rd Legislative Session, the Texas Legislature and the Governor approved Senate Bill 8 which amended § 773.0573 of the Health and Safety Code to require that a new EMS provider seeking a state EMS license must first obtain a letter of approval from the governing body or commissioners court of the jurisdiction in which the applicant is located and intends to provide EMS services.

Section 773.0573 provides that the governing body or commissioners court may issue an LOA if it is determined that:

On November 1, 2023, Ordinance No. 2023-924 increased the maximum award amount to \$25,759,544.17 and extended the contracts terms from September 30, 2023 to September 30, 2024. This amendment extends the contract terms for (20) twenty contracts to September 30, 2025, and allows for the completion of the RFP process and awarding new contracts.

Five of the twenty-five (25) contracts will not be extended and will expire on September 30, 2024, because one vendor was taken over by one of the other awarded vendors, the department is no longer using three vendors, and one vendor has been awarded a new contract.

The COVID-19 pandemic created a need for local and statewide compensation funding to address unexpected service gaps. These gaps included the need to provide additional supportive services, take on new referrals, deliver incontinent supplies and nutritional supplements, and increase caregiver information services, in-home services, and respite services, to name a few. Increased funding from the Older Americans Acts of 1965 enables contractors to meet the unexpected supportive service's elevated demand.

The program is grant-funded by the Older Americans Act of 1965 (OAA), and HCAAA coordinates supportive services for adults ages 60 and older in Harris County through a direct or community-based services delivery system.

The Houston Health Department (HHD) is partnered with Nurse-Family Partnership (NFP), an evidence-based program developed through randomized controlled trial research. The program offers registered nurse home visits to low-income, unmarried, and teenage pregnant women with no previous live births. Nurses visit the women once to twice monthly during their pregnancy and the first two years of their children's lives. The program teaches positive health-related behaviors, competent care of children, and maternal personal development, including family planning, educational achievement, and economic self-sufficiency.

The Department of Family and Protective Services (DFPS) leverages funds from the Texas Nurse-Family Partnership (TNFP) competitive grant program to award grants to community-based organizations for the implementation and operation of the NFP program. Funding from this grant is cost reimbursement for meeting program objectives and will allow HHD to provide community support through the program's benefits.

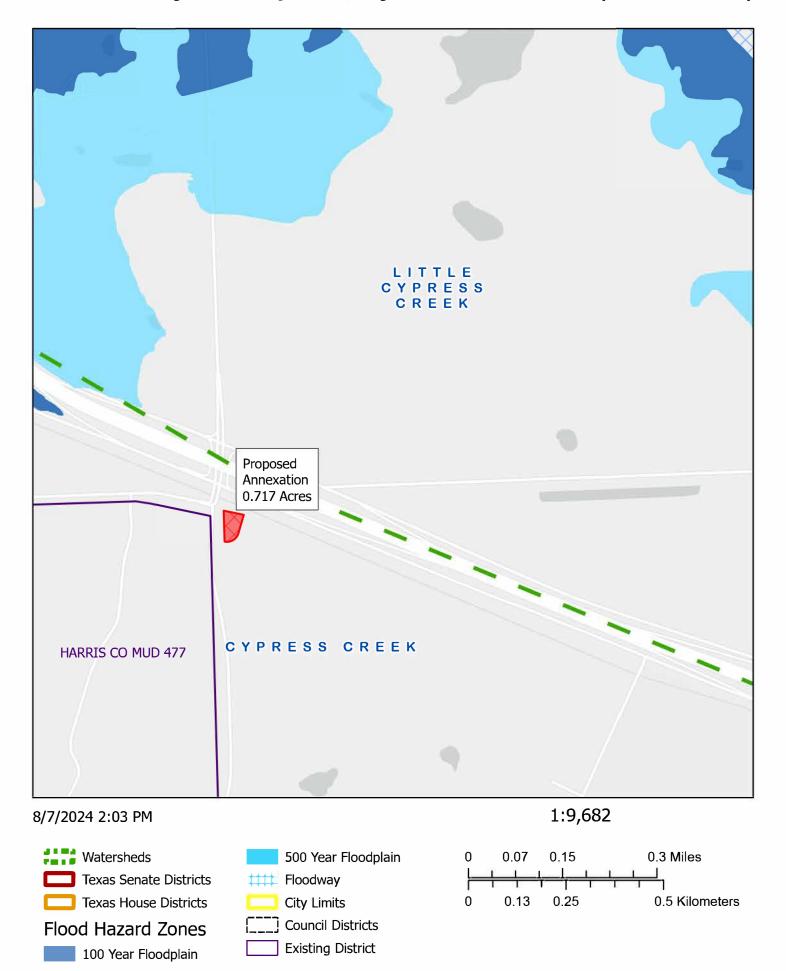

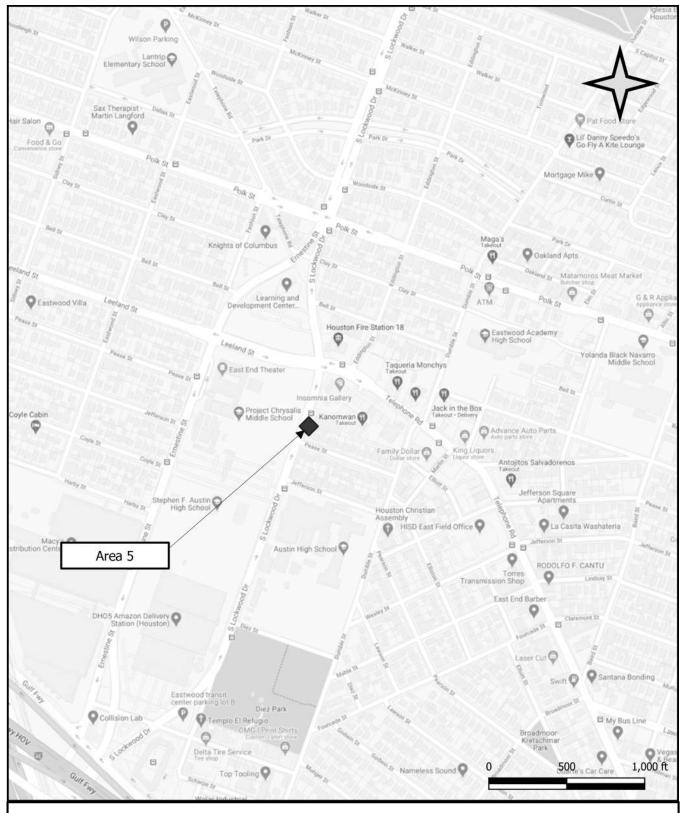

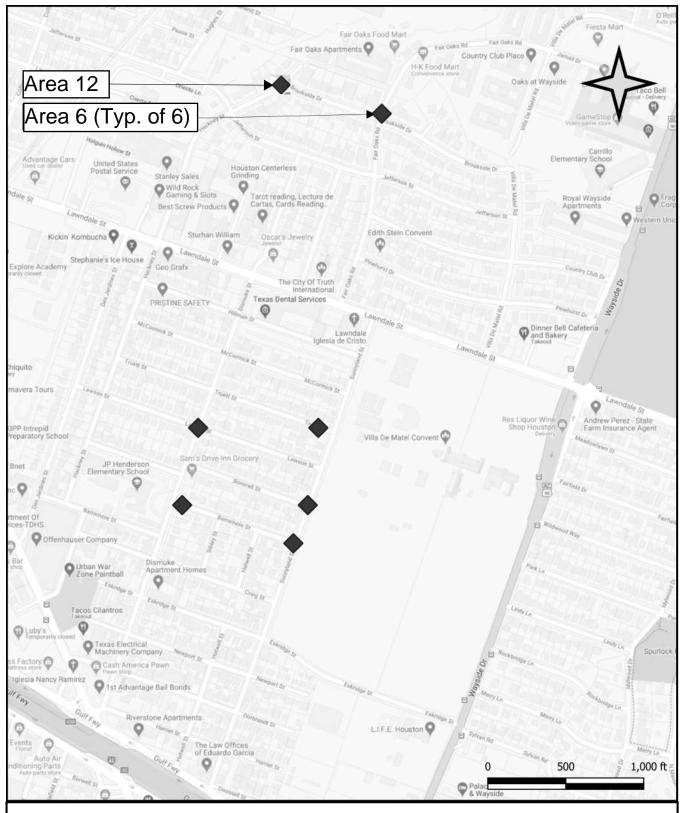

SUBJECT: Contract Award for Westheimer Work Orders for Small Diameter Water Lines.

RECOMMENDATION: (SUMMARY) Reject low bid, return bid bond, award Construction Contract to the second low bidder, Grava LLC for Westheimer Work Orders for Small Diameter Water Lines and appropriate funds.

PROJECT NOTICE/JUSTIFICATION: This project consists of the construction of small diameter waterline extensions at various locations throughout the City of Houston excluding the Central Business District. New small diameter water lines will be built in neighborhoods where the systems are inadequate. It will also provide for the replacement of old, deteriorated substandard, and under capacity small diameter water lines. Replacement and extensions of small diameter lines will be made when requested by Houston Water. Water quality will be improved by using new small diameter water lines and increasing the potable water circulation.

<u>DESCRIPTION/SCOPE:</u> This contract is for construction of small diameter waterline extensions at various locations throughout the City of Houston excluding the Central Business District. The Contract duration for this project is 365 calendar days. This is a work order based contract with work orders assigned on an as-needed basis.

LOCATION: The projects are located throughout the City of Houston.

BIDS: This project was advertised for bidding on June 28, 2024 and July 5, 2024. Bids were received on July 25, 2024. The five (5) bids are as follows:

AWARD: The apparent low bidder, T Construction LLC, was considered non-responsive due to not submitting an acceptable bid. Therefore, it is recommended that this construction contract be awarded to the second low bidder, Grava LLC, with a bid of \$4,000,000.00 (3.25 Adjustment Factor).

PROJECT COST: The total cost of this project is \$4,440,000.00 to be appropriated as follows:

 Early Completion Bonus Allowance 	\$90,000.00

CIP Cost Recovery	\$200,000.00

Testing Services will be provided by ECS Southwest, LLP under a previously approved contract.

Bonus for early completion allowance is \$90,000.00. This represents the number of days between the contract substantial completion date and early completion date, 30 calendar days maximum, multiplied by \$1,000.00 per day for 3 approved locations. The actual amount, if applicable, will be based on the early completion date.

HIRE HOUSTON FIRST: The proposed contract requires compliance with the City's 'Hire Houston First' (HHF) ordinance that promotes economic opportunity for Houston business and supports job creation. In this case Grava LLC is a designated HHF company, but they were the successful awardee without application of the HHF preference.

PAY OR PLAY PROGRAM: The proposed contract requires compliance with the City's 'Pay or Play' ordinance regarding health benefits for employees of City contractors. In this case, the Contractor provides health benefits to eligible employees in compliance with City policy.

Chapter 40 Article XXII. – Sidewalks

Summary:

ORDINANCE amending Sec. 40-553. – Applicability. to remove item (3) as a requirement. Also, to amend Sec. 40-560. Fee-in-lieu of sidewalk construction eligibility; fee established. to remove item "a." under subsection (b) as a requirement.

Background:

This amendment is regarding the "sidewalk to nowhere" issue that many residential developers are facing in the city of Houston. Currently, the city requires sidewalks to be constructed for new-build single-family homes, even if there are no other sidewalks on the street to connect the sidewalk to. Moreover, currently the city can waive the requirement to construct the sidewalk if the developer pays a fee. This amendment aims to remove the mandatory sidewalk construction requirement for new single-family residential developments, thereby eliminating both the construction requirement and the fee-in-lieu option.

Sec. 40-553. Applicability.

- (a) Except as provided in subsection (b) of this section, any person or entity seeking approval for a building permit, certificate of occupancy, or other construction permit or approval required by this Code for any of the following activities must first obtain approval of a sidewalk plan in accordance with this article:
- (3) Construction of a new single-family residential use other than a secondary dwelling unit;

Sec. 40-560. Fee-in-lieu of sidewalk construction eligibility; fee established.

- (a) The planning official and sidewalk committee may waive the sidewalk construction requirement only in accordance with this section. An applicant must file a sidewalk plan with the department and pay the application fee for the plan review and fee-in-lieu determination.
- (b) An applicant may request approval to pay a fee-in-lieu of sidewalk construction when either:
- (1) The planning official determines the activity listed under section 40-553 meets the following conditions:
- a. Construction of a new single-family residential use, other than a secondary dwelling unit;
