

Background:

<u>SUBJECT</u>: Adopt an Ordinance approving an Additional Appropriation for Change Order No. 5 for Lift Station Renewal and Replacement.

RECOMMENDATION: (SUMMARY) Adopt an Ordinance approving an Additional Appropriation of \$2,244,209.21 for Lift Station Renewal and Replacement.

PROJECT NOTICE/JUSTIFICATION: This project is part of the City's ongoing program to upgrade its wastewater lift station facilities.

The work to be performed under this contract award is necessary to maintain compliance with Houston's wastewater consent decree with EPA and TCEQ.

DESCRIPTION/SCOPE: The project included the replacement of the Magnet Lift Station and the rehabilitation of Westpark No.1 and Macgregor Way North Lift Stations. The rehabilitation includes site work, pumps, piping valves, support, instrumentation, and electrical improvements. The Project was awarded to Industrial TX Corp. with an original Contract Amount of \$21,029,950.00.

ADDITIONAL APPROPRIATION: An approval is requested for an additional appropriation of

\$2,137,342.10 in excess of the original contract value and an extension of 284 days of contract time for additional work described in Change Order No.5:

Increase bypass pumping capacity from 46 MGD to 55 MGD. Level Radar relocation and change the Model. Modify the pump and motor levels grating inside the dry well at MacGregor Lift Station. Increase cash allowance for CenterPoint Energy. Furnished and install pump local disconnect. Replace ground level handrail MacGregor and drain lines. Architectural. Supply and install exhaust fan platform for Way North maintenance. Remove existing suction elbow and install new suction elbow in wet well. Change the bypass pumping system discharge location. Supply and install new valve vault covers. Modification to the flow control structure gate actuators. Wet well walls repair. Add check valves support. Field work related to control panel changes. Procure and install float switches.

Magnet Procure and install float switches.

Westpark No.1 Furnished and install pump local disconnect. Field work related to control panel changes. Procure and install float switches.

The requested appropriation will cover the additional work identified.

The total requested appropriation is \$2,244,209.21 to be appropriated as follows: \$2,137,342.10 for contract services and \$106,867.11 for CIP Cost Recovery.

HIRE HOUSTON FIRST: The proposed contract requires compliance with the City's Hire Houston First (HHF) ordinance that promotes economic opportunity for Houston business and supports job creation. In this case, Industrial TX Corp. is a designated HHF company, but they were the successful awardee without the application of the HHF preference.

PAY OR PLAY PROGRAM: The proposed contract requires compliance with the City's 'Pay or Play' ordinance regarding health benefits for employees of City contractors. In this case, the Contractor provides benefits for some employees but will pay into the Contractor Responsibility Fund for others, in compliance with City policy.

M/WBE PARTICIPATION: The M/WBE goal established for this project is 11.00% MBE goal and 7.00% WBE goal. The original Contract amount and subsequent appropriations total \$21,029,950.00. The Contractor has been paid \$19,503,354.15 (92.74%) to date. Of this amount, \$4,584,994.82 (23.51%) has been paid to M/WBE sub-contractors to date. Assuming approval of the requested additional appropriation, the contract amount will increase to \$23,167,292.10. The MWBE goal has been previously met.

FISCAL NOTE: No significant Fiscal Operating impact is anticipated as a result of this project.

The project performance period is from September 1, 2025, to August 31, 2027, for a total award amount of \$595,400.00.

The purpose of this agreement is to provide local public health services to improve or strengthen local public health within the State of Texas, to accomplish this, the activities HHD will conduct under this agreement include, but are not limited to the following:

- Maintain Houston State of Health Data Portal that houses more than 300 population health indicators for the Houston area including City of Houston and Harris County. (Houstonstateofhealth.com)
- Conduct statistical and spatial analyses using various primary and secondary datasets to identify neighborhood and ZIP codes as priority areas for interventions.
- Conduct Community Health Assessment (CHA) periodically in various neighborhoods for informing programs
- Collaborate with academia and stakeholders to evaluate select programs to examine their effectiveness and outcome/impact.
- Conduct monthly Public Health 101 and public health data 101 sessions to new employees and those who do not have formal public health training.

Humble ISD owns all the land that is the subject of this petition. Humble ISD's planned development in and around the Annexation Area includes a new location for Ross Sterling Middle School, which will replace its current location on Wilson Road, and the extension of the existing school sports facilities. The Annexation Area is also adjacent to Humble ISD's Lakeland Elementary School. There are no other planned improvements to this Humble ISD-owned property in the ETJ release area. This Humble ISD tract in this petition request is currently in the City of Houston's ETJ while the rest of the school tract is in the City of Humble.

This jurisdictional division causes numerous points of duplication and confusion in the policing of school campus and the provision of other municipal services to the Humble ISD's property. Besides that, improvements to Humble ISD's facilities will require review and approval by both cities, Houston and Humble, causing duplication of work and delay to Humble ISD's projects to allow both municipal processes to complete. Such a release will not impair the City's ability to annex any other territory in the vicinity. This release will also not impair mobility in the City of Houston or in the ETJ.



SPECIFIC EXPLANATION:

The FY2026-2030 Capital Improvement Plan (CIP) supports improved delivery of services and an improved quality of living for Houstonians, with an emphasis on drainage, transportation infrastructure, mobility, quality of life, affordable housing and public safety. The plan emphasizes the replacement and rehabilitation of existing facilities and the selective addition and expansion of facilities.

The FY2026-2030 CIP book contains vertical construction projects supported by the General Services Department for its clients (Fire, Health, Library, Parks, Police and Solid Waste), projects supported by Houston Public Works (Street & Traffic, Storm Drainage, Water and Wastewater) and the Houston Airport System. In addition, Information Technology, Fleet, and Component Units citywide capital programs are included.

The FY2026-2030 CIP calls for appropriations of approximately \$16.7 billion during the five-year period. Planned appropriations for the Public Improvement & Citywide Capital Programs total approximately \$913 million, Component Unit Programs \$ 2.4 billion and \$13.4 billion for the Enterprise Programs.

Proposition A Council Member Item: Evening Public Session

Summary: ORDINANCE to allow evening Public Session hearings once a month.

Background: Currently, for the public to give input to their local government, they must come to City Council chambers on Tuesday afternoons. To improve access for residents who are unable to attend daytime Public Session hearings, these sessions need to be held in the evening.

Specific Explanation: This Ordinance is to allow the Public Session to occur in the evening at city council chambers the final scheduled hearing of each month at 6 pm instead of 2 pm.

Proposal:

Section 2-2

Rule 1 (a) shall be replaced with the following:

The city council shall conduct its regular weekly meeting in two daily sessions commencing at 1:30 p.m. on Tuesday and at 9:00 a.m. on Wednesday, respectively, of each calendar week. Each session shall be conducted in the city council chamber unless another place in the City Hall is designated by the city council. The final Tuesday session of each month shall take place at 5:30 p.m. Meetings shall recess at the times provided in Rule 7 and shall be subject to recess at other times as provided in subsection c, below. No notice shall be required to be given to any member of any recessed meeting. In the event that Tuesday or Wednesday, or both, of any calendar week falls on a holiday observed by the closure of city offices, then the regular weekly meeting sessions shall be rescheduled or consolidated as determined by the city council. The city council may consolidate daily sessions or reschedule any weekly meeting or daily session the same calendar week and may for valid reasons postpone any regular weekly meeting or daily session to another week.

Rule 8 (a) shall be replaced with the following:

Any citizen of the city shall have a reasonable opportunity to be heard at all regular and special meetings of the city council in regard to any and all matters to be considered at such meetings that are germane and relevant to any subject matter of city affairs or business that is within the scope of the authority and legislative functions of the city council. Such appearances by members of the public shall be scheduled to begin at 2:00 p.m. at the Tuesday session of the regular meetings of city council. The last Tuesday session of each month shall be scheduled for 6:00 p.m. The mayor, mayor pro tem, or other presiding officer shall at all times be responsible for conducting the meeting and maintaining proper order and decorum. Any council member shall have the privilege of raising a point of order as to whether the subject matter to be heard and considered as presented by a citizen is germane and relevant to any subject matter of city affairs or business that is to be considered by city council.

Requests to appear shall be made to the office of the city secretary, and may be made in person or by mail, email, fax, or telephone, provided that the request is received before the scheduled time of commencement of the city council meeting session at which public appearances will be heard. Each speaker shall provide his or her name, street address, mailing address (if different), telephone number, and a brief description (not to exceed ten words) of the intended subject matter of the citizen's remarks. The speaker's street address, mailing address (if different), and telephone number is for internal, administrative use only by city council, the city secretary's office, and city departments, and shall not be disclosed publicly, except as required by law. Speakers who have not appeared at any of the four preceding regular city council meetings shall also state whether they wish to limit their remarks to one, two or three minutes.
