

HCD conducted a Notice of Funding Availability (NOFA) for HOPWA services in September 2022 with the option to renew in up to a one-year increment at the City's discretion. Catholic Charities was one of the selected agencies.

This Agreement began June 1, 2023 and the First Amendment extended the Agreement through July 31, 2025. This Second Amendment will extend the Agreement period and provide funding through September 30, 2025, to avoid service interruption while the 2025 NOFA process is complete.

As of March 2025, Catholic Charities has expended approximately 84% of their allocated funding and served 102% of their client goal. Catholic Charities has received funding through various Agreements with the City since 2003 and had no findings on their last compliance monitoring review.

HCD conducted a Notice of Funding Availability (NOFA) for HOPWA services in September 2022 with the option to renew in up to a one-year increment at the City's discretion. Catholic Charities was one of the selected agencies.

This Agreement began June 1, 2023 and the First Amendment extended the Agreement through July 31, 2025. This Second Amendment will extend the Agreement period and provide funding through September 30, 2025, to avoid service interruption while the 2025 NOFA process is complete.

As of March 2025, Catholic Charities has expended approximately 84% of their allocated funding and served 102% of their client goal. Catholic Charities has received funding through various Agreements with the City since 2003 and had no findings on their last compliance monitoring review.

**RECOMMENDATION:** Adopt an ordinance approving and authorizing the first amended and restated interlocal agreement between the City of Houston, Harris County, Reinvestment Zone No. 3 and the Downtown Redevelopment Authority to provide for the participation of the County in the TIRZ for the purpose of funding capital projects and the maintenance for the capital projects as provided by Chapter 311 of the Texas Tax Code.

### **SPECIFIC EXPLANATION:**

The City Council approved the Tax Increment Reinvestment Zone No. 3 ("Zone") on December 13, 1995, and the Downtown Redevelopment Authority on June 30, 1999, to aid in the administration of the Zone and the implementation of the Reinvestment Zone Financing and Project Plan.

Section 311.002 of the Texas Tax Code describes a taxing unit as "a county, an incorporated city or town (including a home-rule city), a school district, a special district or authority (including a junior college district, a hospital district)... that is authorized to impose and is imposing ad valorem taxes on property even if the governing body of another political unit determines the tax rate for the unit or otherwise governs its affairs."

On April 4, 2001, by ordinance 2001-301, the City Council approved an Interlocal Agreement ("ILA") with Harris County for Harris County to participate as a taxing unit in TIRZ No. 3. The City Council approved an amendment to the ILA on September 9, 2005 by ordinance 2005-1052. The Harris County

Commissioner's Court approved the amended and restated ILA on July 10, 2025. The ILA provides that Harris County, Precinct 1, will participate at 100% of the funds actually collected with respect to the Captured Appraised Value from the County's total ad valorem tax rate (less the portion of the County's tax rate levied for debt service, and not including any taxes levied by the County on behalf of the Harris County Flood Control District, Harris County Hospital District, Port of Houston Authority, or similar entities). The ILA further provides that up to 33% of the participation rate will be used to provide affordable housing and up to 10% of the participation rate will be retained by Harris County to the maintenance and operations of facilities and projects related to the project plan. Additionally, 10% will be retained by the City of Houston.

The term of the ILA begins with the countersignature of the City Controller and terminates tax year 2042. The first tax increment payment from the County will be made August 31, 2026.

The Director of Mayor's Office of Public Safety and Homeland Security (the "Director") recommend that City Council approve an amending ordinance relating to the FY2024 Homeland Security Grant Program to clarify the amount of the grant award received by the City and the City's responsibility for returning funds to Texas Office of the Governor in certain circumstances. On November 24, 2024, by Ordinance No. 2024-891, City Council authorized the Director to apply for, accept and execute sub-award agreements and to request and/or accept any amendments/modifications to these agreements or any subsequent agreements necessary to secure Houston's allocations through this grant program (not to exceed five years).

The U.S. Department of Homeland Security provides grants to enhance the capacity of state and local governments to prevent, protect, respond to, migrate against, and recover from acts of terrorism. The Homeland Security Grant Program includes both the Urban Area Security Initiative (UASI) and State Homeland Security Grant Program (SHSP). The UASI program specifically addresses the unique needs of high-risk urban areas with funding to develop an enhanced and sustainable capacity to prevent, protect against, respond to and recover from threats or acts of terrorism. In Texas, the agency that manages and administers these programs is the Texas Office of the Governor, Homeland Security Grants Division.

The U.S. Department of Homeland Security awarded the City the following grant amounts:

- UASI (\$10,099,118.93) Funds are requested for planning, organization, equipment, training, and exercises. There are 19 projects requested by the City of Houston for this program. The largest projects requested include:
- \$1,486,232.00 for the sustainment and enhancement of the regional radio system;
- \$1,400,000.00 for the Public Safety Video Initiative;
- \$1,293,749.00 for sustainment and enhancements to the Houston Regional Intelligence Service Center, our region's

fusion center; and

- \$1,170,000.00 for Law Enforcement Sustainment and Enhancements for HPD
- SHSP (\$363,246.00) There are three (3) sub-awards allocated to the City of Houston for this program. These funds are

allocated to sustain planning support for the Regional Catastrophic Preparedness Initiative, equipment support for the Houston Police Department's Bomb Squad and training for Special Response Teams.








7.869 Acre Tract J Annexation Vicinity Map Exhibit No 4





**SPECIFIC EXPLANATION:** The City of Houston (Houston) acquired the 60.891 acre tract by deed in 1954 for the Southwest Wastewater Treatment Plant site. Houston Public Works - Houston Water - Drinking Water Operations (DWO) owns and operates the Southwest Wastewater Treatment Plant (Southwest WWTP) located at 4211 Beechnut Street, Houston, Texas 77096. DWO determined that the three tracts (Parcels SY24-044A, SY24-044B,

and SY24-044C) that are outside the boundary of the Southwest WWTP were surplus to its needs and transferred the three tracts to Houston Public Works - Transportation and Drainage Operations (TDO). TDO has declared the three tracts as surplus to its needs and determined that the tracts may be sold to the City of Bellaire. The City of Bellaire (Bellaire) is the owner of a 76.084 acre tract of land located at 9720 Ruffino Road, Houston, Texas 77031, and a wastewater treatment plant located at 4401 Edith Street, Bellaire, Texas 77401.

Houston desires to acquire the property located at 9720 Ruffino Road from Bellaire for the expansion of a regional stormwater detention project to help mitigate flooding in Houston. In 2022, Houston acquired a 73.081 acre tract from the City of West University Place adjacent to LY23-014 for the Ruffino Hills Detention Pond site under WBS M-430296-0019-2. The two contiguous tracts of land will contain approximately 149.165 acres. Bellaire desires to acquire Parcels SY24-044A, SY24-044B, and SY24-044C, for a regional stormwater detention project to help mitigate flooding in Bellaire and the Gulfton area of Houston. Bellaire desires to send its wastewater flows to the Southwest WWTP for treatment by Houston for the purpose of redeveloping the existing Bellaire WWTP site for the regional stormwater. Houston is willing to accept Bellaire's wastewater flows for treatment at the Southwest WWTP under the terms and conditions set forth in a Sanitary Service Agreement to be executed at the closing of the real property. Bellaire will be given a credit of \$5,140,000.00 against the impact fees owed under the Agreement.






