### City Council Chamber, City Hall, Tuesday, March 7, 2017

A regular meeting of the Houston City Council was held at 1:30 p.m., Tuesday, March 7, 2017; Mayor Sylvester Turner presiding, with Council Members Brenda Stardig, Ellen Cohen, Dwight Boykins, Steve Le, Greg Travis, Karla Cisneros, Robert Gallegos, Mike Laster, Mike Knox, David Robinson, Michael Kubosh, Amanda Edwards and Jack Christie D.C.; Randy Zamora, Legal Department; Marta Crinejo Agenda Director and Stella Ortega Agenda Office present. Council Member Dave Martin out of the city on city business. Council Member Jerry Davis absent due to being ill. Council Member Larry Green absent on vacation.

At 1:38 p.m. Mayor Turner called the meeting to order and stated that Council would start with presentations. Council Members Stardig, Boykins, Le, Travis, Cisneros, Laster, Green and Kubosh absent.

Council Member Knox stated that Lidya K. Osachy has been a proud Houstonian for 39 years, and a naturalized citizen of the United States since 1984, born and educated in Moscow, her families quest for religious freedom landed them in Houston where she continued her education, first at Rice University and later at the University of Houston achieving a graduate degree and today, she is the Founding Executive Director of the Holocaust Museum Houston and the CEO of the ESCAPE Family Resource Center, which educates families in crisis to prevent child abuse and neglect, and to build skills in parents and children to ensure a safe and nurturing family life and under Lidya K. Osachy's 17 years of leadership, ESCAPE has increased their number of programs, clients, program sites, community collaborations, and curricula and programs. She has also mentored and coached hundreds of emerging leaders in the Houston community and beyond, facilitated interreligious dialogues in commemoration of the Dr. Martin Luther King's birthday, and launched Holocaust education in all Catholic schools of Houston-Galveston in collaboration with Archbishop Fiorenza and the Roman Catholic Archdiocese of Galveston-Houston and sits on several boards and has a lengthy list of achievements, Texas Non-Profit Council and the Behavioral Health Advisory Committee of the Texas Health and she is also an American Leadership Forum Fellow, a graduate of the FBI Citizens Academy, a certified mediator with the Dispute Resolution Center and an advanced certified Birkman International consultant, she is the proud mother of three children and two granddaughters and on March 7, 2017, Lidya K. Osachy will be recognized for her overall embodies resilience and determination which has led to her success and the City of Houston commends and congratulates Lidva K. Osachy on this momentous occasion as she is truly an inspiration, proving that our triumphs can overpower our tribulations, therefore, Mayor Turner hereby proclaimed March 7, 2017, as Lidya K. Osadchey Day in Houston, Texas. Council Members Stardig, Boykins, Le, Travis and Laster absent.

Council Member Edwards stated that every March during American Red Cross Month, citizens across the United States take time to recognize and thank our everyday heroes, those who volunteer their time to reach out to people in need and the American Red Cross heroes perform many roles, such as helping victims recover from disasters, brightening the days of military families and veterans, driving the elderly and chronically ill to critical medical appointments and teaching life-saving CPR and AED classes; our community depends on the American Red Cross employees and volunteers who continue to offer their assistance and comfort to those in need, giving their time and various donations despite challenging economic times and in March 2017, the American Red Cross will celebrate American Red Cross Month, a time to recognize and thank our heroes – those who volunteer, take life-saving courses or provide financial

Council Member Cohen stated that Priscilla T. Graham is an American Documentary Photo Evangelist, Author and Speaker who specializes in Historical Photo Book of Buildings, settlements, neighborhoods and places that have been forgot in history and her passion is story telling through the lens of the camera, capturing timeless moments of life and after her military service in Texas and graduating from Texas Southern University, she attended a Juvenile Justice Conference in Austin Texas which she was inspired greatly by Congresswoman Shelia Jackson-Lee that was speaking there, she was compelled to practice more rewarding and personally satisfying servant leadership and became the Social Media Manager for Freeman's Town Preservation Coalition and took many pictures during the effort to save the brick streets and because of that she was able to release her book called the 150 Years Standing Strong, a collection of Church histories, places and people that illustrated their origin and connection with Historic Freedman's Town in the Historical 4<sup>th</sup> Ward and she will be honored for her outstanding contributions to our community and the City of Houston commends Priscilla T. Graham for her commitment for educating and inspiring the community through her book and extends best wishes for continued success and therefore, Mayor Turner hereby proclaimed March 7, 2017 as Priscilla T. Graham Day in Houston, Texas.

Council Member Robinson stated that Houston suffers from a very high rate of debilitating obesity and the chronic diseases it causes. Research shows that the best way to embrace a healthier lifestyle is to boost consumption of fresh vegetables, the Recipe for Success Foundation is dedicated to improving the health of Houstonians by changing the way we understand, appreciate and eat our food. The Recipe for Success Foundation created the VegOut! Challenge to encourage Houstonians to eat more vegetables, thousands of Houstonians, including the Mayor and City Council, took the VegOut! Challenge in March 2016 and throughout the month of March 2017, Houstonians are once again invited to take part in the VegOut! Challenge with Recipe for Success by eating 30 different vegetables within 30 days and the Recipe for Success Foundation strives to motivate every single Houstonian to take the VegOut! Challenge in March 2017 and the City of Houston commends the Recipe for Success Foundation for inspiring Houstonians to eat healthy every day through their VegOut! Challenge in March and their many other healthy eating initiatives and advocacy taking place throughout the city, including the Seed-to-Plate Nutrition Education<sup>™</sup> program in schools, Hope Farms<sup>™</sup>, Farmers MarKIDS and RecipeHouse and therefore, Mayor Turner hereby proclaimed March 2017 as VegOut! with Recipe for Success Month in Houston, Texas. Council Members Boykins and Knox absent.

At 2:23 p.m. Mayor Turner recognized Council Member Gallegos for the invocation and the Pledge of Allegiance. Council Member Boykins absent.

At 2:24 p.m. the Roll was called. Council Member Green absent. Council Member Dave Martin out of the city on city business. Council Member Jerry Davis absent due to being ill. Council Member Larry Green absent on vacation.

Council Member Kubosh moved to delay the adoption of the minutes of the last 2 meetings and to approve the minutes of 2/28-3/1, 2017 seconded by Council Member Knox, all voting aye, nays none. Council Members Boykins and Gallegos absent. **MOTION ADOPTED** 

Mayor Turner recognized Council Member Kubosh for a procedural motion, Council Member Kubosh move that the rules be suspended for the purpose of hearing Ms. Jane West, Mr. Michael Huffmaster and Ms. Tomaro Bell out of order and seconded by Council Member Robinson, all voting aye, nays none. Council Members Boykins, Travis and Gallegos absent. **MOTION 2017-0133 ADOPTED** 

Mayor Turner recognized Council Member Cisneros for a procedural motion, Council Member Cisneros moved that the rules be suspended for the purpose to hear Mr. John Branch out of order and seconded by Council Member Kubosh, all voting aye, nays none. Council Members Boykins, Travis and Gallegos absent. **MOTION 2017-0132 ADOPTED** 

At 2:27 p.m. Mayor Turner requested the City Secretary to call the List of Speakers.

Ms. Jane West, 2114 Lubbock St., 77007, (832)721-9080 appeared and stated that she was present to speak on to the Chapter 33 Amendments and the Master Bicycle Plan and they been coming here with concerns on the way it was drafted and the way the Amendments to Chapter 33 had been drafted and they are largely here today in support of the Plan and in support of the changes to Chapter 33 and they had 3 major issues that they were concerned about and will speak on one of the issues and the following speakers after her will speak on the others; their biggest issue was the Public Engagement that the maps on the Plan would be regulatory and that would be like blue prints to a house and since then the maps have been amended and there are suggests where the bike lanes are going to go but would not be built without additional and substantive Public engagement, the District Council Members and the Neighborhoods, it is important that the Super Neighborhoods and Neighborhoods, the Civic Clubs and the Stakeholders get to have a say on how the Bike Plan is implemented. Council Members Cohen, Boykins, Travis and Laster absent.

Members of Council questioned Ms. West at length.

Mr. Michael Huffmaster, 1202 Cove Creek Ln., 77042, (281)734-8172 appeared and stated that he stands to represent the Super Neighborhood Alliance and he would like to add a provision of an Ordinance for Public Engagement and they would like to see a timeline and that movement toward law to move forward and they think that is important because it puts in place a law and not policy, the finance issues with the respect to the Bike Plan are of concern, there are many issue in the future that will have to be dealt with preservations in the Plan in Chapter 33 to do so and he has a concern against a diversion of Rebuild Houston Funds into the construction of the Bike Lanes, they took the Bayou Green Way initiative in the City of Houston pass a 100 million dollar bond vote and that with another 100 million dollars and the citizen approved that and they suggest the finance for the Bike Facilities to be taken on a similar basis and not to take from the General Fund and certainly not the Drainage Fund. Mayor Turner, Council Members Travis, Laster and Edwards absent. Mayor Pro Tem Cohen presiding.

Members of Council questioned Mr. Huffmaster.

Ms. Tomaro Bell, 3248 Charleston St., 77021, (713)825-8449 appeared and stated that she came while that the Super Neighborhoods is supporting the Bike Plan she was present to speak about the Public Safety issue, the current bike connector that they are building is just another line in a road connecting the bike lane to traffic and the Bike Plan as they look at it currently on the street paths that they are talking about, 90% of them like what they are currently like a bus lane and buses do alleviate congestion and it is not safe to have a bus and bike lane in the same path, this is supposed to be like high comfort and safety and that is not what she is seeing and if they look at what it would take to build the lanes she was like the previous speaker, she

was a cheerleader for Bayou Greenway but now barely a year later if they have not stopped it in 2016, they want to put it on the streets, public safety is very important and when they look at the cost on what they wanted before, they would not be able to afford it, not when they are asking the citizens to release the rev cap, she gave the reasons why this would work because the math does not add up and she is asking them to please look at it. Mayor Turner, Council Members Travis and Laster absent. Mayor Pro Tem Cohen presiding.

Members of Council questioned Ms. Bell.

Ms. Regina Garcia, 2425 University Blvd., 77005, no phone, appeared and stated that she is Chair of Bike Houston, she rides her bike everyday and she thinks that they need to come up with a way for families to go outside and enjoy this beautiful city and that is what this Bike Plan is going to do and this is a big change in culturel for this city. Mayor Turner, Council Members Travis absent. Mayor Pro Tem Cohen presiding.

Ms. Catherine Villarreal, 300 North Post Oak Ln., 77024, (713)942-8500 appeared and stated that she is the Director of Communications as the Non-Profit Parks Board, they are contributing member of the development funding for the Bike Plan and they review the plan several times and they hope to share with them that it will help address, the health, safety and connectivity improvements that this city needs. Mayor Turner, Council Members Boykins and Travis absent. Mayor Pro Tem Cohen presiding.

Ms. Shelley Kennedy, no address, (713)822-7688 appeared and stated that she was a Board Member of Bike Houston and she wanted to speak about the bicycle article, they rated all 50 cities for best bicycling cities, New York is rated as Number 4, LA is rated as 24, Chicago is rated as Number 1 and the City of Houston is not rated at all and that means they are far off the curb. Mayor Turner, Council Member Travis absent. Mayor Pro Tem Cohen presiding.

Members of Council questioned Ms. Kennedy.

Ms. Nabiha Hossain, no address, (281)986-7981 appeared and stated that she was Bike Houston first intern and she did some field research on the necessary on cycling as a means of transportation and cycling was her form of transportation and the passing of Houston Bike Plan will give them more passage to get around Houston. Mayor Turner, Council Members Boykins, Travis, Gallegos and Laster absent. Mayor Pro Tem Cohen presiding.

Mr. Miles Wilson, 2023 Huldy St., 77019, no phone, appeared and stated that yesterday his grandfather had passed away because he had a lot of health issues which that made them reevaluate their life and he personally not in the best shape and he take a lot of pride in biking and he is constantly biking towards work but it is not safe and passing this Bike Plan will be promoting a safer environment and a healthier life style. Council Members Boykins, Travis, Gallegos and Laster absent.

Ms. Heidi Saul, no address, (713)373-1780 appeared and stated that she had been a cyclist for the past 14 years and in those years she had enjoyed being advocate for cycling and cycling safety in communities, she was the riding Marshall in the MS150 for the past 9 years and she is requesting and pleading them to think of safer roads for cyclist that come from the suburbs area to the Downtown area, they love their bikes and would like to ride them more often. . Council Members Boykins, Travis, Laster and Knox absent.

Mr. Bill Mintz, no address, (713)392-3406 had reserved time to speak but was not present when his name was called. Council Members Boykins, Travis, Laster, Green and Knox absent.

Mr. Veon McReynolds, 2305 Wheeler Ave., 77004, (713)899-1961 appeared and stated that he has a program called Tour De Hood and maybe some of the Council Members have heard about that, they supply the bike helmets for people to get out and ride, they get novice riders out on the streets and they ride most of the street in Houston, he thinks that people need more education to actually get out on the bike and to go out and see what is on the ground, experience it and do it more than one time because there is a lot to see when you are outside bicycling. Council Members Boykins, Travis, Laster and Knox absent.

Mr. Evan O'Neil, 1615 Hermann Dr., Apt. No. 1330, 77004, no phone, appeared and stated that he lives in Council Member Boykins District and he is present to speak in support of the Bike Plan, feeling that rush which comes with putting on a helmet and looking death in the face, he does not feel safe or welcomed by biking in the City of Houston and he request that they pass policies to make biking safe to all Houstonians and he believes that the Bike Plan gives a path forward to make biking safer. Council Members Travis, Laster and Knox absent.

Ms. Kristi Maulding, no address, no phone, appeared and stated that she is a Brand Manager at a student bike run shop at Rice University and she is an out of State student along with others and they really do not have a car and as a result of that biking is the way that most of them get around in Houston but currently the bike lanes make it very hard to use because they do not feel safe and she feels that this Bike Plan is important to them to help increase safety. Council Members Stardig, Boykins, Travis, Laster and Knox absent.

Mr. Jake Kushner, 3143 Fairhope St., 77025, (832)668-5209 appeared and stated that he is a Physician and he serves as the Chief of Pediatric Diabetes and Endocrinology at Baylor College of Medicine and Texas Children Hospital and he rides his bike everyday and it had been a big part of his life and the children that he cares for do not have the opportunity like he does and many of them live in neighborhoods where they cannot easily access these green ways, parks and others and the Houston Bike plan is really important to get kids to those areas and he urges Council to support it. Council Members Stardig, Boykins, Travis, Laster and Knox absent.

Mr. Radu Tutos, 1648 Banks St., 77006, (310-993-0770 appeared and stated he is a regular Houstonians that uses his bike as transportation, he has a bike that is built like a tank to take his 3 year old to daycare and to haul a weeks worth of groceries, he rides his bike and it makes him feel healthier, it is a lot more fun than being stuck in traffic and it he feels as if the City was designed with a mandate to defeat people that walk or ride and if they do not change Houston will never attract the kind of talent it needs to be a leader in the 21<sup>st</sup> Century and he requested that they vote yes to the Bike Plan. Council Members Stardig, Boykins, Travis, Laster and Knox absent.

Ms. Rose Mikulski, 5022 Carew St., 77096, (954)914-0117 appeared and stated that she lives in District C and as a Member of Toxic Shocks and she is present to speak in support of the Houston Bike Plan, they have over 1000 members that are passionate about riding in the City, that when her groups meets to bike 10 to 12 miles at a friendly pace which all riders can ride, they cycled last year in the MS150 and their motto was we cycle way more a month compared to critical mass, they encourage Council to pass and to raise awareness for cyclist rights, to facilitate improvements of cycling facilities. Council Members Stardig, Boykins, Travis, Laster and Knox absent.

Ms. Leslie Stratta, 3901 Floyd St. Unit B, 77007, (979)204-6357 appeared and stated that as a woman with family history of heart disease and a volunteer for the American Heart Association, she is here today to enthusiastically support the vote for the Bike Plan, heart disease is the number one cause of death and largely preventable risk factors from physical inactivity and poor

diet and in the Houston area 65% of residents are overweight and 25% report no physical activity in the last month according to the Center for Disease Control. Council Members Stardig, Boykins, Travis, Laster and Knox absent.

Mr. David Dick, 4310 Kingfisher, 77035, (281)782-8743 appeared and stated that he is native Houstonian and been rides his bicycle all around the City his entire life and one of his joys is to take people on bikes to see all the different things there is to see in this City, he was part in the 1993 Comprehensive Bike Way Planning and it was based on ICET funding, the City Council passed 360 miles of bikeways in 1993 and Houston was awarded a bicycle friendly designation by League of American Bicyclists and it was taken away because the City did not follow through the plan and the City ended up with some that were broken up, some were complete some and not complete, this new plan is so important because all of the work that has gone through it created an was interconnected and he was very pleased about all the public input that actually resulted in some changes to improve the current plan and urges everyone to vote for this. Council Members Stardig, Boykins, Travis, Laster and Knox absent.

Mr. Alejandro Perez, 8304 Melrose, 77022, no phone, appeared and stated that he lives in the Northline community and working to build up a voice in the community, trying to advocate items like this that would benefit the community by establishing a Bike Plan and in his area there are 4 schools and he can imagine if the Bike Plan were passed that it would facilitate transportation and for the children that live in the area were able to ride their bikes to school and that is one example that he would see the Bike Plan would alleviate traffic, he rides his bike to school and he also came to speak on the Bike Plan before and he really enjoys riding his bike and that is what he is advocating for to please pass the Bike Plan. Council Members Stardig, Laster, Knox and Kubosh absent.

Mayor Turner requested that Ms. Demtria Smith speak next.

Ms. Demetria Smith, 15155 Richmond St., 77082, (832)671-9712 appeared and stated that she did pay attention to the Mayor's press conference last week in regards to homelessness here in the City and of course they should know that caught her attention because she is an advocate for people that are facing poverty and what she would like him to consider what causes the undocumented people that are homeless that are living on top of each other in like a one bedroom and two bedroom and further more and if he would get with some apartment association, he can get with some of their property owners and she would like to be included in the conversation because she had experienced this first hand and to consider like tenant deferment housing program and what she means by that when the tenant housing when the lender will put the current balance on the back and extend the term and she thinks that something that the City of Houston in collaboration with the apartment association can kind of do because people that are facing evictions because loss of a job or other reasons and that can kind of reduce the homelessness issues when it comes to that source and she would like them to consider a policy, a lot of people legally cannot obtain rental housing right now and they know that a lot of people do not qualify for home mortgages and this is very dear to her and she would like him to do that. Council Members Stardig, Laster, Knox and Kubosh absent.

Mayor Turner stated that he would look into that and that Andy Teas with the Houston Apartment Association was standing right next to him at the press conference and he would see if they can tie all of them together to work together.

Ms. Rose Nolen, no address, no phone, appeared and stated that she is a bike rider, she riders the MS150 and many other funding raising bike rides and she is here representing Cycle Houston and she had led a lot of the projects for Cycle Houston and many people do not know

these children are working on earning for an award for a bike and they put about 10,000 kids on bikes every year and they give them 5 minute lessons on how to ride a bike along with helmets and she tries to create a safe environment for the children. Mayor Turner, Council Members Stardig, Cohen, Laster and Knox absent. Council Member Christie presiding.

Mr. Bob Jones, 402 Bayou Cove Ct., 77042, (713)816-6181 appeared and presented information and stated that he is with Jones Engineering Solutions and he is long time advocate for the Rebuild Houston and he is here today to ask them to either table action on the Bike Plan or to put in some Amendments which would protect a couple of things that had been raised, one of them is to have a mediator solve the problem of neighborhoods when they have meeting with Public Works and the second is how they pay for these bike lanes and the specific thing he would talk about was the one street bike lanes, he is not opposed to the Bike Plan, he rides his bike too and he thinks putting on street bike lanes particularly on major thoroughfares is the most inefficient use of money and the Bike Plan in the hand out that he provided to Council the third page summarizes or uses the summary of the Bike Plan shows 620 miles on street bike lanes with no money and that is at a cost between \$500 to \$750 million dollars and it is planned to come out of Rebuild Houston money, that is the way it is set up and if they approve of the plan as written, they would effective be appropriating 500 to 750 million dollars out of Rebuild Houston money and they will not see it again and that would be 10% of Rebuild Houston money over the next 20 years and that is not what people voted on regardless of the lawsuit. Mayor Turner, Council Members Stardig, Cohen, Gallegos, Laster and Edwards absent.

Members of Council questioned Mr. Jones at length.

Mr. Dexter Handy, 5213 Feagan St. Apt. C, 77007, (832)724-8753 appeared and stated he is Chair of the Citizen Transportation Coalition and they are in favor of the Bike Plan and as an organization that advocates for things that improve the quality of life overall and they believe that the Bike Plan is tool to accomplish 3 goals with greatest importance in providing access to all in all forms of transportation, designing safe and complete streets for all groups and supporting creation livable centers to complete communities and he can go on and on but he knows that they heard all so, all he is going to say is to please support the Bike Plan. Mayor Turner, Council Members Stardig, Cohen, Boykins, Le, Travis, Gallegos, Laster and Edwards absent. Council Member Christie presiding. **NO QUORUM** 

Mr. Chris Palumbo, 5102 Academy St., 77005, (713)661-2968 had reserved time to speak but was not present when his name was called. Mayor Turner, Council Members Stardig, Cohen, Boykins, Le, Travis, Gallegos, Laster and Edwards absent. Council Member Christie presiding. **NO QUORUM** 

Mr. John Long, 3610 Fannin St., 77004, (832)930-6919 appeared and stated that he lived in Houston for 22 years and 8 months ago he became the Director of Bike Houston about the same time the Bike Plan was delivered to the TTI Sub-Committee, the number of people riding their bikes in Houston is growing and the Bike Plan addresses the need for safe places to ride for this growing number of people, they cannot delay on dealing with this and he wanted to remind people that 3 people have died in the last 30 days and presented a letter that was sent to him for Members of Council that stated that her mother was killed on a bike to her commute to work at Rice University when she was struck by the Metro train and she was about to give birth to her first child and that child will never know her grandmother but she is still going to teach her how to ride a bike. ## MAYOR'S REPORT

Mayor Turner stated that he wanted to start with Summer Hire Houston Youth Program and invited Director Juliet Stipeche to the podium to help explain about the program and Ms. Stipeche stated with the March 27 deadline to sign up just around the corner, Mayor Sylvester Turner called on Houston corporations to join his Hire Houston Youth (HHY) summer jobs program. The mayor has set a goal of providing 5,000 jobs for Houston youth this summer and as of today, there are pledges from companies for just 3,000 positions Mayor Turner stated there is an urgent need for more companies to step up and offer summer employment opportunities for our youth that an able and ready workforce is essential to ensuring a strong economic future for Houston and with the demand for skilled workers currently outpacing our workforce supply, it is more important than ever that local youth are connected to employment and training opportunities and do not let our kids down, utilizing public/private partnerships, HHY provides young people ages 16 to 24 with a seven week summer internship or job, earning at least \$8 an hour and the young people will attend workforce readiness training prior to their start date and this is the second year for the HHY program and fifty seven companies' participated and 1,135 jobs were provided in 2016. More than 50 percent of the job candidates had no prior work experience and 50 percent had annual household income of less than \$22,000 and HHY has been designated as a White House Summer Opportunity Hub and is part of a National League of Cities study on the best practices for educational and workforce development efforts and to sign up as an employer, visit www.hirehoustonyouth.org to make your pledge today.
