

City Council Chamber, City Hall, Tuesday, October 16, 2018

A regular meeting of the Houston City Council was held at 1:30 p.m., Tuesday, October 16, 2018; Mayor Sylvester Turner presiding with Council Members Brenda Stardig, Jerry Davis, Dwight Boykins, Dave Martin, Steve Le, Greg Travis, Karla Cisneros, Robert Gallegos, Mike Laster, Martha Castex-Tatum, David Robinson, Michael Kubosh, Amanda Edwards and Jack Christie D.C.; Randy Zamora, Legal Department, Marta Crinejo, Agenda Director, Agenda Office present. Council Member Ellen Cohen absent on Personal Business. Council Member Mike Knox absent on City Business.

At 1:37 p.m. Mayor Turner called the meeting to order and stated they would start with the presentations. Council Members Davis, Martin, Le, Travis, Cisneros, Laster, Robinson and Kubosh absent. Council Member Christie presiding. **NO QUORUM**

Council Member Edwards stated that Alpha Kappa Alpha, Incorporated is an international public service organization that was founded on the campus of Howard University in Washington, D.C., in 1908 and the organization is comprised of distinguished and successful women who continue to project excellence and proven leadership skills, chartered in 1928, Alpha Kappa Omega Chapter is one of Texas' oldest alumnae chapter and the largest chapter in the South Central Region which include Texas, Louisiana, Arkansas and New Mexico with more than 800 active members and on October 16, 2018, members of Alpha Kappa Omega Chapter will commemorate Alpha Kappa Omega Chapter Day at Houston City Hall in conjunction with the celebration of its 90th anniversary and the City of Houston commends and appreciates Alpha Kappa Omega Chapter for its invaluable service in our community and extends best wishes for its 90th anniversary celebration and therefore, Mayor Turner hereby proclaimed October 16, 2018, as Alpha Kappa Alpha Sorority, Inc. Day Alpha Kappa Omega Chapter in Houston, Texas. Council Members Stardig, Martin, Le and Travis absent.

Mayor Turner stated that The founders of Fogo de Chão grew up on a traditional Southern Brazilian farm and learned to cook in the churrasco grilling tradition, in 1979, this first restaurant, built of a wood structure and nestled in the countryside of Porto Alegre, Brazil, grew out of an obsessive dedication to quality, investments in the art and culture of the city and a respect for the heritage of the founders' families and after gaining a reputation among businessmen and celebrities, Fogo de Chão opened its second restaurant in São Paulo. After the outpouring requests of loyal American guests, Fogo de Chão made its first debut in Dallas, Texas and between 1997 and 2013, this pioneering churrascaria continued its expansion in Brazil and the U.S. opening 29 new restaurants, its mission is to deliver exceptional service to its guests and while withholding its vision to be the premier southern Brazilian churrascaria by preserving and sharing the Gaucho way of preparing meats and its values are teamwork, integrity and excellence, in 2000, the first Houston location opened and hosted many distinguished guests including former president George H. W. Bush, former governor of Florida, Jeb Bush, and Mayor of Houston Sylvester Turner, among many others and in 2017, Fogo de Chão open its doors for two weeks and hosted over 12,000 Hurricane Harvey first responders for free dining to thank them for their services during a historical flood. The restaurant has made \$100,000 in donations to the Houston Food Bank and on October 16, 2018, Fogo de Chão will be recognized for their 18 years of support and dedication to providing quality food service to Houston and the City of Houston commends Fogo de Chão on its many contributions to the community and extends best wishes on all future endeavors and therefore, Mayor Turner hereby proclaimed October 16, 2018, as Fogo de Chão Day in Houston, Texas. Council Members Stardig, Boykins, Martin, Le and Travis absent.

Mayor Turner stated that recent data from the Employee Benefit Research Institute indicates that in the U.S., only 56 percent of workers are currently saving for retirement and that the actual amount of retirement savings of workers lags far behind the amount needed to adequately fund their retirement and Americans are living longer, and the cost of retirement is increasing, the financial literacy is an important factor in U.S. workers' understanding of the need to save for retirement; and saving for retirement is a key component to overall financial health and security during retirement years and the importance of financial literacy in planning for retirement must be advocated and Retirement Security Week will be observed October 21-27, 2018, by supporting the Financial Retirement Educational Event (F.R.E.E.). The City of Houston commends the organizers and participants of Retirement Security Week and extends best wishes for a successful and rewarding observance and therefore, Mayor Turner hereby proclaimed October 21-27, 2018, as Retirement Security Week in Houston, Texas. Council Members Stardig, Boykins and Travis absent.

Council Member Gallegos stated that The Houston area is wonderfully enriched by its most vital resource – inspired individuals who are willing to serve the public in all sectors, through tireless personal service and leadership, professionals and community volunteers alike work daily to improve the quality of life for all and Michael O. Davis is a graduate of Grambling University and has always strived to provide families with quality and affordable funeral services and after receiving his degree in Mortuary Science/Funeral Directing from the Commonwealth Institute of Funeral Service, he worked at local funeral homes, he flourished while at Skipper Lee & Son, Eternal Rest Funeral Home, working in such capacities as pre-need insurance agent, notary and make-up artist and the founder, Skipper Lee Frazier, was so riveted by his professionalism and passion, that he adopted him as his symbolic son and changed the name of the home to Skipper Lee & Sons, following Skipper Lee Frazier's passing, he became the president and owner of the company, Amid the destruction wrought by hurricane Harvey, Michael O. Davis also selflessly purchased furniture for affected families and donated school supplies for returning students. He has been widely recognized throughout the clergy and business community for his mentorship and charitable endeavors and has been the recipient of many awards, including the Man up Man of Distinction Award and the Hero of the Year Award and on October 16, 2018, Michael O. Davis will be honored for his overall accomplishments and for providing exceptional and dignified funeral services for families in need. In recognition and appreciation of his dedication and loyal service to the community, the City of Houston congratulates and commends Michael O. Council Members Boykins, Knox and Robinson absent.

At 2:24 p.m. Mayor Turner recognized Council Member Laster (on behalf of Council Member Cohen) for the Invocation and the Pledge of Allegiance. Council Member Boykins absent.

The Roll was Called. Council Member Ellen Cohen absent on Personal Business. Council Member Mike Knox absent on City Business. Council Member Boykins absent.

Council Member Kubosh moved to adopt the Minutes of June 19-20, 2018 and delay the balance and seconded by Council Member Davis, all voting aye, nays none. Council Member Boykins absent. **MOTION ADOPTED**

Mayor Turner recognized Council Member Davis for a Procedural Motion; Council Member Davis moved to suspend the rules to hear Peggy Turner out of order and seconded by Council Member Kubosh, all voting aye, nays none. Council Member Boykins absent. **MOTION 2018-0532 ADOPTED**

Mayor Turner requested the City Secretary to call the List of Speakers.

Peggy Turner, 1333 Moursund, 77030, (832)567-4832 appeared and stated that she is the Adoptive Sports Coordinator for the TIRR Memorial Herman Hotwheels and being recognized by Mayor Turner and the honorable Council Members and for bringing home 2 National Championship to Houston this year, the Wheel Chair Basketball Championship and the Junior World Series Championship but today she is here for a different reason, she was here a few weeks ago and it was mention about inviting the Youth Hotwheels to the Annual basketball Game that is part of their Municipal Campaign and one of the principals that they instill with the wheelchair athletics which is gratitude and giving back they are High School students and they soon will be in the workforce and 2 of their Senior Athletics just signed a letter of intent and received a full 4 year ride to the University of Texas Arlington to play wheelchair basketball and get a college education, they require them to do community services and volunteer work and they would like to participate in the Campaign that Mayor and Members of Council are having and help give back and they challenge each of the Members of Council to participate that is against the TIRR Memorial Herman Hotwheel and with that said she expect some of the Council may have a concerned or feel insensitive to sit in a wheelchair and play against the Hotwheels and she wanted to tell them that they should be concern when a group of Junior High School Student and High Students will completely run over the City's Leaders in a public setting and beat them then she express what is in the wheelchair sport and the competition rules and these competitions happens in Cities around the Nation. Council Member Boykins absent.

Mayor Turner stated to Ms. Turner that she knows how to throw down a challenge and Council Member Davis stated to her as well that the Mayor is correct but he took the opportunity to sit down in a chair and shoot and it was bad for him and when he missed he had to cheat because he had to give up and walk over to get the ball and the difficulty in shooting in a chair and he is encouraged by the level of athletics that sit in that chair and competes and to have the ability to move and then shoot and he stated he was nervous because this will be his first time stepping into a basketball court, he is nervous and he does accept the challenge and he awaits the defeat on Friday night.

Georgina O'Neil, 6631 Cadillac St., 77021, (832)845-0272 had reserved time to speak but was not present when her name was called. Council Member Boykins absent.

Josephine Rojas, 4605 Ranger St., no phone, had reserved time to speak but was not present when her name was called. Council Member Boykins absent.

William Beal, no address, no phone, had reserved time to speak but was not present when his name was called. Council Member Boykins absent.

Andrew Evans, 2402 Napoleon St., 77004, (832)495-6323 had reserved time to speak but was not present when his name was called. Council Member Boykins absent.

John Marsden, 8039 Boone Rd., 77072, (832)960-0074 appeared and stated that last year December 2017 he lost his son in a murder, March of this year he opened a company called Houston in South Homicides and he is trying to get families a little hope that one day they would get justice for their loved ones and he is speaking for the families that have lost victims due to crime, murder, rape and kidnapping and he is request for one day that they all could come together at the Court Yard in front of City Hall, he is requesting a Candlelight virtual for homicide victims and missing people, it has never been done in Houston where the families come to the Court Yard at City Hall to Pray and talk about the love that the family members had and he is out there working the streets, he wanted to know how many people around this Council have lost someone due to gun violence or have come up as missing and gave examples of cases that he

help solve, he out on the streets doing work, he actually turned down a position at NASA to be here today, he left his job when his son died and then he presented banners of some of the victims in Houston that were murdered, this is not a game, this is very serious and there are 4 or 5 year old kids dying in the streets and they have adults not coming home and he wants to have this one special day out of the year and he is begging for this day, families reach out everyday and some days he is at a road block. Council Members Boykins, Martin and Laster absent.

Council Member Davis stated to Mr. Marsden that he did lose his Father 15 years ago because someone broke into his home over off of Homestead and he does understand about losing a love one and he continues to Pray on daily bases and he cannot image the things that he is going through and losing a son and going through that and he thanked him for coming here.

Mayor Turner also wanted to state to Mr. Marsden that certainly share his sentiments and he thought they had a day for victims and Council Member Cisneros advised that they do and it is the National Day of Remembrance for Murdered Vicitms and September 23rd but Mr. Marsden stated to them that he knows when it is but he was asking for a day for candlelight vigintile for murdered victims and missing people let them reach out to this particular group and to see how they can get everyone on the same page and he believes that they should share his sentiments and they do not certainly want to forget people, they want to remember the victims and their families.

Jacqueline Simmons-Haley, 5422 Alba Rd., 77091, (713)540-5792 appeared and stated that she is here to speak about building codes concerns and the people after her had someone move into their neighborhood between their 2 properties and she is here in support for her neighbors in her area and the first problem that they have with the building codes is that their neighbor built a fence from the back of the property to the City Right of Way out of wood which blocks her neighbors view and from their understanding from building codes that the wood could not go any further than the face of the building and that is where the problems come in and the neighbor does not have a living dwelling and he built a utility shed and the utility shed is not a house but he is living in it and he built the utility shed just about on the property line to his right and it leaves the property on the left unused and they tried to speak to the neighbor and he would not listen, then they called the City about that and there were inspections made but with the inspections nothing was done and he also connected the outside plumbing and then he drew the plumbing all the way on to the property on his left and connected his plumbing to her plumbing and the Building Inspector was called about that too. Council Members Boykins and Martin absent.

The City Secretary advised that there was 2 people that had called in but were not on the list which is Mr. Kenneth LaVergne and Wanda Pratt which will be next.

Kenneth LaVergne, no address, (713)799-3238 appeared and stated that Ms. Simmons-Haley tried to explain the fact is that the gentleman bought a vacant property and the property was 10430 Caxton and he came in and built a shed, he went over to visit him while he was building the shed and then he turned it into a home and it hangs over on his fence, the roof is leaking onto his property and it does disturb him that he has to come down here with this problem when he believes that the City should have taken care of it and he would be pleased if they look into this and find out what they can do and this person is taking responsibility on his own without getting City Permits. Council Member Boykins and Martin absent.

Council Member Davis thanked Mr. LaVergne for coming down and what they can do so he would not have to come down here, they would help him find out information and take it to the Scenic Woods Civic Club and told him to be free to contact his Office and they can follow up with the Department of Neighborhoods or Housing to see where this issue is and they can get information for him and then asked if he had 311 numbers and if so he can get is from Mr. LaVergne and he

gave it to the Inspectors but that led to him coming down here because he could not get any answers.

Wanda Pratt, no address, (713)633-8901 appeared and stated that there needs to be stricter building codes for the neighborhoods that do not have Deed Restrictions, her sewer was cut and by the owner who they are talking about, he cut her sewer line and then connected his line to hers and the City came out and they red tag him and 2 days later he had a permit to hook up his plumbing to a shed that is not permitted with the City and she would like to know how can this owner of a shed that is not permitted to get a permit to put plumbing in a shed that is not permitted, she has been calling the City since last year and what to know when this lot was purchased and all they do is come out and red tag and will not follow up on the work that had been red tagged, she does have pictures of when the owner cut her sewer and went in the back of her house when she was at work and then cut her sewer line and then hooked it up to the shed.

Mayor Turner requested to see Ms. Pratt pictures and Ms. Pratt stated that the Harris County Office it is listed as a frame utility shed and she does not understand, she has called 311, she does have her reference numbers, she has names of all the Inspectors that have come out and she cannot get help.

Mayor Turner further stated to Ms. Pratt that he wants all the names of the Inspectors that have been out there working on this and the fact she told him that they came out and red tagged it and then they did not follow up and for them to allow someone to get into her sewer line or her property and he wants to take a look at this because he does not want people to come down here to complain if people within the Department should have already dealt with this prior and requested Monica with Houston Public Works to review this and looked at all the Inspectors who have look at this and to the extent that they did not do their jobs and he will hold their Supervisors responsible because he does not want to take time out on Community Sessions if people are not doing their work out in the fields because he will get impatience and he wants to know what happen here.

Crystal Townsend, 500 Lovett #100, 77006, (832)418-5048 appeared and stated that she is the Coordinator of the Houston's Plan to the End the HIV Epidemic and sometimes she reminds herself that Houston is the 4th largest City in the Nation because we have such a hometown feel and she appreciates that she gets to speak a little more about this plan and this is a Citywide effort to end the HIV Epidemic by focusing on those impacted the most and what that looks like in Houston is that the African American communities, the Latin communities and LGBT plus communities, in 2016 data showed them that the Latin community made up 34.2% of new HIV Diagnoses and while HIV in the African American Community made up 48.3% and the White community made up 13.6% of new diagnoses and their goal here is pretty straight forward , they want to keep people not living with HIV negative and people that are living with HIV suppressed so that the chances of them transmitting HIV is nearly impossible to spread HIV and it cannot just only go through health care system and as a Coalition they have listed 30 recommendations on how they believe they can reach their goal and they can use their help, this is about safer communities, economic, opportunities, education and Health care and she wanted to offer suggestion like they would like one is to see funding in the City's General Budget for HIV focused services and she understands the funding is tight so the alternative could be to leverage existing resources by working with initiatives like My Brother's Keeper. Council Members Davis, Boykins and Martin absent.

Members of Council questioned Ms. Townsend.

Mayor Turner stated to Ms. Townsend that he agrees with her that they need to leverage additional resources within the State too.

Antonio Zavala, 1407 James St., 77009, (713)302-9999 had reserved time to speak but was not present when his name was called. Council Members Davis, Boykins and Martin absent.

Blanca Beltran, 427 W. 20th St., 77008, (713)802-3127 appeared and stated that she is a Committee Member of the White Cane Safety Day and she is basically here to invite everyone here to attend their 11th Annual White Cane Safety Day and they are very honored to be able to do it in front of City Hall, they are going to have a dozen buses with children that is going to be brought over here so that they can participate with the festive, they are going to have raffles, they are going to have food, they wanted them to be aware that it is going to be happening this Thursday, it starts from 9:30 a.m. to 1:00 p.m. and the Downtown March begins at the Intersection of Main and Walker Street and if they are able to attend that would be fantastic but if they cannot they understand that they are working, it's all about educating the community about the Organization and also most importantly the disabilities that individuals go through and for people that do not know what White Cane Safety, its been celebrated since 1964 and has grown into an event that is recognized Worldwide and their MC is going to be ABC Melanie Lawson and they are very excited about that. Council Members Boykins and Martin absent.

Council Member Stardig thanked Ms. Beltran for her contribution to this event and it is very important the awareness and asked her to recognized the Members that are present here today and asked them to stand and the White Cane Day is an opportunity for everyone to see the independence that people are visual impaired and it is very important that people understand and they appreciate all of their work.

Matthew Oliva, no address, (832)874-9819 appeared and presented information and stated that he thinks that the City of Houston is one of the best and amazing Cities in the United States and if anyone comes here they are lucky to be here, he was brought here against his will and he spent 15 years working at the rodeo and met some amazing people and in February he was told that he has Congestive Heart Failure and after that diagnosis he lost his apartment because he is not able to work during the day and that is ok because this is a great City with great resources, when he became homeless, he saw the other side of the Houston homeless issue and he thinks that Houston is heading for a myth versus reality and he is one of the people that ask questions and he is a citizen who thinks that citizens should not stop going after they vote and he encounter in the homelessness system good or bad he thinks that everyone is good and this is a massive system and they need their help. Council Members Boykins and Martin absent.

Mayor Turner advised him to speak with Sean is with Housing and he would like to speak with Mr. Oliva.

June Lloyd, 600 E. Tidwell Rd. #309, 77022, (832)627-4145 had reserved time to speak but was not present when her name was called. Council Members Boykins and Martin absent.

Liz Lozano, 7314 El Paso, 77020, (832)525-3549 appeared and stated that she came to speak about the safety of the children in the East End, with the problems that they already had with crime, children and even mothers disappearing and there is a lot of fear right now concerning the immigration issues and she is concern about these children because they are afraid whether they are here illegally or otherwise, the children of Houston need to be at peace to live to grow and to develop into a healthy adult and the fears that are coming at them through watching television, newspapers, through hearing their parents talk have been getting to be quite a lot for the children of the East End and the matter of fact for the kids in Houston with a Hispanic heritage, the children of the East End will also include the children at 419 Emancipation because Houston is a Welcoming City and she knows that these children most likely unless things change and Southwest Keys has multiple cases of abuse, neglect and sexual assault toward these children and she understand that they are trying to do that they can do to stop this place from opening to seeing all the vehicles there has brought more fear into the people in the East End that are right

around it and she has enough information to provide that this is a possible danger to the children in Houston and this immigration is a mess and causing her community deep felt fears that is being passed on to the children in these communities, these children have the right to live and she is asking for the Mayor and Members of Council to do everything they can. Council Members Boykins, Martin, Edwards and Christie absent.

Council Member Cisneros thanked Ms. Lozano for coming down and they know it is well document the effect of stress on young children in their brains and their health and their success is impacted by the stress they undergo when they are very young and then Council Member Cisneros requested a status of Southwest Key.

Mayor Turner stated that the City has been sued by Southwest Key and that case is under litigation and as of today there is no one residing at 419 Emancipation.

Marion Scott, no address, no phone, had reserved time to speak but was not present when his name was called. Council Members Boykins, Martin, Edwards and Christie absent.

that she is the Film Maker and Creator of I am You Dimension of Diversity and it is a community based documentary that she felt was necessary and needed in their current environment, these 3 part documentary was filmed in Houston that features Houstonians and also featuring a women based group here in Houston and that they wanted to feature brave Houstonians as they share their journey through diversity and inclusion as relates to mental health, religious freedom, military sexual trauma and white privilege and intention of the film is to inspire each of us to have a human to human connection and embrace their and identify personal misconceptions and the series here in Houston will continue to outpace the Metro Cities and create not just an inclusive City but inclusive World for their community and the future of this City and she believes that her attendance will demonstrate the strength and importance of engaging with our Local Elected Officials and who are interested in attending she would like to offer a 5 minute opportunity to address the audience and promo materials and there is also a commentary VIP Pass to invite each Council Member who are available to come to check out the documentary. Council Members Boykins, Edwards and Christie absent.

Mayor Turner asked Ms. Guillory when the Documentary and she is advised it was October 29th at the University of Houston in Downtown from 6:00 p.m. to 8:30 p.m.

Sarahy Garcia, no address, no phone, appeared and stated that she was here because she has a question, she was kinda of perturbed that Members of Council that they were able to draw City Ordinance to stop a Robot Brothel and they asked in June if they could do a City Ordinance to stop Southwest Key for an concentration camp from being opening up in here on Emancipation and she is wondering what the differences is, could any of them help them with that, why would they able to do an Ordinance about Robot Brothel and not Southwest Key. Council Members Boykins, Martin, Le and Christie absent.

Mayor Turner advised Ms. Garcia that Southwest Key is suing the City of Houston and then he asked her if she is aware why Southwest Key is suing the City of Houston and she advised the Mayor, that she is aware and that this all could have been avoid with a City Ordinance and she is trying to understand why a City Ordinance was not valid in this case because she is at a loss for words at the lack of humanity and she has asked Members of Council to take a moral stand and none of them are doing anything about this and asking them to look in their hearts and do the right thing.

Deborah Elaine Allen, P.O. Box 263252, (713)264-0127 4145 had reserved time to speak but was not present when her name was called. Council Members Boykins, Martin, Le and Christie absent.

Fredrick Metoyer, no address, no number, appeared and stated that he is concerned about his Civil Rights it is very prominent in Houston and with everyone that comes here, they can go to Texas Southern University or any other University and that is where it starts from but he is writing concerning Public Libraries because every Library he is scrutinized saying that he is rude and he knows that someone is hacking him, he is writing and they do have a major problem. Council Members Boykins, Martin, Le and Christie absent.

Mayor Turner did allow Mr. Metoyer to finish his thought.

The City Secretary advised that there is one more person that did not have their name on the list.

Steven Vargas, no address, no number, appeared and stated that he is here representing the Latino HIV which they heard about it a little earlier and also the Road to end HIV Houston which they also heard earlier as well and he is here to advocate for change and change in two senses, to change or make something different and change also in terms of currency a line item in our City's Budget and National Latino Awareness Day and they wanted to let Council know what is being seen in the front line workers and as person working in the HIV Community, he seen many of them not able to participate in the advances in medical treatment and preventive care for nearly 20 years according to their own state data and they see Latinos smore than any other group and even the Nation has seen a drop but they have seen a rise in when it comes to young men of color who have sex with men in Latinos and African Americans and they are fighting for access for medical care and even access to education and he know that the City Budget is tight but he does believe it is time for Houston to create a line item in its budget to directly address the HIV Epidemic. City Council Members Davis, Boykins, Martin, Le, Kubosh and Christie absent.

Members of Council thanked Mr. Vargas and commented.

The Houston City Council reconvened at 9:00 a.m., Wednesday, October 17, 2018 Mayor Sylvester Turner presiding, with Council Members Brenda Stardig, Jerry Davis, Ellen Cohen, Dwight Boykins, Dave Martin, Steve Le, Greg Travis, Robert Gallegos, Mike Laster, Marta Castex-Tatum, Mike Knox, David Robinson, Michael Kubosh, Amanda Edwards and Jack Christie D.C.; Ronald Lewis, City Attorney, Marta Crinejo, Agenda Director and Stella Ortega, Agenda Office present. Council Member Steve Le absent due to being ill.

At 9:07 a.m. Mayor Turner called the meeting to order and moved to the Mayor's Report. Council Members Stardig, Martin, Travis, Gallegos and Laster absent.

MAYOR'S REPORT

Mayor Turner stated that he wanted to make a few announcements before they go to the Agenda and he first wanted to start off on a very positive, positive note and recognition to Council Member Christie, he has been honored which he does have a picture on his phone when he was in High School which he will send out to everyone because he would like everyone on Council to see the
