A regular meeting of the Houston City Council was held at 1:30 p.m., Tuesday, September 24, 2019; Mayor Sylvester Turner presiding with Council Members Jerry Davis, Ellen Cohen, Dwight Boykins, Dave Martin, Steve Le, Greg Travis, Karla Cisneros, Robert Gallegos, Martha Castex-Tatum, Mike Knox, David Robinson, Michael Kubosh, Amanda Edwards, and Jack Christie D.C.; Ron Lewis, Legal Department, Marta Crinejo, Agenda Director and Stella Ortega, Agenda Office present. Council Member Stardig absent on City business. Council Member Laster absent due to death in the family.
