A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, October 24, 2023, with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Carolyn Evans-Shabazz, Tiffany D. Thomas, Mary Nan Huffman, Karla Cisneros, Mike Knox, David W. Robinson, Micheal Kubosh, Letitia Plummer and Sallie Alcorn; Randy Zamora, Legal Department, and Marta Crinejo, Agenda Director, present. Before going into the Mayor's Report, he requested Chief Peña to get an update on where we are. Chief Peña gave a brief update on the investments and resources for the Houston Fire Department. He briefly spoke on recruitment and retention, year over year budget allocations and health and safety equipment along with a slideshow presentation. After his presentation, Mayor Turner again thanked Chief Peña and his department for the work that they've done.

MAYOR'S REPORT

Thompson Reuters announced a new online resource to fight human trafficking. Public awareness campaigns play a critical role in tackling human trafficking. The City of Houston's campaigns are recognized as a model of best practices. We were picked up nationally by Thompson Reuters and they've acknowledged that throughout this partnership. Thompson Reuters will make the city's world class anti-trafficking toolkits readily accessible online to other cities and public authorities. Over the last eight years, our efforts have focused on ensuring that the locally accomplished mitigating work was shared nationally and globally thru emerging programs that welcomed US municipalities and foreign governments to Houston, as well as international forums where we were invited to showcase the model. He thanked Minal Patel-Davis and her team for some incredible leadership. What we're doing here in the City has now been picked up nationally.

The Ismaili Center Houston was a huge success. The construction on the center will be completed sometime in 2024.

Mayor Turner made mention that he'll be adorning the Texas Rangers jersey. As we know, the Houston Astros lost to the Texas Rangers in the World Series. He thanked the Houston Astros for another incredible run. In the last seven years, they've been in the World Series three times, winning twice, and seven times as Division Champs. Houstonians have been spoiled.

The Greater Houston Partnership put out a financial report on the City of Houston. They have recognized that they have made some mistakes in their report and will be revising it.
