

Council Chamber, City Hall, Tuesday, December 5, 2023

A regular meeting of the Houston City Council was held at 2:00 p.m., Tuesday, December 5, 2023, with Mayor Sylvester Turner presiding with Council Members Amy Peck, Tarsha Jackson, Abbie Kamin, Dave Martin, Tiffany D. Thomas, Karla Cisneros, Robert Gallegos, Edward Pollard, Martha Castex-Tatum, Michael Kubosh and Sallie Alcorn; Randy Zamora, Legal Department, and Marta Crinejo, Agenda Director, present. Council Members Carolyn Evans-Shabazz, Mike Knox and Letitia Plummer absent on personal business. Council Member Mary Nan Huffman absent on City business. Council Member David W. Robinson out of the City on City business.

At 1:43 p.m., Mayor Turner called the meeting to order and Council Member Kamin for the first proclamation.

Council Member Kamin presented a proclamation to Shma Koleinu celebrating the 10th Anniversary of the congregation. Accepting the proclamation was Rabbi Scott Hausman-Weiss.
